







Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

On the field in the 2023-2024 school year, Westfield athletic programs won 8 conference, 6 country, 8 NJSIAA section (Boys and Girls Cross Country, Girls Volleyball, Boys Winter Track, Boys Swimming, Boys and Girls Spring Track, and Boys Lacrosse), and 5 Group Championships (Boys Cross Country, Boys Winter Track, Boys Swimming, Boys Swimming, and Boys Lacrosse). Our Boys Cross Country team competed in the Nike National meet in Oregon and our girl's flag football team qualified for the state tournament in their 2nd full season. Over 50 of our student-athletes are continuing their athletic careers at the collegiate level.



More than 80% of students participate in co-curricular activities with more than 65 clubs, including several community service-oriented clubs and academic clubs. Model UN and Youth and Government Clubs continually earn regional Delegation awards and other recognitions. All these activities encourage students to take on leadership roles in their community as well as promote wellness and well-rounded individuals.

The current Westfield High School building was opened in 1952 with an addition in 2003 that included a new science wing. The building houses a library offering over 45 databases and 25,000 volumes; computer labs; a TV Studio; visual, performing, and practical arts; resource room; and common spaces such as the Student Center, auditorium, and cafeterias. Our Buildings & Grounds Department provides regular maintenance while our IT Department keeps the building technologically up-to-date. All classrooms, library, and many other common spaces are air-conditioned.



Safety is a priority at Westfield High School which holds regular safety drills. The building is equipped with interior and exterior security cameras. Key exterior and interior doors are equipped with access control readers. The building is equipped with an audio and visual alert system, integrated with the fire and burglar alarm system. To comply with Alyssa's Law, panic buttons are directly connected to the Westfield Police Department.



Challenging engineering courses are offered in our Innovation Classroom which includes a digital presentation podium, LED lighting, laptops with computer aided design (CAD) capabilities, and motorized window shades. The innovative space also hosts our Robotics Club. Many of the classrooms are equipped with interactive projectors and whiteboards and there are document cameras in the Science Wing and other classrooms. We have a dedicated technology lab, a television studio and mobile computer labs with laptops and Chromebooks. All students participate in technology-rich lessons using their own devices in our building's BYOD technology initiative.
