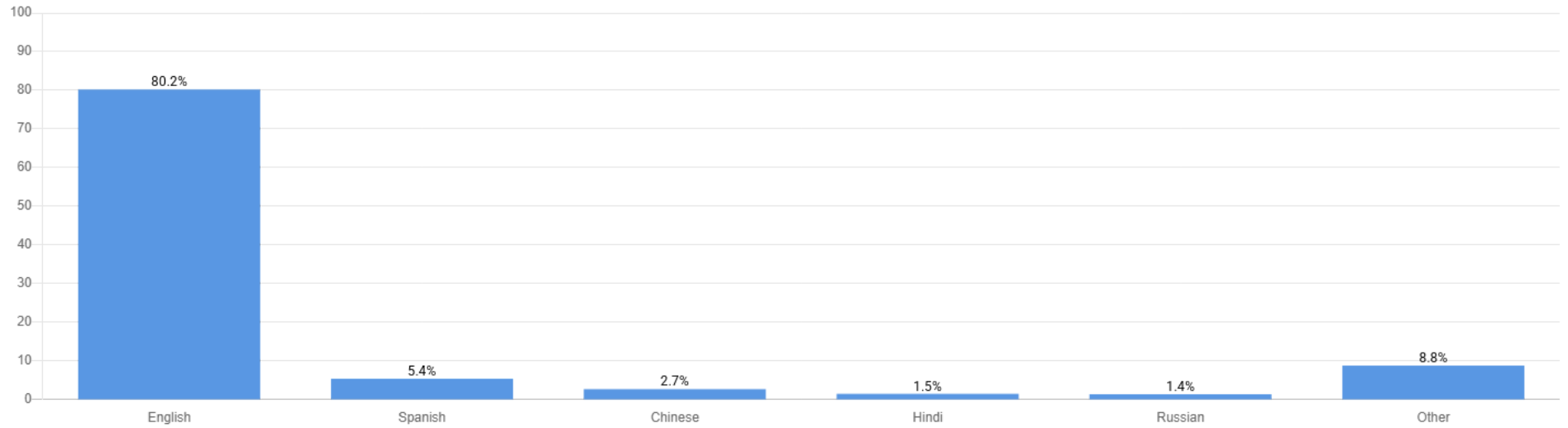

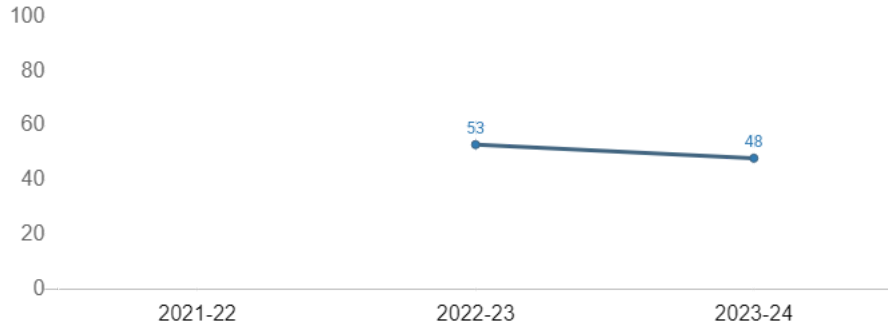

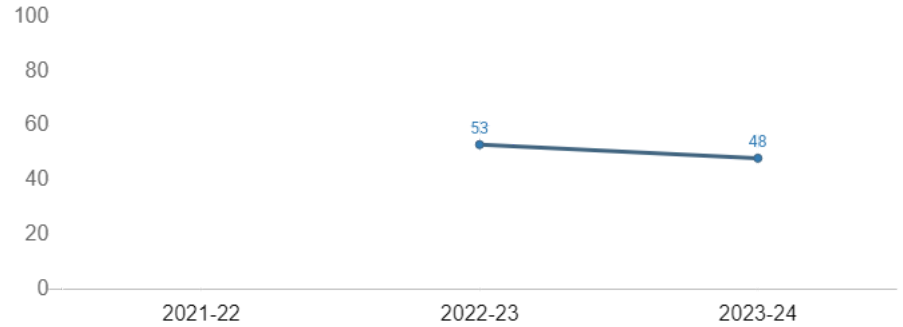

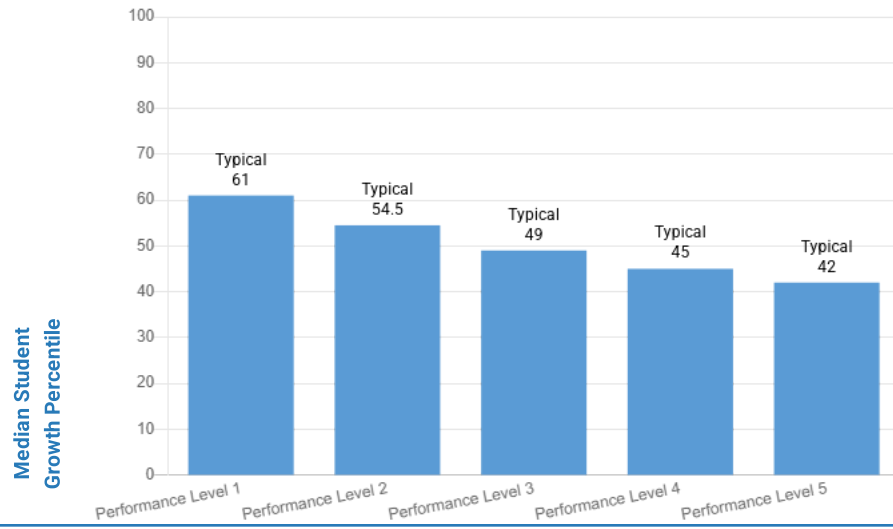

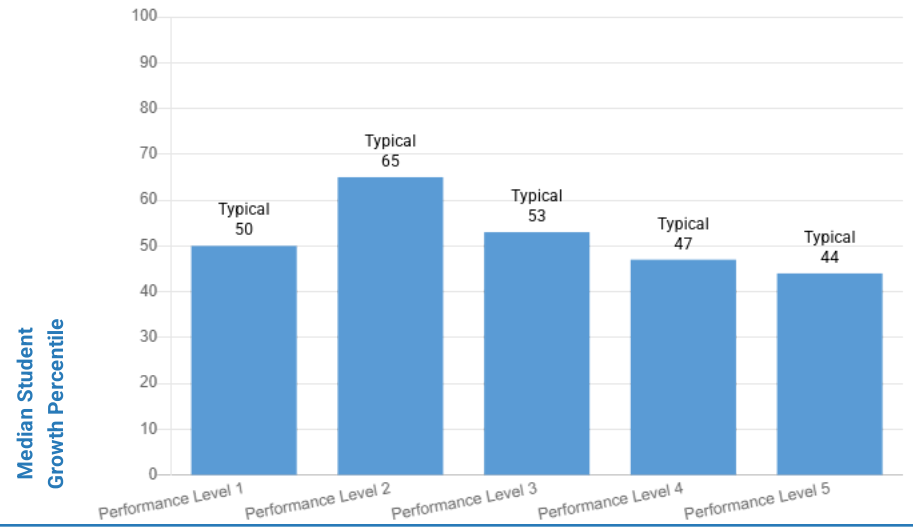

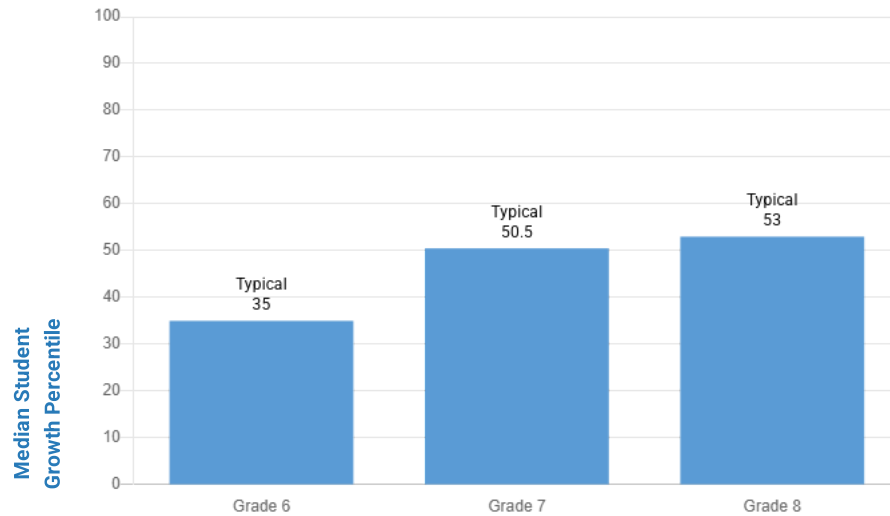

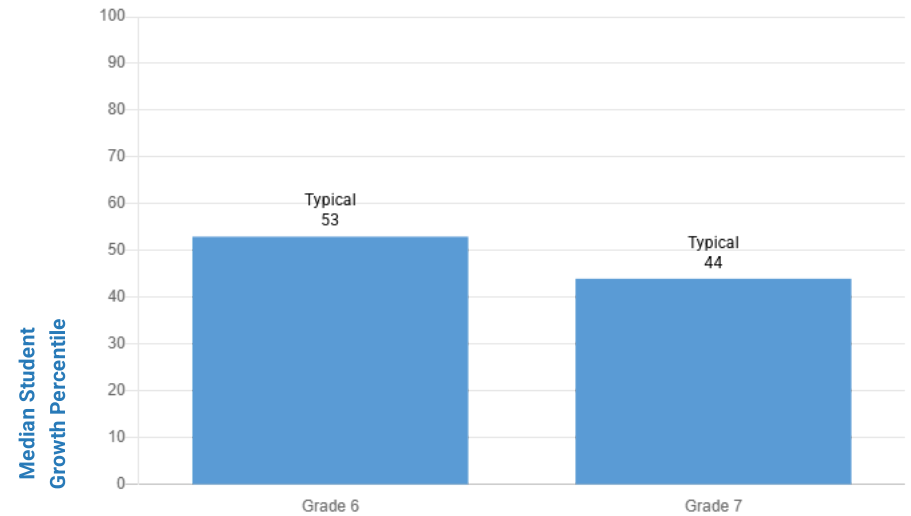

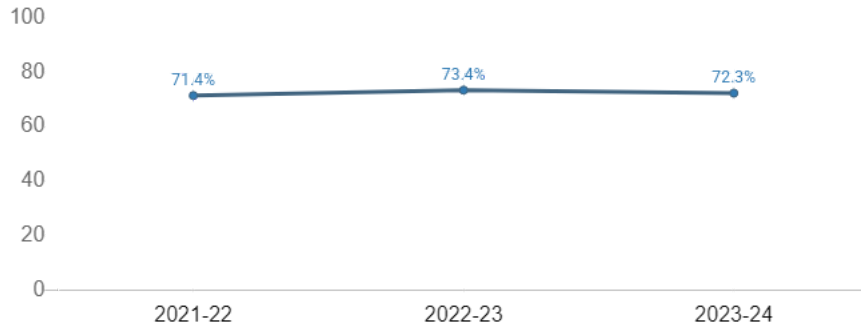

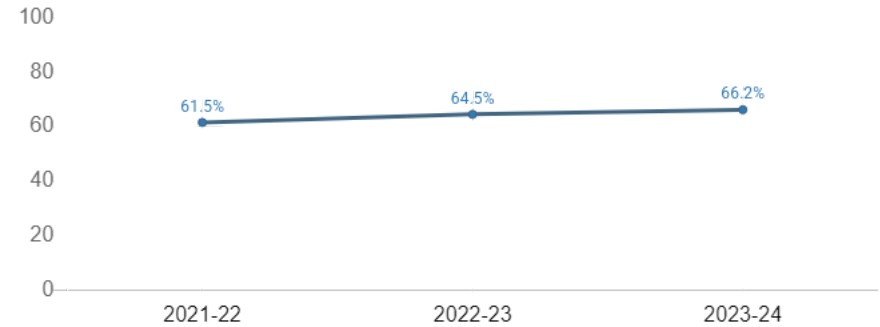
English Language Arts and Mathematics Performance Trends

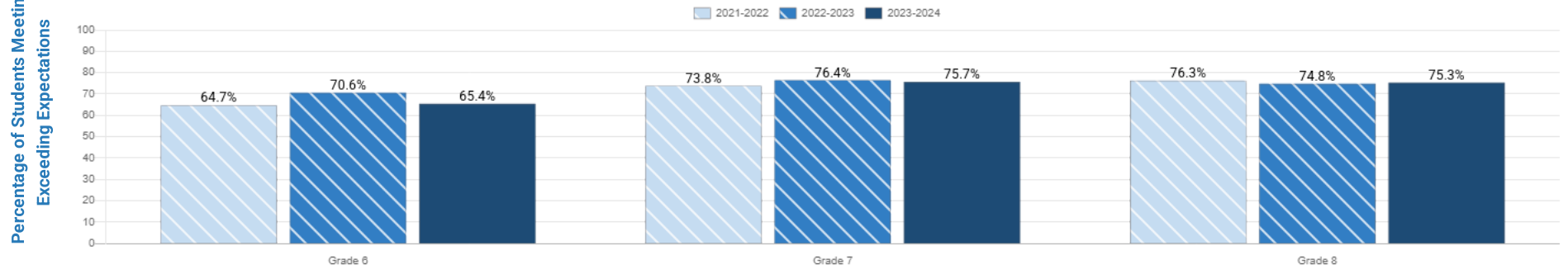

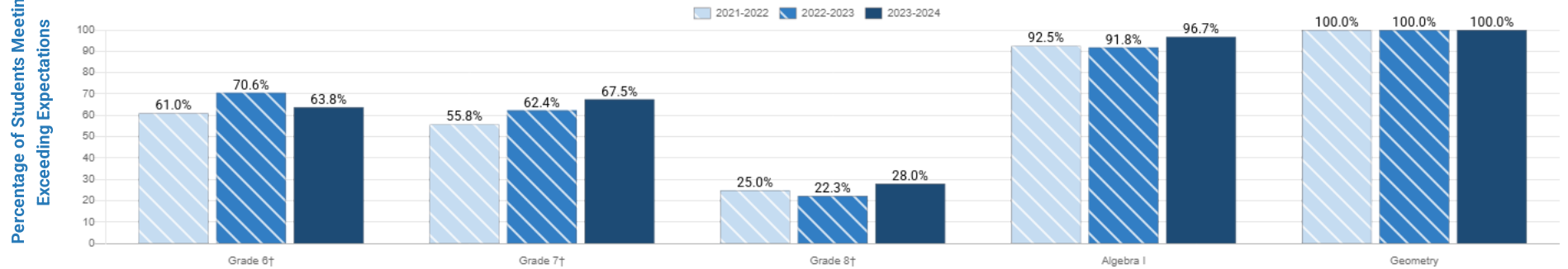

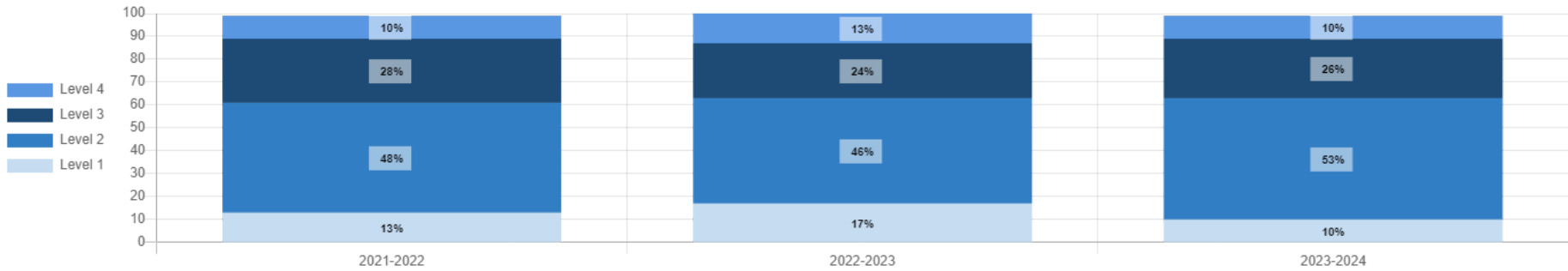

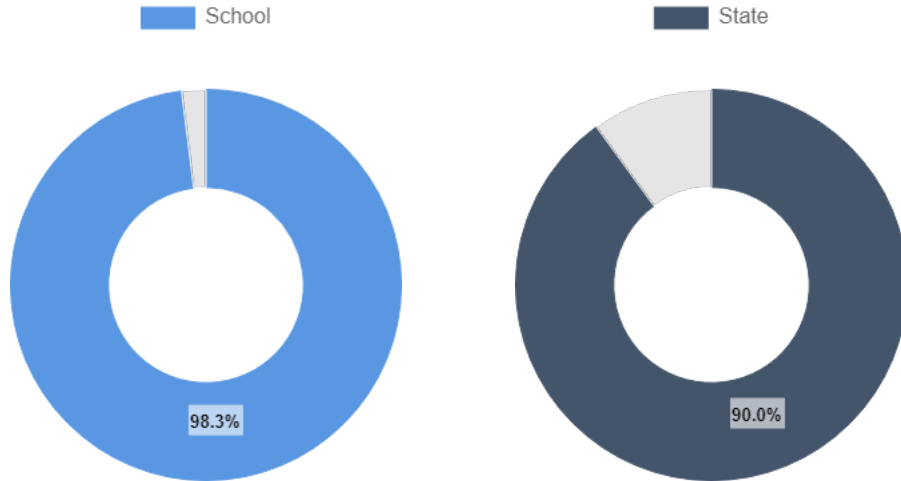

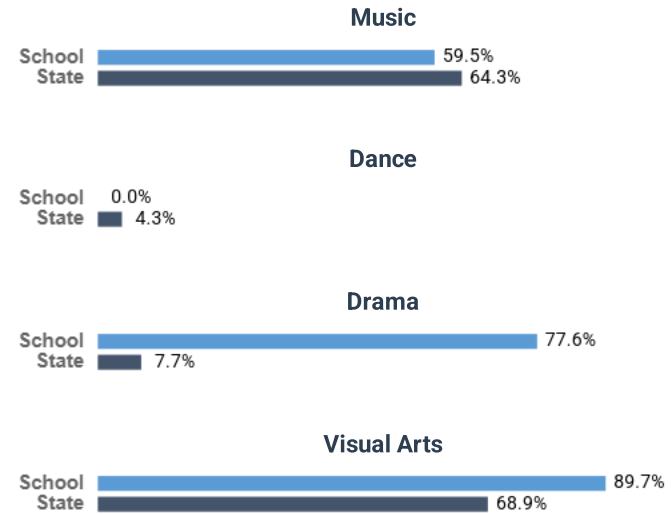

Students enrolled in one or more classes by discipline:



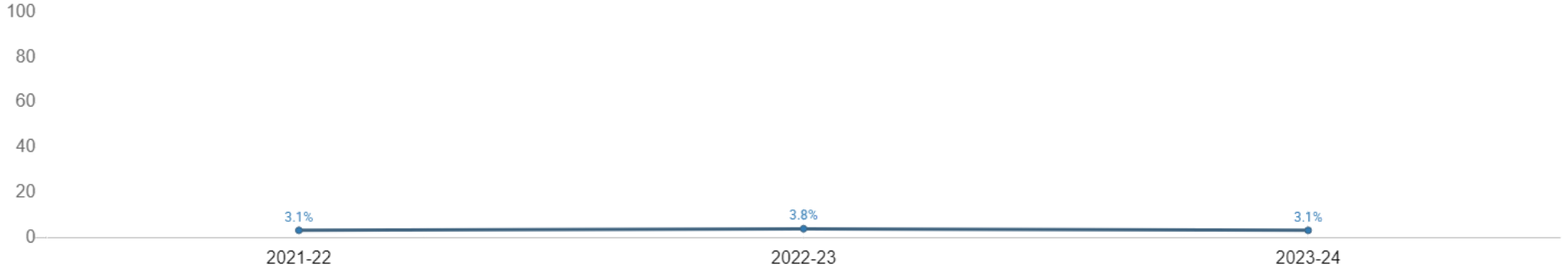

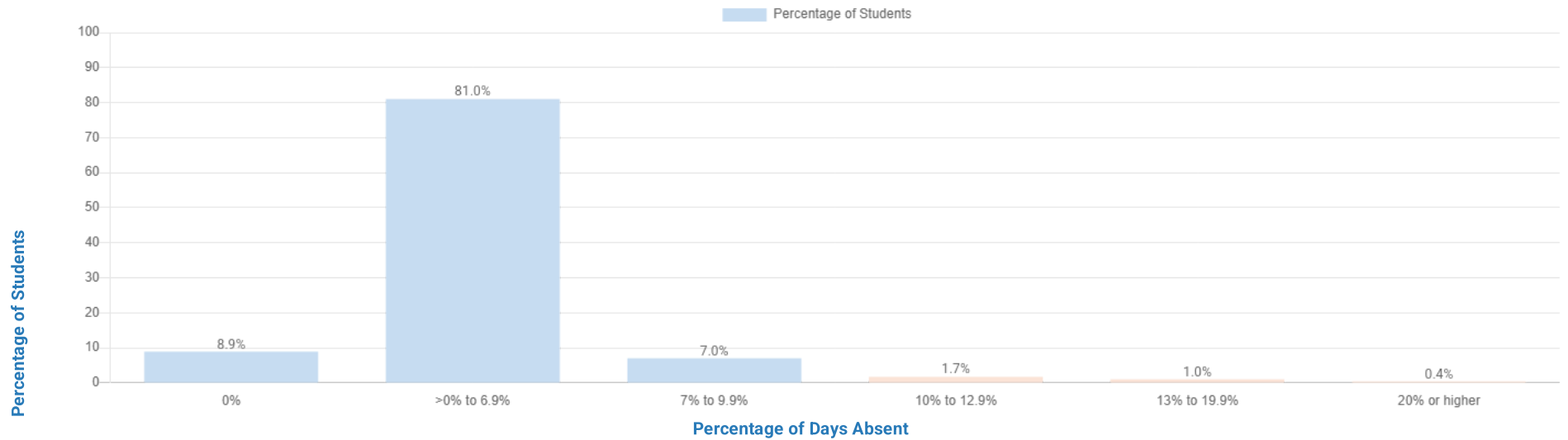

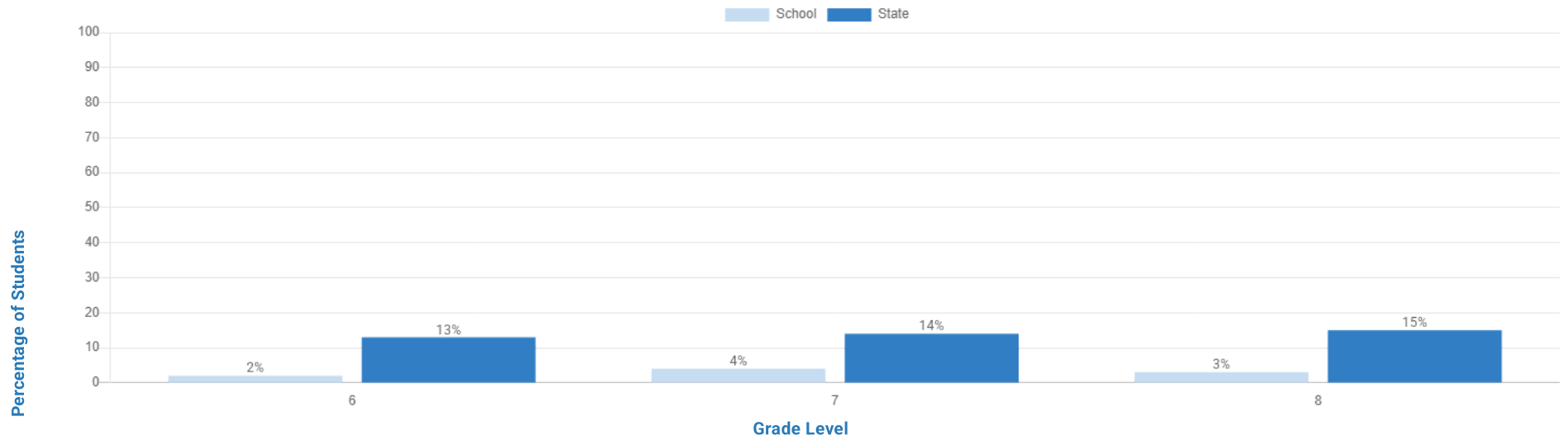

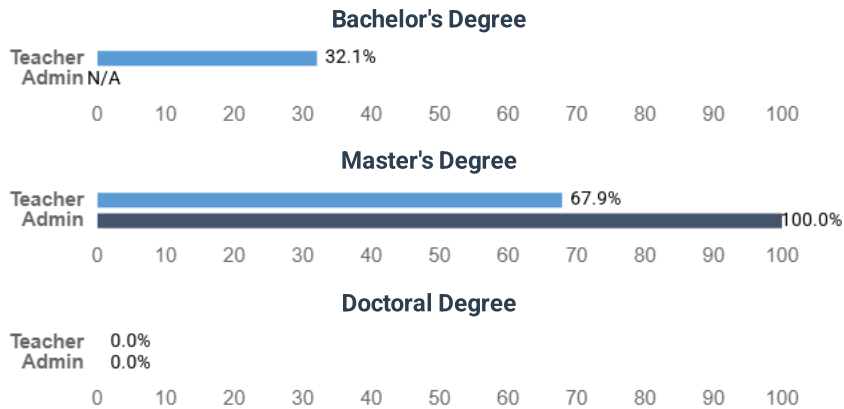

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Safety is a priority at Edison Intermediate School which holds regular safety drills. The building is equipped with interior and exterior security cameras. Key exterior and interior doors are equipped with access control readers. The building is equipped with an audio and visual alert system, integrated with the fire and burglar alarm system. To comply with Alyssa's Law, panic buttons are directly connected to the Westfield Police Department.



Technology and STEM:

Our school's media center is equipped with an interactive projector with whiteboard and fully-networked computer stations, including Chromebooks. Edison Intermediate School students take part in a one-to-one Chromebook initiative where each student receives a Chromebook from the district to be used throughout the school year. To support technology classes, two dedicated technology labs are available which include robotics instruction. Students in grades six, seven, and eight take part in technology education design (TED) courses.



Attendance:

We closely monitor and analyze daily attendance data to identify trends and patterns, enabling us to intervene early when needed. By fostering strong relationships with our students and families, we create a sense of connection and belonging that encourages consistent school attendance.
