







Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

We take pride in being the home of the Warren Hills Blue Streaks. Our school was opened in 1967, and has had a number of expansions and renovations since then. Throughout the renovations, the building has been updated to ensure efficiency and a positive overall experience, including natural lighing through our interior courtyards. We have over 50 classrooms, a large media center, two full gyms, a weight room, a training room, a greenhouse, a large cafeteria, and an auditorium which seats over 600. Across our campus, we have many athletic fields and a multi-sport turf athletic complex.



School security and safety is a priority throughout our district. Warren Hills has been recognized as one of the safest school districts in New Jersey. We are continually assessing and improving our safe schools practices and implementing the latest in security procedures and protocols through collaboration with local and state officials, monthly drills, and regular roundtable discussions.



Warren Hills Regional High School takes great pride in providing students with diverse experiences and opportunities within our STEM field. Girls Coding with Girls, for example, is a unique program where high school female students work with grades 4-8 female students to learn coding and computational thinking. We host STEM alumni chats and have received the AP Computer Science Diversity Award for the third time with 50% of our females taking the APCSA exam. Additionally, our current, in-depth computer science course sequencing has been enhanced with the adoption of an Intro to Cybersecurity I and II courses. We also have the privilege of working with St. Luke's University Health Network and the Venel Institute to provide our students with the unique opportunity to "scrub in" and assist a local surgeon in performing a human cadaver leg dissection as other students witness the procedure.
