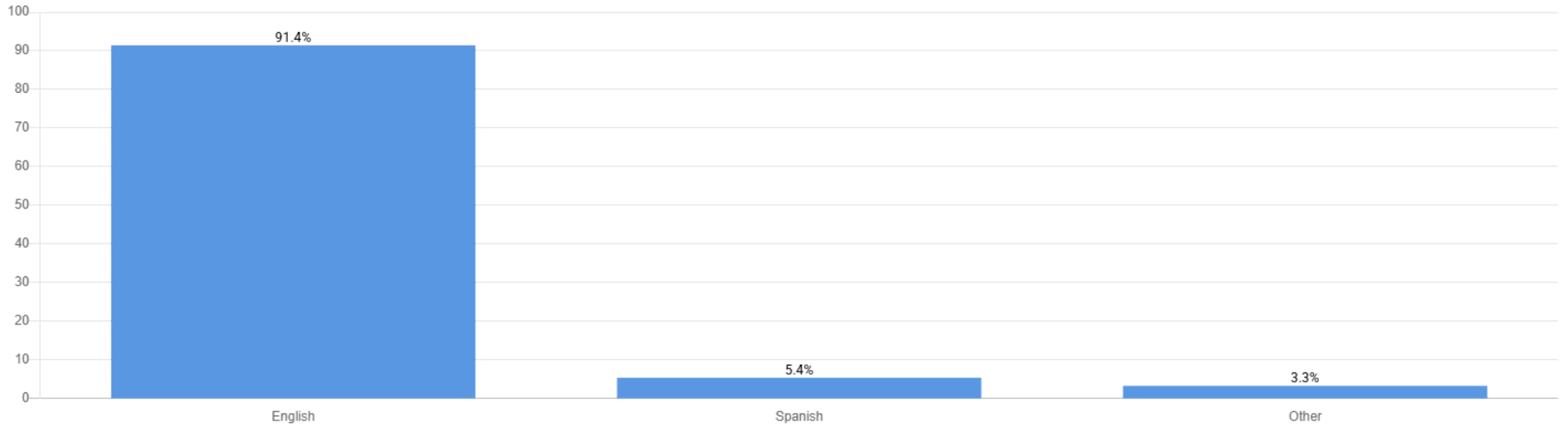

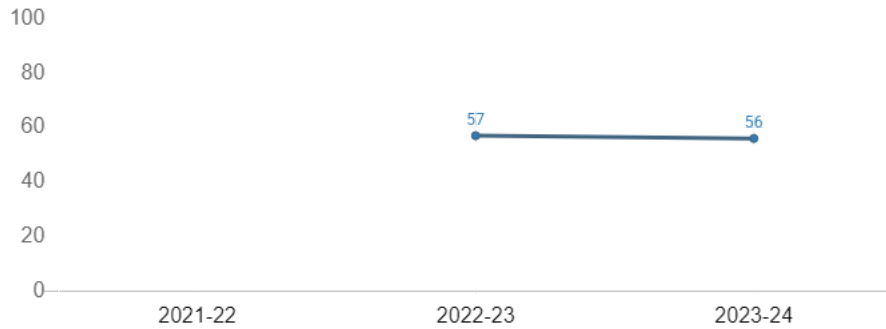

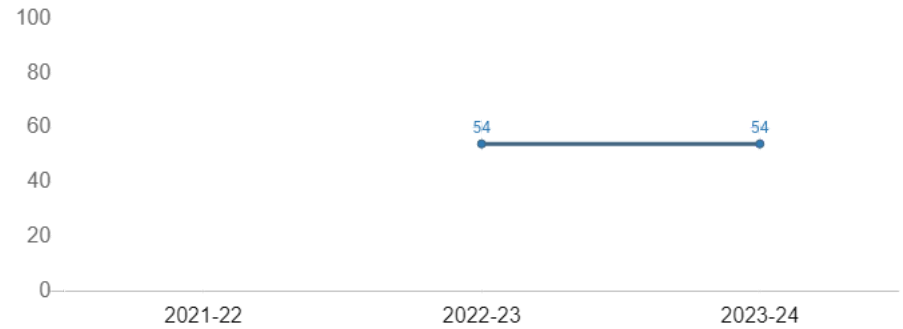

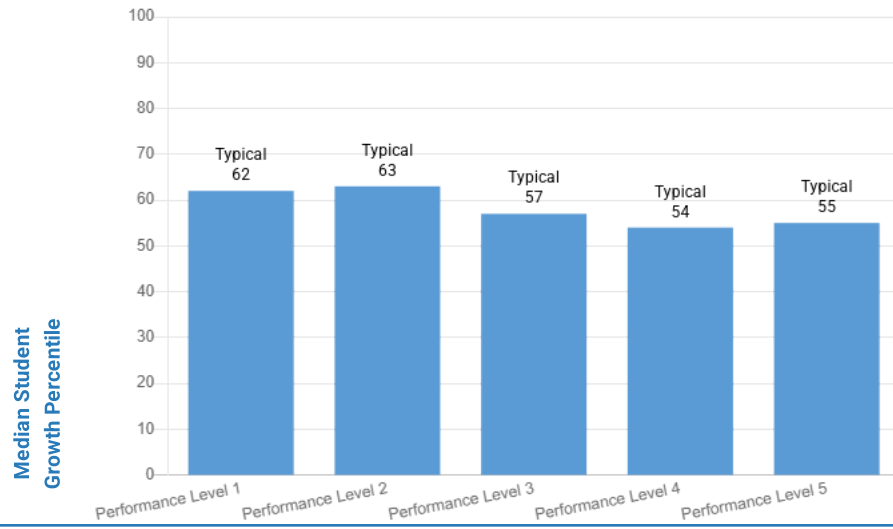

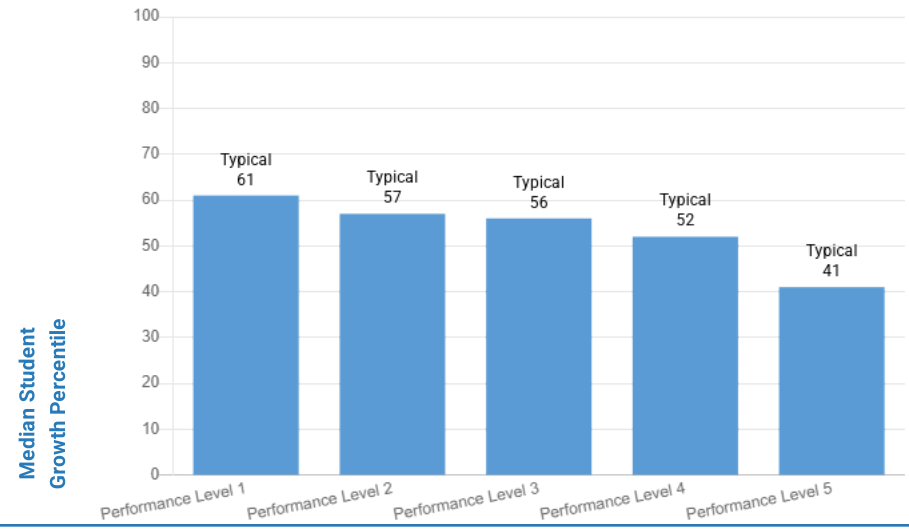

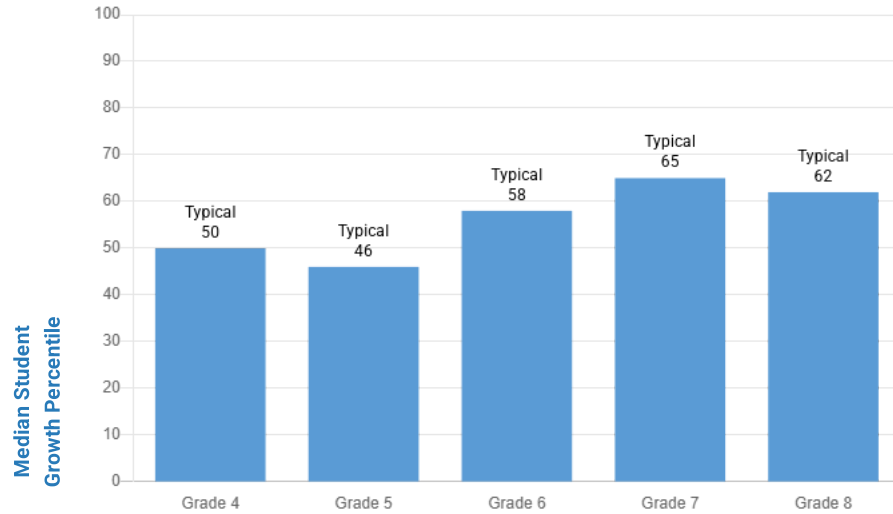

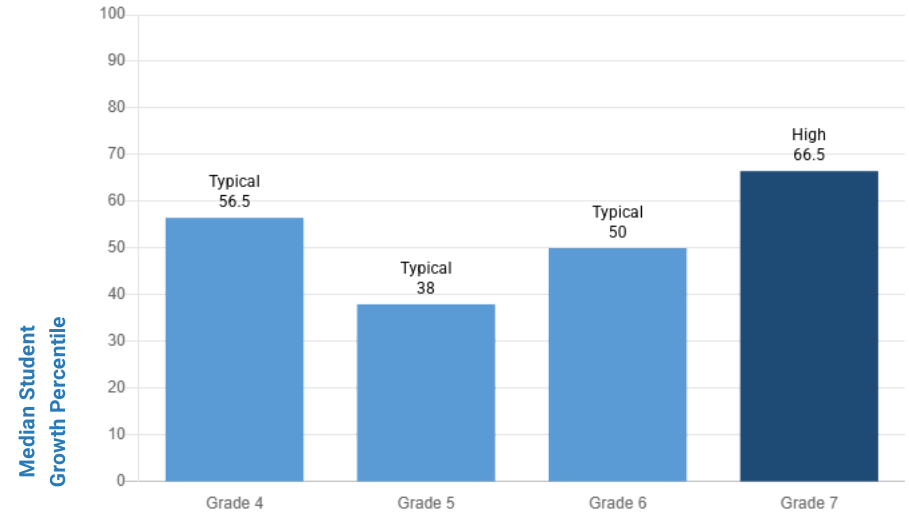

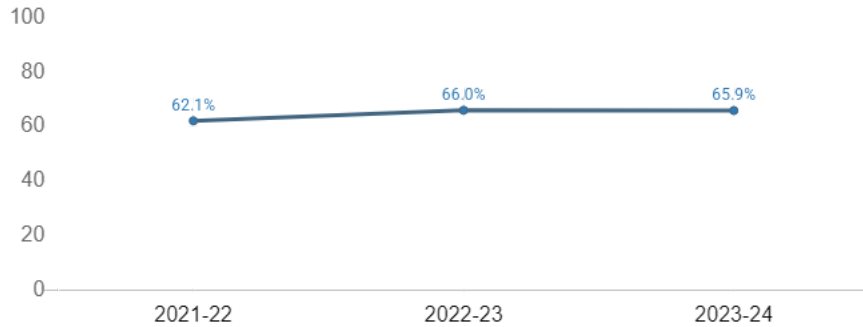

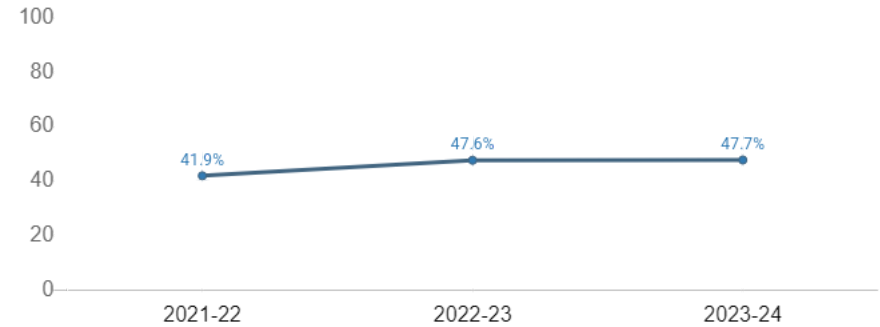
English Language Arts and Mathematics Performance Trends

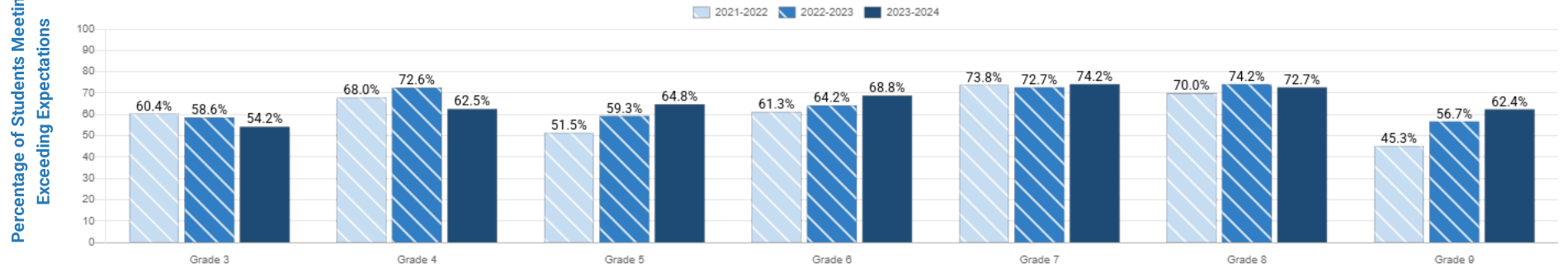

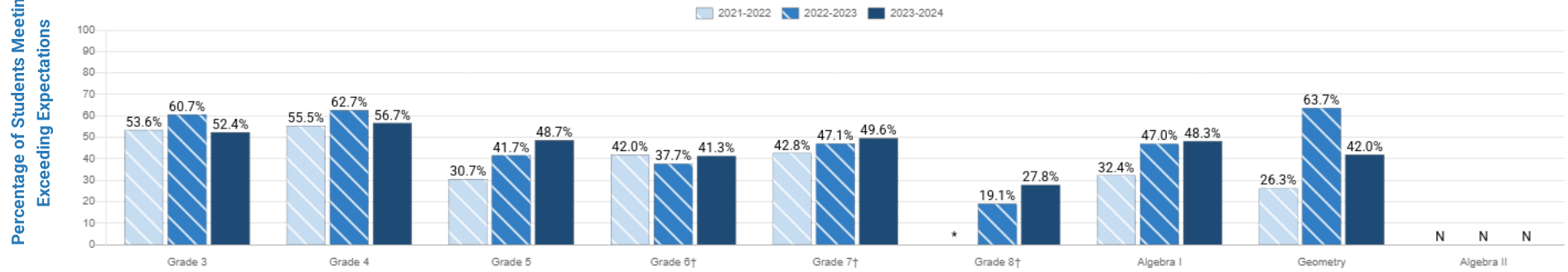

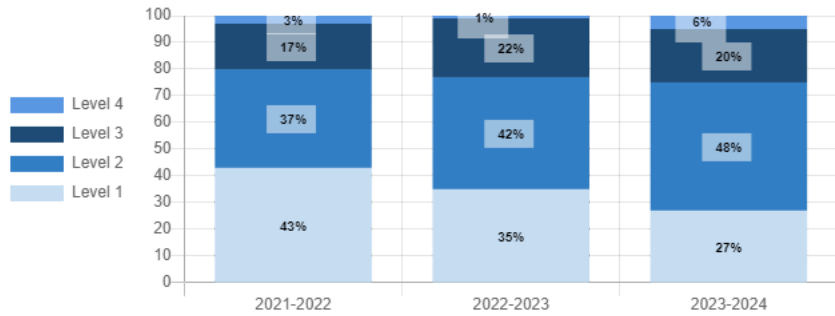

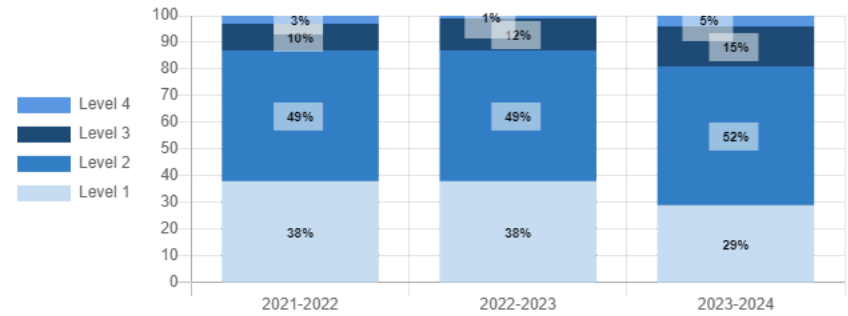
NJSLA Science Assessment: Grade 5 Summary

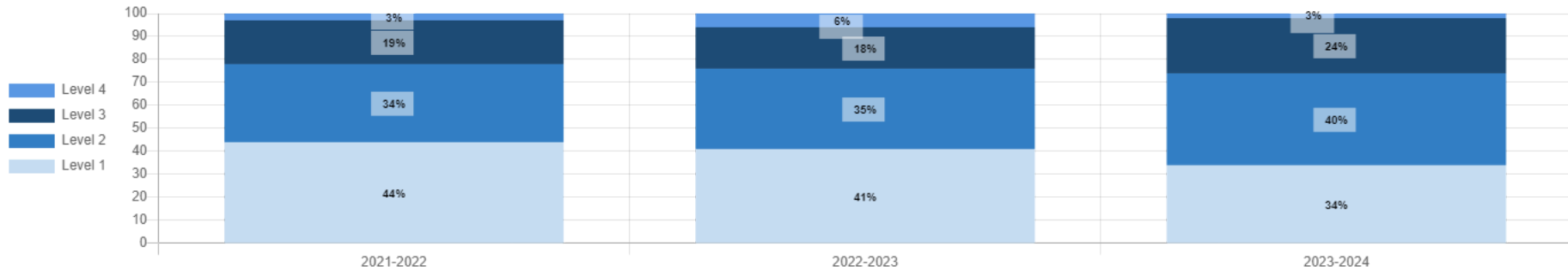

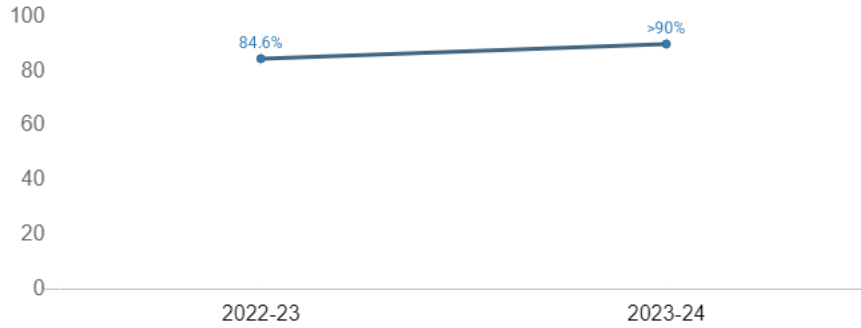

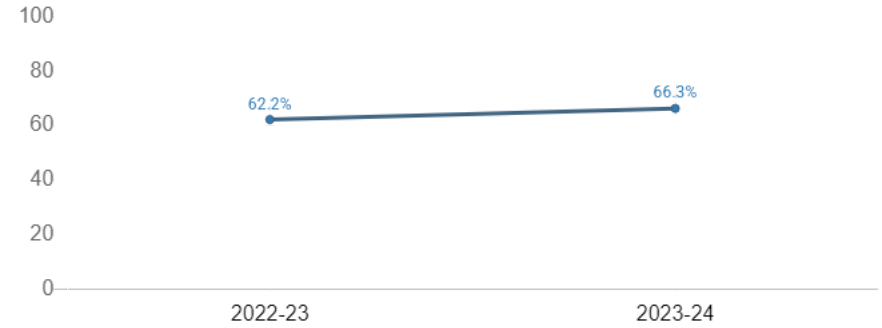

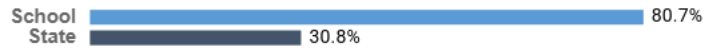

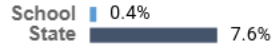

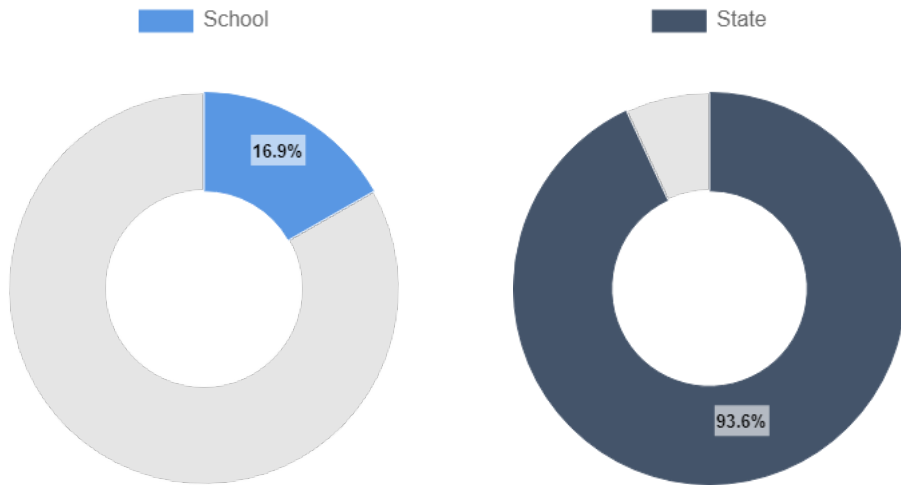

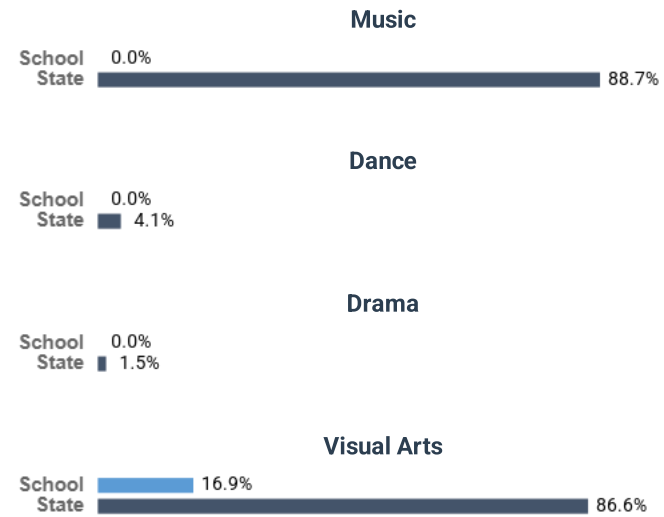

Students enrolled in one or more classes by discipline:



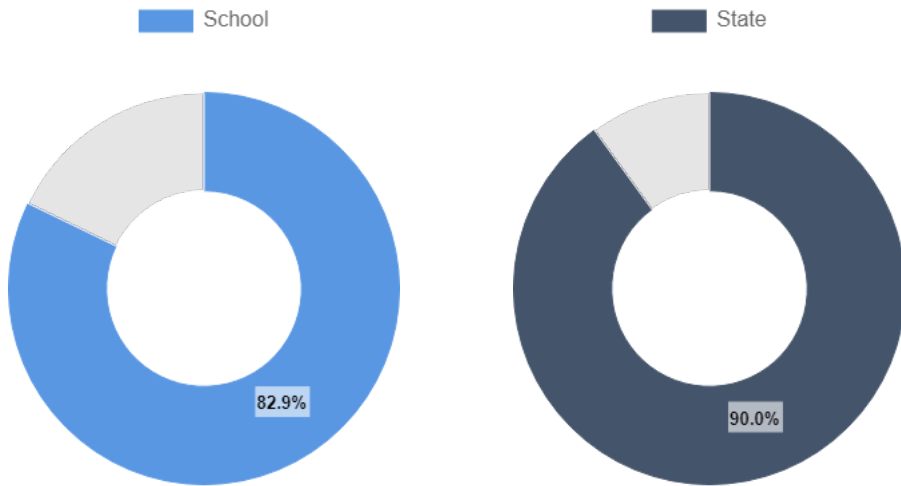

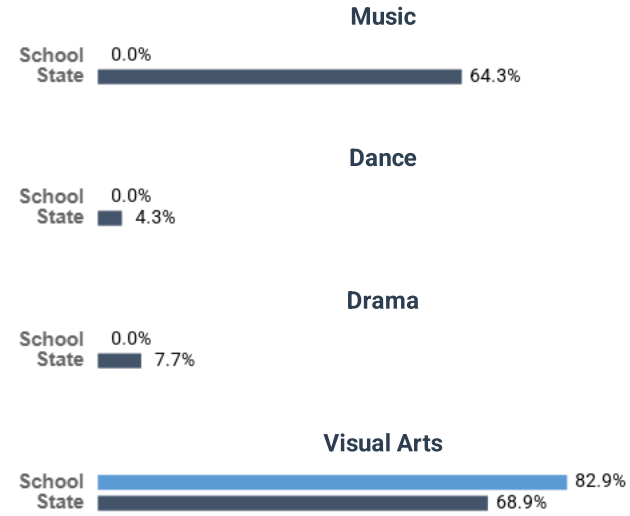

Students enrolled in one or more classes by discipline:



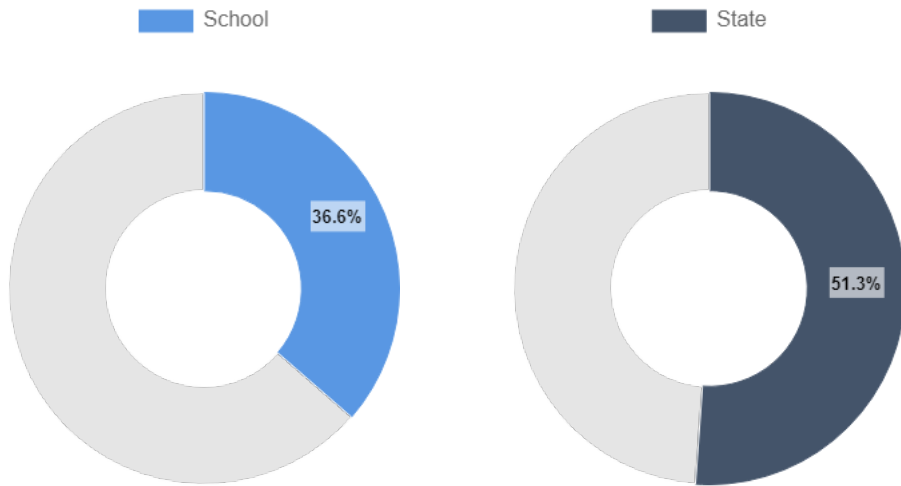

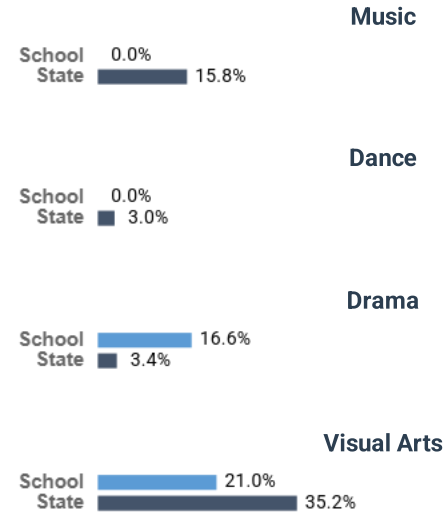

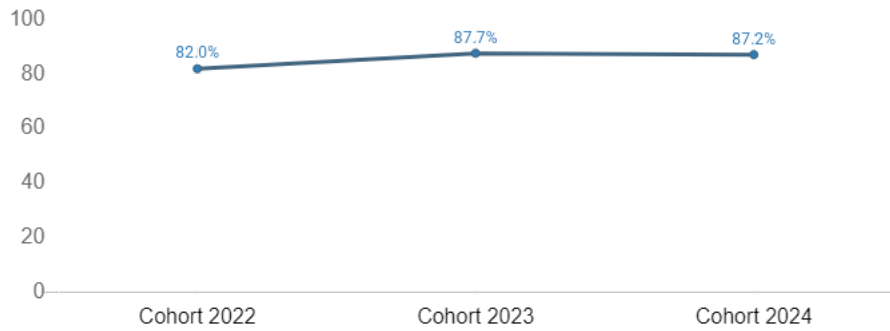

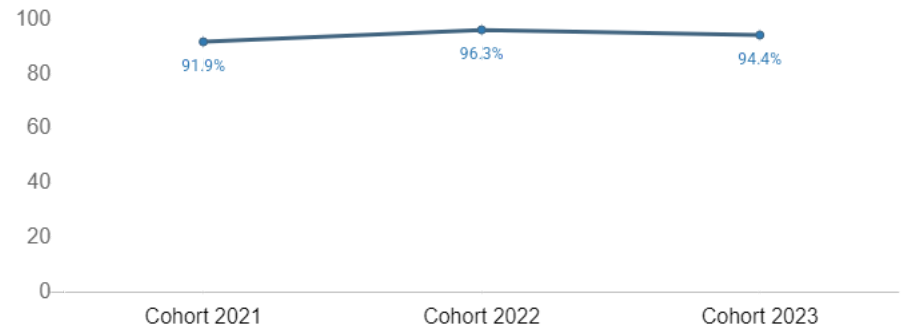

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

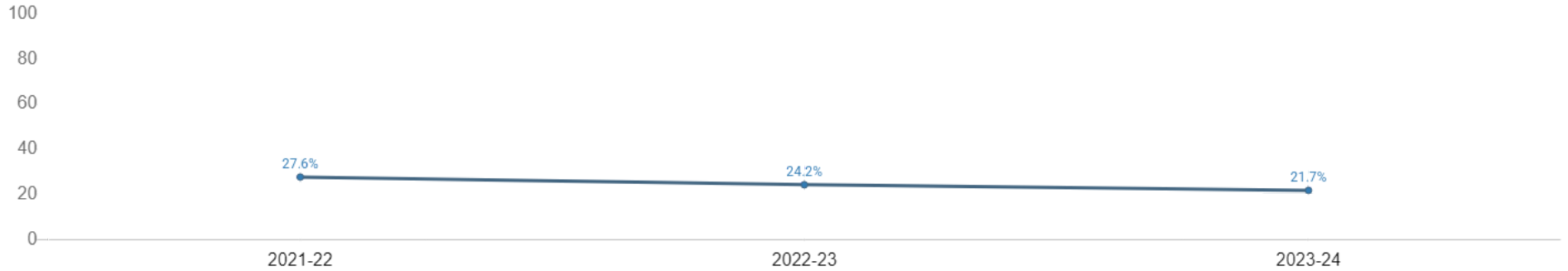

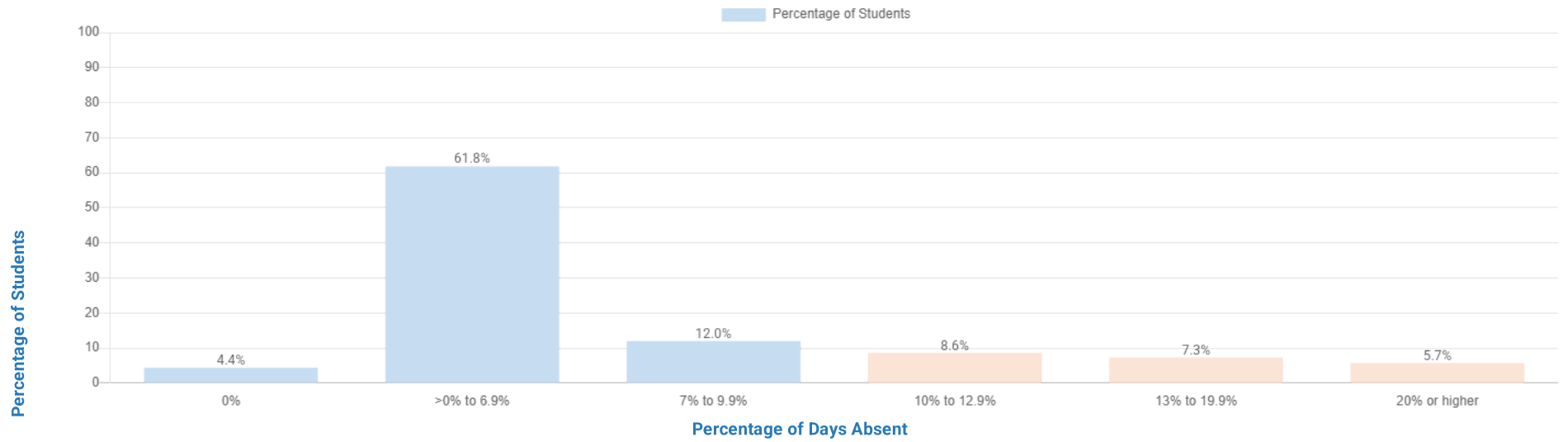

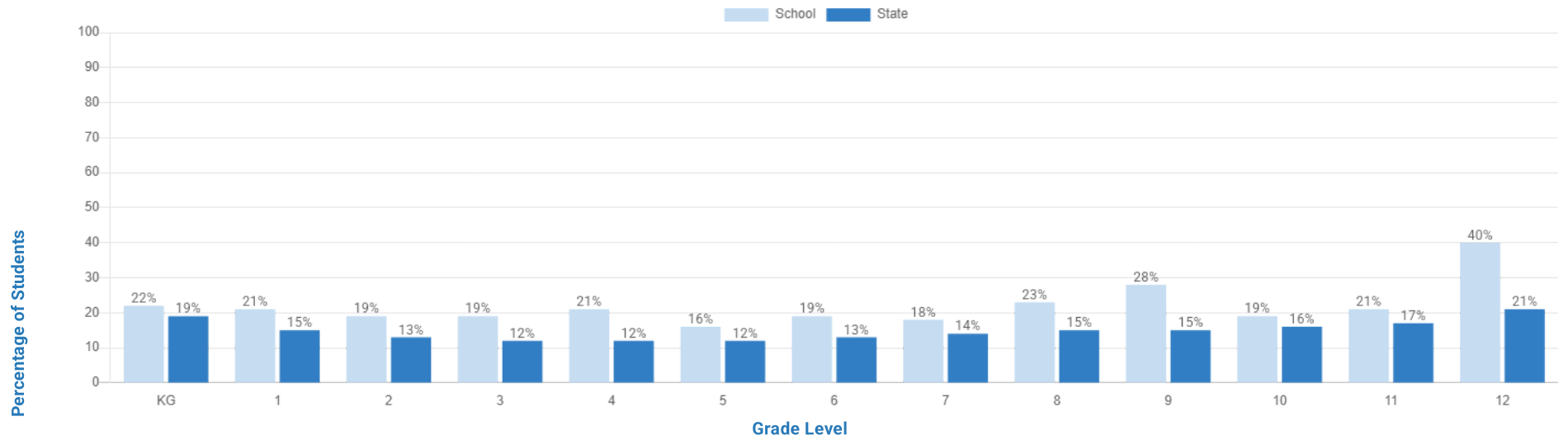

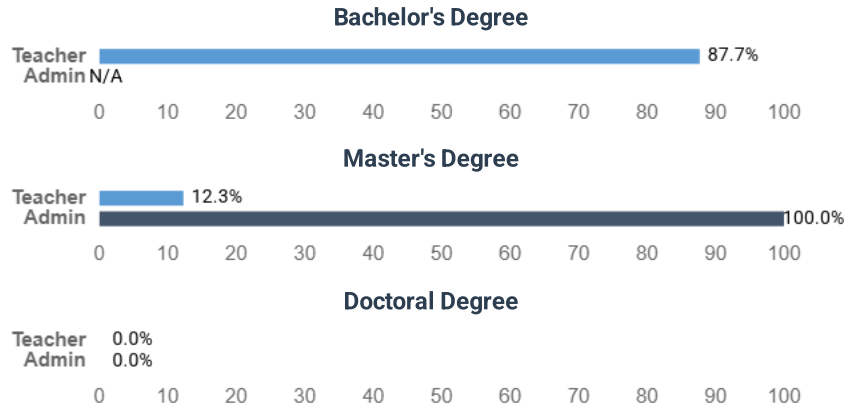

Accountability Summary by Student Group - 2023-24 School Year

North Star provides high-quality professional development that well exceeds the 100 hour minimum requirement of the NJDOE. Every new teacher has 3-4 weeks and returning staff members have two weeks of summer professional development. New teachers that join after the first day of school participate in additional professional development led by our principals. During the year, staff participate in weekly professional development meetings. North Star does not lock in set topics for the year but rather responds to the needs of the teachers based on leader observations and interim assessment results.



Postsecondary Information:

North Star has a College Access & Success Team of nine full-time counselors who support seniors through the college process, as well as alums. Seniors receive support with college application processes, Questbridge, POSSE and Cooperman Scholars applications, parent engagement workshops, one-on-one family meetings, and FAFSA/CSS Profile workshops. Graduates enroll in institutions such as the University of Pennsylvania, MIT, Princeton, Cornell, Oberlin, Rutgers, Syracuse, NYU, and Spelman.

And targeted, student-centered investments include continued investment in our students wellbeing in all aspects ranging from a launch in a state of the art High School Engineering lab, a full-time special education program to better serve students impacted by autism and afterschool + summer enrichment programs.

Twenty-seven years ago in Newark, New Jersey, 72 students became the pioneering class of North Star Academy Charter School. Today, North Star Academy is one of the largest charter schools in New Jersey, serving over 6,000 students in Newark across 14 campuses. With approximately 86% of students qualifying for free or reduced priced lunch, North Star Academy has gone on to prove that low income students from Newark can achieve at the highest levels. North Star Academy is a free, public K-12 charter school. There is no entrance requirement to apply. North Star Academy participates in the Newark Common App, a universal enrollment application which allows families to apply to multiple charters on one single application. From Kindergarten through 12th grade, students engage in a challenging curriculum. Teachers use student assessment data to target their daily lessons to meet the unique needs of each student, at every academic level, and guide students to success.
