














English Language Arts and Mathematics Performance Trends








NJSLA Science Assessment: Grade 5 Summary













Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.











The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Highlights:

- PCSST K-1 & 2-3 campuses are committed to educate the whole child through social-emotional development, including enrichment & support activities along with rigorous and technology-infused instruction
- ROAR time at the 4-7 campus dedicates 20 minutes daily to independent reading, fostering a love of books and enhancing literacy as students and staff enjoy reading materials of their choice.
- PCSST 8-12 campus provides several Advanced Placement courses and dual enrollment opportunities. PCSST 8-12 has very successful STEM, JROTC, and Athletics programs.



Mission, Vision, Theme:

The mission of the Paterson Charter School for Science and Technology (PCSST) is to provide a responsive educational model that will empower all students, through a standards - equity based academic program founded on expectations for high achievement that will graduate literate, responsible, self-directed citizens who have the core knowledge and skills needed to be successful, contributing members of society. PCSST has established an approach to education that is based on best practices research. PCSST teachers engage in frequent common and cross-curricular planning during which student work and performance data are analyzed and used to improve programming and practices to further student learning. Common professional development activities are undertaken during the summer orientation and throughout the school year by all faculty members to ensure a common language of instruction and a common understanding of school goals and objectives along with vertical articulation takes place.



Awards, Recognition, Accomplishments:

PCSST earned Middle States accreditation for growth in 2014. In 2021, PCSST earned re-accreditation with the Middle States under the Excellence for Design model until 2028. PCSST offers 12 Advanced Placement courses and has a partnership with eight colleges and universities for dual enrollment. PCSST students have received Ivy League acceptances every year since 2013, with the first West Point acceptance in the class of 2019. PCSST has an award-winning JROTC program, with over two hundred cadets participating. In 2021, PCSST was granted our fourth renewal for our fifth term by the NJDOE. PCSST recently celebrated its 20th year anniversary by hosting a ceremony to highlight the growth and achievements of our district. A community carnival was also held to celebrate our anniversary with the larger PCSST community.

Courses, Curriculum, Instruction:

PCSST believes that every child has the right to high-quality instruction and should graduate prepared for college and career. A culturally responsive philosophy guides the creation of classroom structures and the teaching of routines to establish positive classroom management. Curriculum, instruction, and assessments are aligned with the NJSLs, supported by a standards-based curriculum across all courses. Teachers design their instruction and assessments to match these standards, enabling them to measure student mastery of grade-level expectations. In the elementary grades, the focus is on providing high-quality instruction that equips students with the foundational reading and writing skills necessary for lifelong success. College and career readiness is central to the curriculum at the 8-12 campus, where a variety of AP and honors courses, along with hands-on electives, are available.



Sports and Athletics:

Sports Offered: Baseball (Boys), Bowling (Coed), Cheerleading (Coed), Cross Country (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Volleyball (Boys & Girls)

The PCSST Athletic Department offers 12 varsity programs that cater to diverse interests, allowing students to compete at high levels. Five middle school programs nurture young athletes and prepare them for future varsity competition, ensuring a continuum of athletic development. PCSST Boys Basketball has won 6 NJIC Division titles, 3 Sectional State Championships, 1 County Title, and 1 Group State Championship. In 2023-2024, PCSST hosted the 3rd Annual Cross-Country Invitational, "Serving Up The Season" Volleyball Tournaments, and the 9th Annual Holiday Classic for basketball. Student-athletes earned the NJSIAA Sportsmanship Award, and PCSST Athletics achieved Level 2 recognition on the NFHS School Honor Roll. Additionally, PCSST received its first-ever two Division 1 Full Athletic Scholarships in boys volleyball, highlighting a commitment to sportsmanship, leadership, and excellence where students develop skills, build friendships, and represent PCSST with pride.



Clubs and Activities:

PCSST provides a diverse extracurricular program with over 20 clubs, competitions, and sports teams, allowing students to explore their interests. Lower elementary clubs include Gardening, Art, and Music. In middle and high school, options expand to Arts and Crafts, Reading, Spanish, Book Club, Choir, Academic, Computer, Technology, and Fitness/Sports Clubs. The "World is Our Classroom" travel club, active since 2007, enables students and staff to explore various countries on three continents. Students also participate in JROTC Raiders, Robotics, Science, Social Studies, and Art fairs, as well as sporting events and service learning opportunities.

Before and After School Programs:

PCSST offers after-school programs to students who need extra help on core courses and enrichment programs for college-bound students. Credit recovery is an after-school program for high school students to help them gain the credits necessary to be on track for graduation. Math and ELA tutoring is offered to students in grades K-12 through an after-school tutoring program. Saturday Academies are held in grades 2-12 to provide tutoring on Saturdays to students who need additional support. The College Coaching Program is designed for college-bound students to get them ready for college by providing enrichment activities and SAT prep. This program is open to students in grades 6-12. At our K-1 campus and 2-3 campus, before and aftercare is provided through our Lion Pride program. At the K-7 level, we have also partnered with the local Boys and Girls Club to provide extended time for after-school care.



Staff and Professional Learning:

PCSST faculty begin the school year with an extensive professional development program. New staff receive four days of training during new teacher orientation, followed by five additional days during full staff orientation. Three full and two half days are set aside for professional development throughout the year. In 2023-24, each campus had distinct professional development goals, covering topics like restorative practices, small groups, and management. Additional workshops are planned by PCSST administrators as needed. Staff also engage in out-of-district webinars and are part of professional organizations. Each campus has a Professor in Residence through a partnership with William Paterson University and the Professional Development School Network, coaching teachers, providing resources, and developing workshops.



Postsecondary Information:

PCSST Class of 2024 consisted of 77 scholars; 70 percent received acceptance to post-secondary institutions, including 4-year universities and 2-year colleges. The remaining percentage of scholars chose a non-traditional route such as military, trade schools or workforce. Collectively the class earned over \$11,456,859 worth of Scholarships. Students who are uncertain about post-secondary plans usually seek employment which is supported by the PCSST Alumni program. From the 595 college acceptances, some College/Universities included; WestPoint, Princeton, Cornell, Carnegie Institute of Technology, FIU, UCLA, BC, George Washington, Howard, Rutgers, WPU, DSU, Felician, MSU, FDU, NJIT, Penn State, NJCU, Rider, Seton Hall, Caldwell, Bloomfield, NYU, Emerson, Berkeley, Pace, Morgan State, Ramapo, Norwich, Kean, Lehigh, University of Florida, NYIT, Saint Peters, Boston, Rowen, Coppin State, US Army, North Carolina AT&T, UMass, SUNY and more.

Student Supports and Services:

PCSST offers a wide range of services to support diverse student needs, including ML and special education. ML students benefit from 90 minutes of daily ESL instruction, while special education services, guided by CST evaluations, provide both in-class and pull-out resources. Students with IEPs can access speech, occupational, and physical therapy, counseling, and academic support via 504 Plans. Additional academic assistance is available through small group instruction and after-school tutoring. Transition services for students with IEPs and 504 Plans include visits to college fairs at Kean College and Seton Hall University. For students facing behavioral or learning challenges, PCSST's I&RS committee and BCBA services implement targeted strategies, offer staff training, and facilitate social groups. Collaborations with community partners like Perform Care, Teen Thrive, and local organizations provide essential resources for family, mental health, and substance abuse support.



Student Health and Wellness:

Today's students face various stressors that can impact their emotional health, from short-term struggles to more serious, long-lasting issues. While school counselors help address some concerns, major crises may require assistance from professional mental health experts. PCSST has contracted a private counseling service to provide social-emotional support, including screenings, crisis counseling, group sessions, and treatment for socio-emotional problems. During the spring semester, PCSST held Mental Health Awareness Week, where students and staff participated in sessions focused on mental well-being. In July, incoming 8th-grade students take part in a transition program designed to help them adjust to the challenges of a new school, including academic expectations and social changes. Team-building activities foster confidence and skills, preparing students for high school and beyond.



Parent and Community Involvement:

The goals of PCSST are to encourage interaction between family and school, serve as a source of support, and work with teachers, staff, and the community at large to improve children's educational experience. The PTO works closely with the school administration to meet these goals. Multiple lines of communication have been established to make parents a part of the PCSST learning community. Examples include letters/newsletters, parent-teacher conferences, the school website, the broadcast message system, Class Dojo, and various social media accounts that are used to communicate vital information when families might not find time to come to the school. PCSST started offering parent training sessions such as Internet Safety parent training, how to Build Healthy Relationships with Your Kids, suicide prevention parent training, and ESL & GED classes for the parents and community members.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Teachers. The New Jersey School Climate Improvement Survey, conducted in the spring, gathered feedback from parents, staff, and students. Developed by Rutgers University's School Climate Transformation Project with the NJDOE, the survey highlighted PCSST's strengths, including a positive environment, commended by 96.29% of parents, and strong safety measures, praised by 85.18%. Parents also valued the well-maintained infrastructure, with 92.59% noting it as a strength, and 83% appreciated teachers' commitment to fostering critical thinking. However, the report identified areas for improvement: 39.13% of parents suggested more time management lessons, 59.26% highlighted the need for better peer relationships, and staff noted inconsistency in disciplinary measures. Concerns about student sleep deprivation and mental well-being, as well as challenges like housing insecurity and food scarcity, underline the importance of targeted interventions for a supportive environment.



Facilities:

In the 2023-24 academic year, PCSST operated four campuses in Paterson, New Jersey, serving different grade ranges: K-1, 2-3, 4-7, and 8-12. The K-1 campus, located on Main Street, downtown Paterson, opened in fall 2017. It is a three-story building with fully equipped kindergarten and regular classrooms, a cafeteria, and a large indoor play area. The 2-3 Campus, on E. 34th Street, opened the previous year and features the latest classroom technology, as well as ample outdoor space with a learning area and playground. Both K-1 and 2-3 Campuses accommodate 288 students each. The 4-7 Campus, on Wabash Avenue, has been serving students since fall 2005 and currently houses 576 students. The 8-12 campus, situated at West Railway Avenue, opened in the fall of 2014. This building boasts state-of-the-art facilities, including a maker space and a spacious gymnasium, and accommodates 528 students.



School Safety:

PCSST provides a secure and welcoming learning environment across all its campuses. Each campus features a designated vestibule for visitors, where IDs are thoroughly checked upon entry. Inside the school, hallway monitors ensure smooth student transitions and maintain order during busy times. Student bathrooms are equipped with vape detectors to further enhance safety. Regular monthly fire and security drills are held throughout the academic year. Additionally, all staff participate in comprehensive security and safety training during pre-year in-service sessions conducted by state agencies or the School Safety Specialist.

Technology and STEM:

PCSST offers STEM programs starting at early ages: All classrooms are equipped with interactive Boards/Panels to allow for interactive use of the technology during every lesson. Teachers are provided with laptop computers to create and manage their lessons. Every instructional process and community communication is enhanced through the use of technology, particularly in communication with parents, students, and staff. Students are exposed to engineering and technology education by Makerspace and robotics programs in elementary school. In high school, students can take courses in design and engineering. These hands-on courses walk students through the engineering design process while teaching them how to use 3D printers and laser cutters. Students now create prototypes as part of their engineering and robotics projects. Also, PCSST offers various computer education programs, including Cisco Networking Academy, PLTW Engineering, and AP Computer Science courses.



Attendance:

PCSST prioritizes character education, integrating it into our curriculum to support holistic student development. Our middle and high schools feature an Advisory program, nurturing relationships and emphasizing college and career readiness. At the elementary level, SEL lessons are woven within the curriculum. With the generous backing of ESEA and ARP ESSER Funding, we've successfully implemented a comprehensive Social and Emotional Learning (SEL) program, extending crucial mental health services to students of all grade levels. To address the achievement gap, PCSST utilized ESEA and ARP ESSER Funds to offer "Summer Enrichment Programs" spanning 18 days at all campuses. Many students seized this opportunity.

Other Information:

The admission policy for PCSST is non-discriminatory and is designed to ensure equal opportunity for interested applicants in grades K through 12. Enrollment is open based on the availability of seats in each grade level. The average total number of applications received annually is over 1200. Due to the overwhelming number of applications for admission, PCSST conducts an annual open public lottery event to identify accepted students and the order of enrollment for each grade. PCSST has a strict uniform policy in place for all grades. Transportation is available for all eligible students through Paterson Public Schools. PCSST provides a grade-level appropriate daily schedule at its four campuses. The elementary bell schedule accommodates breaks and recesses. The 8-12 campus offered multiple Advanced Placements courses, and dual enrollment opportunities with 8 different colleges/universities to help students with college transition. All campuses utilize a variety of communication tools to reach out to parents, including the Genesis student information system, emails, SMS and automated phone messaging, social media, and one-on-one parent meetings. PCSST provides opportunities for students to gain and exercise leadership skills through student-led organizations such as the Student Council, National Honor Societies, Teen Summit participation, mentoring programs, JROTC Leadership and Raiders teams, and JROTC Cadet formation.
