Old Business

Council members reflected on February's presentations and alignment with council priorities.

Council members were provided with a link to the Dispute Resolution Findings.

New Business

Council members were reminded of their upcoming responsibilities to complete the membership survey, submit their intent to return for the 2025-2026 Council Year, and complete their annual subcommittee reports.

Jocelyn Gottlieb, assistant chairperson, reviewed the status and activities of the engagement committee, prioritizing parent and family voices.

Priority subcommittee leads gave their committee updates and reports.

Announcements

Several council members announced training and resource opportunities during the public meeting. The engagement committee captured these announcements and sent them out in an email following the meeting with corresponding links.

Public Comment

The chairperson, Dr. Paul Barbato, verbally recited excerpts from the NJ-SSEAC bylaws regarding public comment procedures. He identified that the council would not comment during the public portion of the meeting. However, he reported that comments, concerns, and recommendations were to inform current and future work of the council.

Meghan Bierly made a public comment reinforcing sentiments shared by council members following the presentations. The focus and nature of her public comments centered on the equity of access to multi-tiered systems of support, emphasizing a gap between theory and practice. She also discussed her concerns and experiences with adequate support and services. She further reiterated prior public comment statements about concerns regarding the dispute resolution process and the barriers that families face in the process.

Anjali Viswanath made a public comment to address the limited access that some students with disabilities have regarding access to specialists in their local education agencies.

The chairperson invited all public participants to provide further correspondence via email, if they had not already done so. Dr. Barbato concluded by informing all participants that, following receipt of the written submission, someone from the Office of Special Education would be in contact with them.
