Administrative Complaint Disposition – No Correspondence Received by the
Custodian Regarding This Request

GRC Complaint No.: 2013-83

Complainant: Bob Thomas

Public Agency: County of Camden

Custodian of Record: Maria Efstratiades

Date of Request: February 16, 2013¹

Date of Complaint: March 12, 2013²

Complaint Disposition: The Custodian certifies that she did not receive a records request from the Complainant. Additionally, the Complainant has failed to provide any evidence to contradict the Custodian's certification. Therefore, this complaint is without any reasonable factual basis to pursue.

Applicable OPRA Provision: "The custodian of a public agency shall adopt a form for the use of any person who requests access to a government record held or controlled by the public agency. The form shall provide space for the name, address, and phone number of the requestor and a brief description of the government record sought. The form shall include space for the custodian to indicate which record will be made available, when the record will be available, and the fees to be charged. The form shall also include the following: (1) specific directions and procedures for requesting a record; (2) a statement as to whether prepayment of fees or a deposit is required; (3) the time period within which the public agency is required by [OPRA], to make the record available; (4) a statement of the requestor's right to challenge a decision by the public agency to deny access and the procedure for filing an appeal; (5) space for the custodian to list reasons if a request is denied in whole or in part; (6) space for the requestor to sign and date the form; and (7) space for the custodian to sign and date the form if the request is fulfilled or denied. The custodian may require a deposit against costs for reproducing documents sought through an anonymous request whenever the custodian anticipates that the information thus requested will cost in excess of \$5 to reproduce." N.J.S.A. 47:1A-5(f).

"A request for access to a government record shall be in writing and hand-delivered, mailed, transmitted electronically, or otherwise conveyed to the appropriate custodian." N.J.S.A. 47:1A- 5(g).

¹ This date is based on the Denial of Access Complaint. The Complainant did not attach a copy of the relevant OPRA request and did not return three (3) telephone calls from the GRC to rectify the deficiency (messages left each time).

² The GRC received the Denial of Access Complaint on said date.



“The council shall make a determination as to whether the complaint is within its jurisdiction or frivolous or without any reasonable factual basis.” (Emphasis added). N.J.S.A. 47:1A-7(e).

This is the final administrative determination in this matter. Any further review should be pursued in the Appellate Division of the Superior Court of New Jersey within forty-five (45) days.
