Corporation Business Tax Dedication

The voters on Nov. 4, 2014, approved Public Question #2 to amend the New Jersey Constitution with a clause creating a permanent annual dedication of a percentage of the Corporation Business Tax (CBT) to conservation, historic preservation and pollution management programs.

Initially the referendum stipulated that 4% of CBT revenue be dedicated to these environmental purposes. Of this, 71% was to go to GSPT-funded conservation and preservation programs.

Starting in Fiscal Year 2020, the CBT dedication increased to 6%. The share of that dedication that went to GSPT-funded programs also increased to 78%.

The table on the first page in this section shows that according to the Comprehensive Annual Financial Report (CAFR) for FY2020, CBT collections reached \$4 billion in Fiscal Year 2020, resulting in a dedication of \$191 million to GSPT-funded programs.

Accounting for a reserve of 25% to be withheld, this provided \$59 million to the Green Acres program, \$29.4 million to DEP for capital projects, \$44.5 million for Farmland Preservation and \$10 million for Historic Preservation.

The tables on the pages after that will show the funds reported by Treasury's Office of Management and Budget (OMB) as available for appropriation from FY2017 to FY2020.

These sums for FY2020 are less than in the first table because OMB made these forecasts at the time of the enactment of the State Budget in June 2019. CAFR shows CBT collections were 12% higher than expected.

These extra funds are not lost. Because this is a constitutional dedication, unused funds are always carried forward to the next fiscal year.

Conservation Lands Preserved

The Garden State Preservation Trust has financed and monitored the funding for conservation agencies whose dedicated, innovative staffs have been running the largest state-based land conservation program in the history of the United States.

There are many ways to tell these stories but on the following pages they are told by columns of statistics: Acres preserved in each town and county, the local achievements that mean so much to the people who live locally. Yet over the course of the past 20 years, these "small" acquisitions taken together exceed the size of Grand Canyon National Park.

The first section compiles acreage preservation statistics for the past 20 years under the GSPT.

The next section concentrates on the parks, forests and wildlife refuge lands acquired and preserved through the Green Acres program by State Acquisition as well as by grants to counties, municipal governments and nonprofit land trusts.

The third section compiles statistics for the 35-year history of easement acquisition through the Farmland Preservation program. In these projects, the threat of sprawl development is removed through the purchase of agricultural easements on the land. The result is the farmland remains in private hands but is restricted to agricultural use so that the soil and water resources are permanently conserved.



Historic Preservation

Most cities and towns have cultural and historic sites by which the residents are able to define their community. It is impossible to place a cash dollar value on such local treasures just as it is difficult to quantify the damage when they are allowed to deteriorate or are lost.

Historic sites have a unique role in helping us understand our New Jersey story – and these precious sites through the threat of re-development or from sheer aging and overuse must have funding for improvements and rehabilitation.

The New Jersey Historic Trust was established in 1968 to facilitate a way to preserve historic sites. The mission was brought to life with its first public financing in 1992. Since then the Historic Trust has invested more than \$150 million in matching funds to stimulate at least \$300 million in historic site rehabilitation and management, plus countless millions in heritage tourism.

Since FY2000, the financing mission was carried forward by the Garden State Preservation Trust. Now under the CBT dedication the Historic Trust enjoys its highest-ever levels of annual funding.



Land conservation programs sometimes draw criticism for investing taxpayer resources in pristine areas without paying enough attention to cities and to blighted urban parks.

In New Jersey, such criticism comes only from those who lack knowledge of the programs.

Since its inception 60 years ago, the Green Acres program has placed an equal emphasis on the improvement of urban parks and the development of recreational facilities around New Jersey.

Under the Garden State Preservation Trust funding system established in FY2000, more than \$477 million has been invested in recreational projects and for local grants, almost 70 percent of it to New Jersey's "urban aid" cities.

The need to preserve wetlands habitats and cool, green forests has always been in balance with the needs for children in cities and densely populated suburbs to have safe playgrounds and for residents to get the exercise essential for a healthful life.

The following tables identify projects as well as the grants and funding they have received.

In many cases, grants are awarded to urban counties and to cities to fund an array of projects and improvements throughout their park system. In these cases it can be difficult to separate out the funding for a specific site. But this kind of flexibility in a multi-project approach is efficient and effective.

The CBT dedicated funds are deposited into three "Preserve New Jersey" accounts from which appropriations are drawn:

- 1.Preserve NJ Green Acres Fund
- 2. Preserve NJ Farmland Preservation Fund
- 3. Preserve NJ Historic Preservation Fund

Appropriations go to

- · Green Acres Program for land acquisitions
- Green Acres for grants to local governments
- Green Acres for grants to nonprofit land trusts
- Blue Acres flood property buyouts
- DEP for capital projects in the Division of Parks & Forestry and the Division of Fish & Wildlife
- State Agriculture Development Committee (SADC) for farmland preservation
- SADC for grants to local governments
- SADC for grants to nonprofit land trusts
- NJ Historic Trust for historic site restoration or rehabilitation projects
- NJ Historic Trust for historic site management grants.

Each of these agencies submits project lists to the board of the GSPT to assess project recommendations against funds available.

Once resolutions are approved by the GSPT members, the Legislature introduces Appropriations Acts for votes in the Senate and Assembly, after which they go to the Governor for his signature.

The voters on Nov. 3, 1998, approved Public Question #1 to amend the New Jersey Constitution with a clause creating the annual dedication of \$98 million in Sales Tax revenues for 30 years.

The Garden State Preservation Trust was established the following year as the financing authority to generate bond proceeds and to monitor their expenditure.

In 2003, the GSPT executed its first bond issue of \$500 million, followed by "forward delivery" bond issues of \$500 million and \$150 million in 2005.

This was the first time a specific conservation agency had issued New Jersey bonds. The 2003 and 2005 bond issues in combination also represent the largest public financing for conservation in U.S. history.

The following tables show the debt service structure of the original GSPT bond issues, including the issuance of refinancing bonds in 2005 and 2012 to reduce the taxpayers' annual debt service costs.

Municipal Open Space Tax Rates & Revenues

There are 235 cities and towns in 2020 which have a special property tax rate in effect in their community to set aside funds for "open space." These local taxes are approved by the residents in voter referendums.

This money can be used to acquire land for recreational parks or natural areas or to preserve privately owned farmland. These local funds are crucial in putting up the matching dollars required to draw down county and state funding that provides most of these acquisition costs.

In most cases, the "open space" funds can also be used to develop or improve recreational facilities on preserved lands.

The most recent tax rate data shows that \$105.2 million is raised annually at the municipal level.

Tax rates in these tables are shown as fractions of a dollar – in other words, as cents. The rate as shown is charged against every \$100 of the assessed value of a property.

For example, if the tax rate is 0.010, a property assessed at \$300,000 would pay \$30 a year for the open space tax.

The tax rate and revenue data listed here is taken from the Abstract of Ratables filed annually with the NJ Division of Taxation.

County Open Space Tax Rates & Revenues

All 21 counties in New Jersey have a special property tax rate in effect to set aside funds for "open space." These county taxes are approved by the residents in voter referendums and are separate from any open-space tax passed by a municipality.

While 330 municipalities have not implemented an open-space tax of their own, their property owners are still required to pay into the county open-space tax.

The effective tax rate varies from town to town each tax year because of disparities in municipal tax assessments.

Tax revenues collected from this special rate can be used to acquire land for recreational parks or natural areas or to preserve privately owned farmland. These local funds are crucial in putting up the matching dollars required to draw down state funding that provides a large share of the acquisition costs.

Many counties also use "open space" funds to develop, improve and maintain recreational facilities in their parks.

The most recent tax rate data shows that \$216.5 million is raised at the county level in 2020. Combined with the \$105.2 million raised annually at the municipal level, this provides \$321.7 million in county and local funding to match and therefore to draw down state preservation dollars.

The tax revenues listed here are taken from the Abstract of Ratables filed annually with the NJ Division of Taxation.
