Federal Retail Pharmacy Program to Launch

An additional federal retail pharmacy program will launch next week through the state's continued partnership with Rite Aid and CVS.

As Governor Murphy outlined in a press briefing Wednesday, since most Americans live within five miles of a pharmacy, the new program will expand the state's footprint in areas of high need and is poised to receive direct allocation from the federal government without tapping into the state's supply.

A Day in the Life of the State's Vaccination Megasites

February 5. 2021

The state's six regional megasites can vaccinate thousands each week – on Thursday, the sites vaccinated over 10,000 that day. As vaccine availability increases, the sites will be able to scale up even more. Running a megasite smoothly to meet the demand requires teamwork and deft coordination.

"Putting together a mass vaccination site is a huge undertaking that requires collaboration and many hours of hard work," New Jersey Department of Health (NJDOH) Commissioner Judith Persichilli has said.

Staff begins arriving early, typically between 7 a.m. and 8 a.m. depending on their role. Site hours are generally 8 a.m. to 6 p.m. but days and hours can vary by site.

The six sites are located in <u>Atlantic</u>, <u>Bergen</u>, <u>Burlington</u>, <u>Gloucester</u>, <u>Middlesex</u> and <u>Morris</u> counties.

The **staff** is a mix of healthcare professionals from the site's healthcare partner, or, in Gloucester, from the county health department; National Guard; representatives from NJDOH, state Office of Emergency Management and State Police; and some volunteers. In addition, there are administration staff from the healthcare partner, security and also a full medical team onsite in case of an adverse reaction.

Appointments for the day have already been scheduled in advance. Except for

the Gloucester County megasite, where appointments can be made via the New Jersey Vaccine Scheduling System, the other sites have their own registration portals.

Doors open

As individuals enter, they are greeted by the National Guard or other staff who will check their name against the roster of appointments, take their temperature and guide them to the **registration** area.

When individuals are registered, they are given a QR code which is scanned at each point in the process and helps the site keep track of people. Tracking the flow will help the site make modifications if needed to improve operations.

Individuals then move to the **vaccination area** where they will be asked a few medical questions. Once they have cleared the medical questions, it is time to roll up their sleeve and receive their COVID-19 vaccination.

After being vaccinated, individuals move to an observation area for 15 minutes or, if they have previously had an adverse reaction to medicine, are observed for 30 minutes. In between vaccinations, staff moves in to disinfect all areas.

Checking out

After **observation**, the National Guard assists to check out the newly vaccinated, who are expected to return to the same site for their second dose.

All in all, the whole process should be done within an hour. Virtua Health, the healthcare partner in the Burlington County megasite, even put together a <u>video</u> walking viewers through the process. By day's end, as operations close down, a cleaning crew goes through each site getting it ready for a new day of vaccinating the public.

Vaccination Safety, Rollout Among Topics in NJDOH Video Podcast Series

A new video podcast series by NJDOH debuted this week and is addressing the importance of vaccination across communities.

The first installment featured a discussion on the importance of COVID-19 vaccination and hesitancy among workers in long-term care settings with Lisa Williams, Executive Director, Maplewood Senior Living at Princeton, and Chair of the Assisted Living Council, Health Care Association of New Jersey.

"We've done a lot of town hall meetings so that the staff can ask questions as far as the vaccine is concerned," Ms. Williams explained of outreach efforts in the video. "It really was the responsibility of the leadership of the facilities to educate the staff as far as the importance of the vaccine and answer any questions they might have because it was a lot of the fear of the unknown as far as the vaccine was concerned."

Future podcasts will focus on vaccine distribution in New Jersey; vaccine development, safety and efficacy; maintaining COVID-19 health and safety personal behaviors; and the importance of vaccinating seniors. The series is part of the state's vaccination public awareness efforts.
