

NJDOH Monoclonal Antibody Therapy Process and Important Contact Information

All requests for allocation of monoclonal antibody therapies must now be done through the New Jersey Department of Health. Orders may no longer be placed directly with Amerisourcebergen. Cycles are weekly at this time. Should that change, all sites with valid and current Amerisourcebergen accounts will be notified.

All sites should continue to report daily to the federal tracking system. Failure to do so, or to not accurately report patient and administration data may result in no allocations being received for that cycle. Additionally, allocation requests must be done via the NJDOH surveys according to the schedule on the right of this document. No allocations can be made without survey data except initial ordering for new sites. Surveys links are:

The survey for usage reporting/product ordering is done EVERY MONDAY. The survey will be open from 12:01 a.m. through 10:00 p.m. There will be no data recorded after that time. Complete all questions in the 'Facility/ Provider Information' and 'Allocation' sections. Product requested and patient usage data will be tracked and allocation quantities will be determined based on that data. There is no stockpiling of product at this time due to limited supply.

A supplemental survey for urgent orders only will be open from 7:00 a.m. to noon on Thursdays. Fulfillment of any urgent requests is based on quantities available and must be supported by patient usage data. Requests received will be processed immediately with notes regarding order urgency so that shipment can be expedited. The

Department of Health cannot determine or influence delivery times. Please contact your Amerisourcebergen account representative if there is a concern about the shipment of your order.
