Dear Youth Camp Owners/Operators/Directors:

Prior to this coming summer youth camp season, the Public Health and Food Protection Program (PHFPP) is reminding all camps about the importance of recognizing, reporting and mitigating communicable disease outbreaks in a timely manner. The New Jersey Department of Health's Communicable Disease Service (CDS) has posted a guidance document, *General Guidelines for the Prevention and Control of Outbreaks in Camp Settings*, on their website at <a href="http://www.nj.gov/health/cd/documents/topics/outbreaks/camp\_outbreak\_guidance.pdf">http://www.nj.gov/health/cd/documents/topics/outbreaks/camp\_outbreak\_guidance.pdf</a>
Please review this document carefully. This guidance document provides essential information to camps regarding the prevention and management of communicable disease outbreaks. Ongoing and effective disease surveillance will allow camps to immediately implement control measures, and timely reporting will allow both local and state health authorities to provide assistance as needed.

Outbreaks must be <u>immediately</u> reported by telephone to the local health department under which jurisdiction the camp is located, and <u>within 24 hours</u> to the PHFPP at (609) 826-4935 or by fax at (609) 826-4992.

Please note that for instances when disease transmission is <u>NOT</u> effectively controlled, the PHFPP has the authority to suspend a camp's Certificate of Approval and close the camp until control measures are proven effective and camper health and safety are assured. Therefore, it is very important that camps react promptly to indications of disease presence and possible transmission concerning both campers and staff.

Camps are further reminded that health histories for all campers (and minor staff) must include documentation of the immunizations required for Preschool and K-12 school age children as specified on in the Youth Camp rule at N.J.A.C. 8:25-5.5(g) and as listed on the CDS Immunization Requirements webpage at

And finally, we are emphasizing that **all Camp Health Directors** (and backups, as needed) are required to possess a current **professional-level cardiopulmonary resuscitation** (**CPR**) **training certification**.
