Re: **Notice of Proposed Suspension of EMT Certification (# 550107)
Investigation Control #2018-0154V**

Dear Mr. Williams:

The New Jersey Department of Health is vested with the responsibility of carrying out the provisions of the Health Care Facilities Planning Act, N.J.S.A. 26:2H-1, et seq., which was enacted, in part, to ensure that all hospital and related health care services rendered in the State of New Jersey are of the highest quality. As defined at N.J.S.A. 26:2H-2b, health care services include any pre-hospital care rendered by basic life support (BLS) personnel. In furtherance of the objectives set forth in the statute, the Department of Health (the Department) has adopted regulations that govern the training, certification and professional conduct of Emergency Medical Technician (EMTs), such as you. See N.J.A.C. 8:40A-1.1, et seq.

On December 28, 2018, investigators from the Department's Office of Emergency Medical Services (OEMS) were conducting inspections on licensed ambulances at the emergency department of Trinitas Regional Medical Center in Elizabeth, New Jersey. During this time, investigators began inspecting a vehicle from Smart Care Mass Transit (Vehicle # 602), of which you were a crew member. Upon requesting your credentials and access to the vehicle, you became indignant, uncooperative, and walked away from the investigators, ignoring their request. At one point, while approximately 200 feet away from the investigators, you were asked for your credentials again. Your response was, "you want them, come down here and get them." It was not until the investigators stated that you were hindering an investigation and would be subject to penalty action that you followed the investigators to their vehicle and

provided your credentials. While providing your credentials, you continued to be uncooperative holding your identification in the investigator's face.

As a certified EMT, you should already be aware that OEMS is authorized to conduct inspections of emergency medical vehicles and require EMTs to produce their credentials upon demand. Specifically, N.J.A.C. 8:40-2.6(a) provides that “[a]uthorized representatives of the Department may conduct periodic vehicle inspections and provider audits as necessary to determine compliance with this chapter.”

Furthermore, N.J.A.C. 8:40-4.1(a) states that “[e]ach crewmember who is operating a vehicle shall possess a valid driver’s license, as required by N.J.S.A. 39:3-10. Licenses shall be made available to Department staff upon demand.”

Even more, N.J.A.C. 8:40-4.1(e) provides that “[e]ach crewmember shall possess and shall make available to Department staff upon demand, certification for the type or level of patient care he or she is providing. No person shall be allowed to provide a type or level of patient care beyond the level he or she is lawfully eligible to provide in the State of New Jersey. In addition, each crewmember shall, upon request by Department staff, produce a photo I.D. that Department staff may utilize in order to verify the validity of the required certification credentials.”

Upon review of the incident and your actions on December 28, 2018, the Department finds that you have not complied with the above cited regulations.

Pursuant to N.J.A.C. 8:40A-10.2(b), “[t]he Commissioner, or his or her designee, may issue a formal written warning, impose a monetary penalty, place on probation, suspend, revoke and/or refuse to issue or renew the certification of any EMT or EMT-Instructor for violation of any of the rules set forth in this chapter. This includes, but is not limited to:

17. Willful obstruction of any investigation and/or representative of the Department or other agency empowered to enforce the provisions of this chapter or any applicable law, rule and/or regulation. . . [and]

23. Failure to comply with any part of this chapter, any applicable part of N.J.A.C. 8:40 or N.J.A.C. 8:41, or any applicable law, rule and/or regulation.”

On December 28, 2018, you not only failed to produce your EMS credentials upon request by the OEMS investigators, as you are required to do under the above rules, but you also hindered OEMS’ inspection of an emergency medical vehicle and its crewmembers. **Consequently, the Department is suspending**

your EMT certification for a period of thirty (30) days. Following the suspension, you shall be placed in a probationary status for a period of twelve months. Additional regulatory violations will result in further action against your certification up to and including revocation. As such, the suspension will begin on March 15, 2019 and end on April 15, 2019.

Please note, in accordance with N.J.A.C. 8:40A-10.2(d), you are prohibited from acting in the capacity of an EMT on any mobility assistance vehicle, BLS ambulance, mobile intensive care unit, specialty care transport unit or air medical unit while your certification is suspended. The suspension may be followed by a probationary period; however, you will be permitted to enroll and successfully complete the educational conditions outlined during this suspension period.

N.J.A.C. 8:40A-10.2(e) provides that, "An EMT-Basic who has been placed on probation may be monitored for performance by the Department."

1. A person who has been placed on probation shall operate only when under the direct supervision of an EMT or EMT-Paramedic. Under no circumstances may a person who has been placed on probation act independently or in conjunction with, or on the same MAV, BLS ambulance, or SCTU as, another probationary EMT-Basic.
2. The Department shall have the right to restrict or otherwise limit the scope of practice of the probationer. Failure to meet such conditions or any terms of probation shall be cause for revocation of certification and/or other such action the Department deems appropriate."
 - i. Monitoring shall include of all calls in which you provide Basic Life Support services (including 100% chart reviews) by any EMS program by which you are employed. Your employer's Medical Director is required to provide a written quarterly report to the Department as to your progress and any remediation that may be needed;
 - ii. You shall provide the Department within 14 days of your probation with the name(s) of all of the EMS programs you are employed by or volunteer with. You are required to notify the Department within one (1) business day in any changes in your status with these agencies.

Please note, in accordance with N.J.A.C. 8:40A-10.2(d), you are prohibited from acting in the capacity of an EMT on any mobility assistance vehicle, BLS ambulance, mobile intensive care unit, specialty care transport unit or air medical unit while your certification is suspended. The suspension shall

last for a specified period and may be followed by a probationary period; however, you will be permitted to enroll and successfully complete the educational conditions outlined during this suspension period.

Pursuant to N.J.S.A. 52:14B-1, et seq. and N.J.A.C. 8:40A-10.2(b), you are entitled to a hearing before the Office of Administrative Law to contest this proposed suspension. Your request for a hearing on this matter must be submitted in writing and must be accompanied by a response to the charges contained herein. In the event that you request a hearing, the proposed suspension will be held in abeyance and you shall retain your EMT certification until such time as the hearing has been concluded and a final decision has been rendered. Your request for a hearing must be submitted within 30 days from the date of this Notice and should be forwarded to:
