Dear Vendor Representative:

Federal regulation 7 CFR 246.12(h)(3)(B)(xii) requires all authorized WIC vendors to participate in the Annual Vendor Training during a 3-year authorization period. State Agency (SA) is requiring WIC Authorized Vendors to complete the Annual Vendor Training.

The content covered during the Annual Vendor Training will include, but will not be limited to, information related to the purpose of the WIC program, authorized supplemental foods, minimum stock requirements, eWIC transaction and redemption process, the Federal and State sanction system, complaints, claims procedures and any changes to the program requirements. The information included in the PowerPoint presentation will satisfy the training requirement for Federal Fiscal Year (FFY) 2023.

The training will be offered via **Novi Survey** as a self-paced PowerPoint Presentation. You will be required to enter your Vendor Identification Number, along with other store identifying information at the end of the training. Entry of this information will provide verification of completion of the Annual Vendor Training FFY 2023.

Chain/corporate stores or owners with multiple WIC authorized stores are eligible to complete **ONE** Annual Vendor Training for all their WIC authorized store locations. Vendor Identification (ID) Numbers for all store's must be entered in NoviSurvey.

A minimum of one store representative must complete this training. It is suggested that the store representative you select is someone who will be responsible for the daily supervision of cashiers and WIC transactions. **Failure to complete the training will prevent your store from participating as an authorized WIC vendor.**

The training must be completed, and Vendor Information entered via Novi Survey no later than August 11, 2023.
