New Jersey WIC has scheduled Interactive Trainings for Authorized WIC Vendors. The trainings will satisfy mandatory federal requirements for Vendors who must attend an Interactive Training prior to the time of Vendor's authorization period, October 1, 2024 – September 30, 2027.

A minimum of one store representative must join the webinar. It is suggested that the store representative you select is someone who will be responsible for the daily supervision of cashiers and WIC transactions. **Failure to join the scheduled webinar will prevent your store from participating as an authorized WIC vendor.**

The NJ WIC Annual Vendor Training will be hosted on **GoToWebinar** and will require registration to ensure your store location(s) receives credit for attendance. Upon completion of the mandatory online interactive training session, a Vendor Agreement will be provided for the store representative to sign. The signed Vendor Agreement must be submitted by email to NJ.WICVendor@doh.nj.gov prior to **August 30, 2024**.

Chain stores are eligible to submit **ONE** signed Vendor Agreement for all their NJ WIC authorized store locations. The submission of the Vendor Agreement must also include a list of all applicable stores included under this Agreement.
