

**NEW JERSEY WIC VENDOR MINIMUM STOCK REQUIREMENTS**  
**SMALL INDEPENDENT STORES**

The following table outlines the **minimum stock requirements** for NJ WIC Authorized Vendors.

Cash-Value Benefit (CVB) (Vegetables & Fruits)	3 Varieties Each of: Fresh Fruits, Fresh Vegetables, Canned Fruits, or Vegetables, Frozen Fruits or Vegetables	varies	CVB: dollar amount available in eWIC benefit balance for fresh, frozen & /or canned vegetables & fruits only

**Note: Exceptions to the Vendor Selection Criteria may be granted if the State agency determines that a vendor is needed for participant's access or in the event of a disaster situation, in accordance with the State agency's policies.**

**\*Minimum Stock Requirements for Baby Foods: One (1) 2-pack equals two (2) individual 4-oz containers.**

**Examples:**

- 16 individual 4-oz Baby Fruit containers = 8 two-pack containers
- 32 individual 4-oz Baby Vegetable containers = 16 two-pack containers
