

Enclosed is an Order of Summary Suspension, issued under authority of N.J.A.C. 8:39-43.5(b), for unlawfully entering the home of another, and attempting to burn it down, resulting in being charged with aggravated arson in the second degree under N.J.S.A. 2C:17-1A(2), burglary in the third degree under N.J.S.A. 2C:18-2A(1), and criminal mischief in the third degree under N.J.S.A. 2C:17-3A(1).

As of your receipt of this Order, your nurse aide certification is no longer valid. However, you have thirty (30) days from the date you receive this notice to appeal this summary suspension to the Commissioner of the Department of Health, as set forth in the enclosed Order. Please review the Order carefully, as failure to submit a written request for emergency relief within 30 days from the date of receipt of this Order shall be interpreted as an acceptance of this Department's decision to summarily suspend your nurse aide certification pending completion of the investigation, thereby forfeiting all rights to emergency relief..



TAKE NOTICE that, in accordance with the authority set forth in N.J.S.A. 26:1A-1 et seq., N.J.S.A. 26:2H-1 et seq., and the provisions set forth at N.J.A.C. 8:39-43.5(b), the New Jersey Department of Health (hereinafter, "the Department") hereby

FINDS that you, Twynia Woodard, Certification No. NA 200015432, is a certified nurse aide within the State of New Jersey, which certification entitles you to obtain and/or maintain employment at nursing homes, other long term care health care facilities and in private residences in New Jersey, where your duties include the provision of direct, hand-to-hand care to elderly, often vulnerable, residents of said nursing homes and other long term care health care facilities; and the Department further

FINDS that credible evidence exists that Twynia Woodard, Certification No. NA 200015432, was charged with aggravated arson in the second degree under N.J.S.A. 2C:17-1A(2), burglary in the third degree under N.J.S.A. 2C:18-2A(1), and criminal mischief in the third degree under N.J.S.A. 2C:17-3A(1) based on a police report provided to the Criminal Background Unit of the New Jersey Department of Health from the Camden County Police Department. Specifically, you have been accused of, and there exists credible evidence that you unlawfully entered someone else's house and attempted to burn it down. You confessed to these actions in a taped statement made to the Camden County Police Department. The Department further


FINDS that you pose an immediate threat to the health, safety and welfare of the public, including residents of long term care facilities, assisted living facilities and other licensed health care facilities or agencies, including home health agencies that provide in-home care, and that you be immediately suspended from eligibility for employment as a nurse aide, pursuant to N.J.A.C. 8:39-43.5(b),

NOW, THEREFORE, it is hereby administratively

ORDERED that your certification to work as a certified nurse aide in a long term care facility, assisted living facility and other licensed health care facility or agency, is hereby **SUMMARILY SUSPENDED**, and your certification shall remain suspended until such time as the Department has completed its investigation into this matter; and it is further administratively

ORDERED that, in the interim, the Department will continue to investigate this matter. You will be notified when the Department has completed its investigation, at which time you will be advised of what action(s), if any, will be taken with respect to your nurse aide certification.
