This letter clarifies the letter issued on January 28, 2019. Upon confirmation on January 26, 2019 that all residents have returned to baseline for a minimum of 30 days and all residents have had at least two sequential negative tests for adenovirus, the Department has lifted the Directed Plan of Correction ("DPOC"), which required The Wanaque Center for Nursing and Rehabilitation (hereinafter "Wanaque"), to employ the consulting services of a Certified Infection Control Practitioner and a consultant Physician who is Board-certified in Infectious Disease.

The curtailment of admissions, except as previously specified, remains in effect until otherwise notified by the Department. This curtailment shall continue pending review and approval by the Department of the facility's written plan for an infection control outbreak, including the following:

- How the facility will communicate collaboratively with the Department's Communicable Disease Service;
- How the facility will communicate with the resident and/or resident representative; and;
- How the facility will address the need for cohorting of residents.

Please be advised that <u>N.J.A.C.</u> 8:43E-3.4(a)(2) provides for a penalty for each resident admitted in violation of the curtailment order. Failure to comply with any State regulations and/or with the curtailment order will result in the imposition of further enforcement remedies, including but not limited to, civil monetary penalties, and may include summary suspension and/or license revocation.
