In Re Licensure Violation:

Iselin Adult Day Care

CEASE AND DESIST ORDER

(NJ Facility ID# 12025)

The Health Care Facilities Planning Act (N.J.S.A. 26:2H-1 et seq.) (the Act) provides a statutory scheme designed to ensure that all health care facilities are of the highest quality. Pursuant to the Act and N.J.A.C. 8:43E-1.1 et seq. (General Licensure Procedures and Standards Applicable to All Licensed Facilities), the Commissioner of Health is authorized to inspect all health care facilities and to enforce the Standards for Licensure of Adult Day Health Services Facilities set forth at N.J.A.C. 8:43F-1.1 et seq.

Pursuant to N.J.S.A. 26:2H-12, no health care service or health care facility may operate unless it has a license. Additionally, pursuant to N.J.A.C. 8:43F-2.5 (b), no facility shall admit participants to the facility until the New Jersey Department of Health issues a license to operate the facility. Lastly, pursuant to N.J.A.C. 8:43F-2.6(d), the license shall not be assignable or transferable and shall be immediately void if the facility ceases to operate, if the facility's ownership changes, or if the facility is relocated to a different site.

Iselin Adult Day Care Center advised the Department through email on October 14, 2025, of a boiler issue, resulting in a relocation of its day care, Iselin Adult Day Care, from its licensed location at 477 Lincoln Hwy, 27, Iselin, NJ 08830, to 36 Meridian Road, Unit 2, Edison, NJ 08820, an unlicensed location. In accordance with the provisions set forth at N.J.A.C. 8:43E-3.11, this enforcement action was taken because of evidence indicating Iselin Adult Day Care Center participants were relocated, and services were being provided at the unlicensed, unsafe location in Edison, NJ.

CEASE AND DESIST ORDER

As you were notified verbally on October 14, 2025, effective at the end of day October 14, 2025, the Department ordered Iselin Adult Day Care Center to cease and desist all services at the unlicensed location, 36 Meridian Road, Unit 2, Edison, NJ 08820, and to refrain from doing services at any location other than what is permitted by their approved license.

Please be advised that N.J.A.C. 8:43E-3.4(a)(1) provides for a penalty of \$1,000 per day for operation of a health care facility without a license.

This Cease and Desist Order shall remain in place until the facility is otherwise notified in writing by a representative of the Department.
