Dear Dr. Lipsky and Mr. Uuumarogie:

On July 18, 2025, the New Jersey Department of Health (the Department) issued to Silver Lake Hospital LTACH (Silver Lake) a verbal order curtailing new admissions and readmissions to the facility in response to serious violations observed by Department staff at Silver Lake during its on-site complaint inspection. On July 21, 2025, the Department memorialized the verbal directive in a written order, which was amended on July 25, 2025. This order confirms that effective upon verbal notification to the facility on July 28, 2025, the Department lifted the curtailment of admissions and readmissions.
