The Health Care Facilities Planning Act (N.J.S.A. 26:2H-1 et seq.) (the Act) provides a statutory scheme designed to ensure that all health care facilities are of the highest quality. Pursuant to the Act and N.J.A.C. 8:43E-1.1 et seq. (General Licensure Procedures and Standards Applicable to All Licensed Facilities), the Commissioner of Health is authorized to inspect all health care facilities and to enforce the Manual of Standards for Licensing of Ambulatory Care facilities set forth at N.J.A.C. 8:43A-1.1 et seq.

Pursuant to N.J.S.A. 26:2H-12, no health care service or health care facility may operate unless it has a license.

ORDER LIFTING CEASE AND DESIST ORDER

As you were notified by email on September 3, 2024, effective beginning September 3, 2024, the Department ordered Care Strategies to cease and desist providing services. This enforcement action was taken because Care Strategies' license expired on July 31, 2024. Because the facility is now licensed on October 1, 2024, the Department notified the facility by email that the Department lifted the cease-and-desist order issued on September 3, 2024. This formal order confirms that the cease-and-desist order was lifted on October 1, 2024.
