The Health Care Facilities Planning Act (N.J.S.A. 26:2H-1 et seq.) (the Act) provides a statutory scheme designed to ensure that all health care facilities are of the highest quality. Pursuant to the Act and N.J.A.C. 8:43E-1.1 et seq. (General Licensure Procedures and Standards Applicable to All Licensed Facilities), the Commissioner of Health is authorized to inspect all health care facilities and to enforce the Manual of Standards for Licensing of Ambulatory Care facilities set forth at N.J.A.C. 8:43A-1.1 et seq.

Pursuant to N.J.S.A. 26:2H-12, no health care service or health care facility may operate unless it has a license.

ORDER LIFTING CEASE AND DESIST ORDER

As you were notified verbally on April 19, 2024, effective beginning April 19, 2024, the Department ordered Totowa Medical Imaging, LLC to cease and desist providing services. This enforcement action was taken because Totowa Medical Imaging, LLC's license expired on August 31, 2022. Because the facility is now licensed on April 24, 2024, the Department notified the facility verbally that the Department lifted the cease and desist order issued on April 19, 2024. This formal order confirms that the cease and desist order was lifted on April 24, 2024.
