## **RESILIENCE**

- Jamie Weller NJDOH, Office of Local Public Health
  - o Resilience functions of Local Health Departments:
    - Infectious disease-related pandemic response activities including testing, case investigation and contact tracing, isolation/ quarantine and social supports, communication, and vaccination planning
    - Coordination in public health response
    - Creation of sustainable local health workforce capacity with focus on vulnerable populations
  - Medical needs sheltering ex: after Superstorm Sandy
  - o Medical countermeasures ex: providing meds after a bioterrorism attack

- Dave Ellis NJ Dept of Children and Families, Office of Resilience
  - Sawubona Swahili "I see you" traditional greeting, more than "Hello," similar to Namaste
  - Office of Resilience public-private partnership, "in but not of," developing a statewide plan to address ACEs, training around ACEs, assisting with legislation





- Look at solutions based on root causes, not symptoms
- o Process: what did we learn, not just what succeeded
- "Self-healing communities" more than surviving, it's prevention and healing also
- o How to make NJ a trauma-informed self-healing state
- Office has an interagency team. Wants a community team. Wants a trauma-informed technical assistance center.
- o Develop statewide awareness of ACEs with common language
- o How do we gift this back to the community?
- o No ACEs-specific data currently. Plan addresses this.
- Training to all sectors, especially business community and those most directly impacted.
- o Want to host an annual summit. Plan will be a living document.
- o Atmosphere of collaboration between agencies.
- Community Capacity Development is a repeating process
- Attachment and Belonging being "present" for your children, relationships with caring and competent adults --> It takes a healthy village.
- Historical trauma needs to be factored in ask the community what's important to the community
- Leadership expansion: Who's not at the table and how do we get them here?
- o Currently under 3 pandemics: COVID, ACEs, and racial inequity
- Diversity is not about sameness, it's about conflict. We see things differently based on our experiences. We have to understand this and that there's nothing wrong with it.
- o Office of Resilience was established June 1, 2020.
- Plan to be released in late December (or when it's ready). Includes Nurture NJ.
- Stay patient, focused, and informed
- o NJ funders ACEs collaboration report (John) relevant parts for HL ACT
- o Core protective systems (John) similar to human development
- o CDC: How a reduction in "ACE score" affects work productivity

- Jeanne Herb Rutgers, Bloustein School of Planning and Public Policy
  - o Climate change exacerbates health inequities
  - Use COVID rebuilding to address climate change, biggest hurdles are underlying inequities
  - Community needs to lead. The community (not government) knows what they need to build resilience.
  - New report coming in December
