### Action Team Duties

### Healthy People Guidance (refresher)

- ✓ Offer flexible ways to organize topics.
- Refine the list based on the "most important" aspects of health:
  - Reducing deaths
  - Reducing morbidity
  - Reducing disability
  - Reducing health disparity/increasing health equity
  - Increasing well-being
- Convene stakeholders to work on topics and objectives
- Convene topic working groups

# Phase One: Development

Convene stakeholders to "refine the list based on the most important aspects of health"



**Task:** Decide what issues will be the focus of each TA



Three HNJAC members on each team



At least one DOH senior staff member on each team



At least one HNJCC member on each team



Remaining membership recruitment: TBD on subsequent slide



Will be encouraged to remain on board for Phase 2

# Phase Two: Action

Convene topic working groups to work on objectives and action plans



**Task:** 3-5 SMART objectives that will be used to measure success at the end of the decade



**Task:** Search for existing plans, policies, initiatives and continue to search at least annually



**Task:** Propose new long- and short-term plans, policies, initiatives to help achieve the 2030 targets



**Task:** Carry out or track those short-term plans



Assign appropriate DOH staff and "advertise" via intranet

## Topic Area Team Recruitment

### How to recruit?

- By invitation only?
  - Candidates who've been selected by HNJAC
- Self-identified (like HNJAC recruitment)?
  - Description and <u>application</u> online
  - Targeted emails to all suggested candidates
  - Emails to LHDs and other groups
  - Social media posts by DOH
  - Applicants self-select their Topic Area

# Updated Recruitment Timeline

- 1. Refine list of candidates (see handout) based on today and input from DOH senior staff
- 2. Initial contact with "first round draft picks" If you know a selected candidate, reach out to them
- 3. Official offer Form letters will be emailed from the HNJ account (or from the Commissioner)
- 4. Candidate responses due 6-8 weeks from initial contact (no later than Feb.1<sup>st</sup>)

# Topic Area Rationale -Background



#### **HP/HNJ2020:**

Lots of narrowly-focused TAs, limited to DOH programs



**Public Health Accreditation Board guidance:** 

Formed HNJAC



**HNJAC & HNJCC reviewed similar initiatives:** 

Most only have 4-6 broad TAs

Address upstream factors, rather than outcomes


