# **SOCIAL DETERMINANTS OF HEALTH**

- Loretta began the discussion
- Melissa: Likes giving the SDOH context of what we're doing. What about addressing structural determinants? (Structural are part of the policy section from CDC.) Will send diagram. [Edit: See Figure 1 at end of minutes for diagram.]

- Megan: We want Health in All Policies but there's no money. 96% of local health departments are only funded by local taxes. No long-term sustained funding.
- Put Jeanne's draft document on Teams so everyone can comment and edit.
- Jeanne: What to do with the action plans that don't address SDOH?
- Melissa: If the SHIP is supposed to guide the public health of the state, we need resources.
- Jeanne: Public health is shifting from traditional areas toward SDOH, equity, non-health things (housing, wages, transportation, etc.)
- Melissa: We know what we need and want to do but we need resources to make it successful.
- Megan: Resources need to be in place first.
- Melissa: Use what's in the action plans and put it into context using Jeanne's framework.
- Jeanne: The action plans aren't cohesive.
- Alycia: This document/statement becomes the forward/framework for the SHIP. Action plans become illustrative appendices.
- Jeanne: Why are the action items what they are? The answer is often "because that's what the team wanted to work on."
- Jeanne: "Look at these great ideas, but we need capacity, authority, laws, etc."
- Alycia: Cut action plans for length and focus on the main concepts.
