

**MINUTES OF A REGULAR MEETING
BOARD OF TRUSTEES
TRENTON PSYCHIATRIC HOSPITAL**

A meeting of the Board of Trustees of Trenton Psychiatric Hospital was held on **Thursday, June 15, 2023**, pursuant to notice duly given. ROLL CALL/CALL TO ORDER/MINUTES APPROVAL:

Roll call was conducted in-person. The Board of Trustees meeting was called to order at 9:30 a.m. Minutes from the May 18, 2023, meeting were approved with no changes.

BOARD REPORT:

June Monthly Report:

- Dr. Lebel remarked positively on the slightly increased number of discharges.
- Dr. Lebel expressed concern about an increase in the number of assaults in May. She said that this was discussed in the Violence Prevention Committee, but noted that the trend for incidents overall, over the past several years, is downward.
- Dr. Lebel praised the reduction in restraint use, both in number and in duration. Dr Ahmad added that he is organizing a restraint work group which will strive to encourage keeping time in restraints to no longer than necessary.
- Mr. Weisfeld noticed a significant increase in the number of minor injuries, on the assault report; Dr. Ahmad believes this can be attributed to improved reporting.
- Mr. Weisfeld and Ms. Torre both asked about implementation of the DOL grant to Thomas Edison, granted in May, which aims to provide workforce development opportunities to nursing students in partnership with TPH; Th. Ed. has not yet reached out to set up a meeting.
- Mr. Weisfeld commented on the low admission rate in May. Dr. Ahmad explained that for some months, a larger proportion of patients with legal issues (KROL; IST) were being admitted to Ancora; he expects TPH will receive more of these patients in the summer.
- Ms. Torre praised the delinquency rate, at 0%, again, in May.
- Ms. Torre asked the outcome of the PSCU site visit on May 16th: they reviewed staff deployment and therapeutic programming. Recommendation: redo staff badges, some of which are blurry.
- Ms. Torre asked for an explanation of the nature of two A plus level incidents; Dr. Lebel has not yet received an explanatory report from Quality Improvement for the Incident Review Committee; this is slated to occur, going forward.
- Dr. Ahmad reported that there were 12 graduates of the Stepping Stone Substance Use program.

AUXILIARY REPORT:

COMMITTEE REPORTS:

- **Incident Committee – Dr. Maureen Lebel**

During May, the monthly report showed 135 assaults, the highest monthly total this year. Three percent of assaults (4) resulted in moderate injuries, 39 percent (53) resulted in minor injuries and 58 percent (78) resulted in no injury. As per the DOH website report of State Psychiatric Hospital Incidents, three patient to patient assaults at TPH resulted in moderate injuries. The total application of restraints for May (36) was the lowest thus far in 2023 as was the total duration (56.32 hours) of restraint. During May, there were two incidents at the A+ level, down from 5 in April.

Dr. Ahmad will be presenting information from the May 23, 2023, Violence Prevention meeting. Some particulars include: the system wide trendline clearly shows that occurrences of violence are going down; peaks in incidences of acting out are frequently a function of “outliers” (a small number of patients caused the majority of assaults); within the last 24 months 44 percent of assaults resulted in no injury; the majority of incidents occur between 3pm and 8pm with peaks at 5pm, 8pm and 8am. Effective interventions include distracting the patient with activities, separating individuals at risk, providing rewards for kindness behaviors, placing patients at risk under close observation and long-acting medications.

The Legislature continues to consider the Governor's budget for FY24. Much of the controversy over the budget involves the issue of property tax relief for seniors.

Primary elections for all seats in both the Senate and the Assembly took place on June 6. Only a few elections were contested.

- **Schulley Trading Post – Mr. Weisfeld:**

Mr. Weisfeld inquired with concern about the deficit of nearly \$5,000 attributed to the Schulley Trading Post in May. Mr. Hollen explained that this was a result of overdue bills that had been paid by check since February; sent by internal mail for posting, they were found, undelivered. So, the checks were reissued; this was all money due to vendors supplying STP.

- Mr. Hollen and Dr. Christiansen commented on the very successful Annual Open House held on 5/12/23 by the New Leaf gardeners, as noted in the Rehab. Report. Sales to staff for the day totaled \$455.00.

- **Welfare Fund – Ms. Torre**

At the May meeting, the Board approved Mr. Hollen's suggested budget for 2024 of \$47, 250. Since that time, TPH has been awarded surplus funds for 2023 through DOH, which along with the remainder of 2022 surplus funds, totals nearly \$5.8 million. This makes possible the purchase of much- needed equipment including furniture, copiers, computers, android phones, carpet, a sprinkler system, passenger vans, food service equipment and the completion of much-needing projects like road paving and sewage system repair. This leaves the Welfare budget untouched, so the Board can consider patient-centered activities/materials to which that money might be directed.

**Report from Ms. Mary Jean Weston, MSW, Regional Coordinator
Office of Community Services, Division of Mental Health & Addiction Services (DMHAS)
(June 15, 2023)**

1. Mental Health Services at Shelters:

Governor Murphy signed a law that allows Mental Health services at emergency shelters. The law will make mental health services accessible to people who otherwise may not have the means to seek treatment on their own. “If the program is in a shelter, they will have to be no cost. And not only no cost, but no barriers to getting in,” according to Connie Mercer, CEO of the New Jersey Coalition to End Homelessness. “It’s hard to quantify how many unhoused people in New Jersey have mental health issues because many are afraid to self-report.” <https://whyy.org/cdn.ampproject.org/c/s/whyy.org/articles/new-jersey-homeless-shelters-provide-mental-health-services/amp/>

2. Opioid Settlement Funds:

The state of New Jersey will be receiving at least \$641 million of opioid settlement funds over the next 18 years. The state will receive half of the funding, and the other half will be provided to participating county and local governments. The Murphy Administration is interested in the opinion of NJ citizens about how the funds should be used. The New Jersey Opioid Recovery and Remediation Fund Advisory Council is holding listening sessions to hear from the public. 3. DMHAS Recent Funding Awards:

4. 988 Update:

- a. DMHAS 988 Staff recently made a presentation on 988 to the New Jersey Commission on American Indian Affairs. The Commission serves as a liaison among the three state-recognized NJ tribes (Nanticoke Lenni-Lenape Indians, Powhatan Renape Indians and the Ramapough Lenape Indian Nation), the Inter-Tribal People, and the State and Federal governments. Inter-Tribal People refers to American Indian people who reside in New Jersey but are members of federally and/or State-recognized tribes in other states. The Commission is empowered to develop programs and projects to further understanding of New Jersey's American Indian history and culture.

Inclusion of Tribal communities in all aspects of 988 services has been a requirement of the Substance Abuse and Mental Health Services Administration (SAMHSA – federal funder) and Vibrant Emotional Health (Vibrant – 988 Lifeline national administrator) from the beginning. With this in mind, DMHAS 988 staff are also meeting with leaders of the Commission to learn how the 988 system in NJ can best serve tribal community members in crisis.

5. RFPs from DMHAS;

- a. Request for Proposals for Independent Peer Review. DMHAS is seeking credentialed substance abuse professionals to provide Independent Peer Review (“IPR”) for quality and appropriateness of treatment services of substance use treatment facilities funded by DMHAS. Mr. Frank Miller is retiring. The Board and the Staff offered their thanks and congratulations and wished him well.

COMMENTS FROM THE PUBLIC – There were no comments from the public.

Timothy Loesch Raycroft Complex Administrator: presented a status report on Raycroft.

Mr. Loesch reported on challenges in the unit, including managing staff shortages, and dealing with contraband. He described the satisfaction of having succeeded in discharging patients with long patient stays, including one of over three years. He discussed the positive effects of an art therapist working with patients to create a mosaic that maintenance is framing and that will be hung. He has developed in-house sports tournaments for Level I patients who can’t leave the building. Over time, the assault level has been coming down in Raycroft.

Annual Report

Mr. Frank Miller presented the annual report and addressed all Board members' questions. The report is a public document and can be shared. A copy of the report is attached.

The meeting was adjourned at 10:45 a.m. The next meeting is scheduled for Thursday, September 21, 2023, at 9:30 a.m., in person at TPH.
