#### **ROLL CALL/CALL TO ORDER/MINUTES APPROVAL:**

Roll call was conducted in-person. The Board of Trustees meeting was called to order at 9:30 a.m. Minutes from the May 16, 2024, meeting were approved.

# **May Monthly Report:**

- Ms. Torre noted that admissions were up in the month of May.
- Ms. Torre observed that though the assault rate was significantly higher in May, the use of restraints was the lowest of any month since January.
- Ms. Torre congratulated New Leaf gardeners on the Mother's Day plant sale.
- Ms. Torre praised all the Wellness Events.
- Ms. Torre inquired about the Nutrition Department group session on "Nutrition Know to Go". The group is taught in the evening. Mr. Weisfeld had a similar interest and asked if the Nutrition Dept. could offer a presentation about it to the Board at a future meeting.
- Ms. Torre asked for a brief explanation of two A+ incidents that seemed to arise from a patient's delusions.
- Ms. Torre praised staff for results of JC unannounced May visit: They closed out the Ligature Risk Extension Request evaluation with no findings.
- Ms. Torre congratulated staff on the 0% delinquency rate (of physician completion of medical records) in HIM report.
- Mr. Weisfeld asked if there is a mechanism in place to determine if patients discharged from TPH are then accessing care at another facility? Response: No current method to track this information. Dr. Lebel suggests patients could be tracked using Medicare and Medicaid data using diagnostic codes.
- Mr. Weisfeld pointed out a discrepancy between the average daily census and the average monthly census figures; Mr. Holland says that the average monthly census table isn't accurate and needs to be corrected.
- Dr. Lebel also pointed to the increase in assaults for the month of May; she told the Board that 5 patients were responsible for 30% of the assaults.
- Dr. Lebel was very pleased with all the Wellness Committee events.
- Dr. Lebel noted that the evening\Weekend activities are down a little bit. Staff response: The complexes are doing their own activities, not all of which are included in this report.
- Dr. Lebel would like more information of SkillUp Training Program, including how long it takes to finish. Ms. Faith Johnson will get back to her with that information.
- Mr. Pyle raised the issue of the complexity of discharging some CEPP patients; this
  is often related to challenges related to their immigration status. 20.7% of TPH
  patients are on CEPP status which is very close to the hospital goal of no more than
  20%.
- Mr. Pyle asked about pressure on TPH to admit more patients: Mr. Holland described a backlog of patients from both the ER and the community.

- Mr. Pyle asked the number of patients with DDD status (Division of Developmental Disabilities): Answer: 8 patients.
- Mr. Pyle noted assaults were up the Raycroft West 2. Dr. A. said that this was related to an unstable patient in the unit and that with the transfer of two patients, the assault rate has fallen.
- Dr. Rosenberg asked about the discrepancy between assault numbers on p.3 and p.4 of the monthly report: this is due to the timing of issuing the totals for the report; the final assault number for May was 97 which is the highest it has been in 2024, to date.
- Dr. Rosenberg commended all the staff who participate in the wellness events.
- Dr. Rosenberg praised the vocational training programs; he would like to see more of them.
- Mr. Gallagher congratulated staff on resolution of previous Joint Commission findings on ligature risks in their recent visit.
- Mr. Gallagher commented positively on pastoral support services for staff who have experienced an assault or difficult encounter.
- Mr. Gallaher described New Leaf gardener's activities, hikes, and skills training as highly beneficial for patients; kudos to staff.

#### IV. NOTE ON LEGISLATION AND OTHER DEVELOPMENTS:

Primary elections for federal and county offices were held throughout the State on June 4. For the U.S. Senate seat held by Bob Menendez since 2006, Democrat voters nominated Representative Andy Kim, and Republican voters nominated Curtis Bashaw. Menendez is currently on trial in New York on 18 federal felony charges including conspiracy to act as a foreign agent of the Egyptian and Qatari governments, obstruction of justice, wire fraud, and bribery, and has declared his intention to run to retain the seat as an independent.

Herb Conaway, Jr., current and long-time chair of the Assembly Health Committee, won the Democratic nomination for the U.S. House seat currently held by Representative Kim. Representative Donald Payne, Jr., held the only other now-open seat in New Jersey's 12-member House delegation until his sudden death April 24. A special election to fill Mr. Payne's seat for the few months until the end of the term will be held September 18, following a primary election on July 16.

Governor Murphy signed a major revision of the Open Public Records Act into law on June 5. The controversial new legislation will make it more difficult for journalists and others to access public records.

The Governor and leaders of the Legislature will seek to negotiate a compromise budget for fiscal year 2025 before its July 1st start date.

# • Schulley Trading Post – Mr. Hollen reported for Dr. Rosenberg:

James Hollen reported that there was \$27,000.00 in revenue to date this year.
 On June 17 there will be a price increase for all items at the Trading Post consistent with the increased cost of expenditures. Overall, the Trading Post is doing well, as it continues to recover from the downturn in business associated with the pandemic.

# • Therapeutic Environment Committee – Mr. Pyle: Notable activities:

- Removal of diseased/dying trees planting of Two Cherry Blossoms/other trees for each removed.
- Additional tricycles have been purchased.
- Indoor murals are being drawn in Complexes.
- On 6/28, there is an Outdoor event for the Spring into Summer. The band will be: "Bell Bottom Blues" Band (Blues\Clapton)
- On 8/16, there will be a Board-supported trip to Cape May.

#### • Welfare Fund - Ms. Torre:

• At the request of the TPH Auditor for direct Board approval for items over \$1,000 (paid for by the Welfare Fund), the Board did so for expenditures between now and Oct. 25th. The Board also voted to approve an increase in the total annual budget to \$63,000.00.

# Report from Ms. Angela Wairimu, Program Analyst Office of Community Services, Division of Mental Health & Addiction Services (DMHAS) (June 20<sup>th</sup>, 2024)

#### RFPs

Permanent Community-based Housing for Individuals Currently Diagnosed with a Mental Illness who are in a Nursing Facility, State of County Psychiatric Hospital or are Homeless:

This RFP is issued by DHS/DMHAS for the provision of Community Support Services (CSS) and community housing (unsupervised) to adult consumers age 18 and over being discharged from a NJ long term care or nursing facility (NF) or, with prior written DMHAS approval, persons being discharged from a State or County Psychiatric Hospital or persons experiencing homelessness. Total annualized funding for each award is \$525,950 subject to federal and State appropriations. DMHAS anticipates making up to fifteen (15) awards. DMHAS seeks to award 5 residences in each of the 3 regions. Each of the 15 residences will accommodate 3 individuals resulting in a minimum of 45 community housing placements served through this RFP, with up to 45 CSS consumers served.

Regions: North (Sussex, Passaic, Bergen, Warren, Morris, Essex, Hudson); Central (Monmouth, Mercer, Middlesex, Hunterdon, Somerset, Union); South (Ocean, Burlington, Camden, Gloucester, Salem, Cumberland, Atlantic, Cape May).

# Designated Screening Services Atlantic, Bergen, Cape May, Middlesex, Morris, and Somerset Counties:

This RFP is issued by the NJ DHS/DMHAS for the continued provision of Designated Screening Services (i.e., Psychiatric Emergency Services) for Atlantic, Bergen, Cape May, Middlesex, Morris, and Somerset Counties. The psychiatric emergency services programs awarded through this RFP shall offer services to persons who may be approaching or are experiencing a psychiatric crisis. Prompt assessment, crisis intervention and referrals services will be offered 24 hours per day, 365 days per year. The program will also operate a 24-hour hotline, with calls being answered by trained clinical staff at all times.

Total annualized funding is \$10,672,570 subject to State appropriations. DMHAS anticipates making 1 award for each of these county-based service areas, resulting in 6 total awards. ### 988 Mobile Crisis Outreach Response Teams - Essex/Hudson Counties:

This RFP is issued by the DHS/DMHAS for Mobile Crisis Outreach Response Teams (MCORT) to respond to adults (18 and above) in non-life-threatening situations who have contacted the 988 Suicide and Crisis Lifeline. Total available annual funding, subject to State appropriations, is \$2,838,704. DMHAS will also fund one-time startup costs (for computers, phones, office furniture, vehicles, etc.). This funding will be used to support 11 MCORTs across Essex and Hudson counties in NJ. DMHAS will make 1 award. #### Residential Services for Individuals Discharged from Nursing Homes:

NJ DMHAS is issuing this Proposal (RFP) for A+ Level residential services per NJAC 10:37A. This initiative is for eligible individuals 18 years of age and older with medical needs. This funding will be provided to develop a Level A+ residential program for those with both a mental health diagnosis and medical needs, who have been discharged from a nursing facility and require assistance temporarily or permanently in order to live independently in the community. DMHAS anticipates making up to four (4) awards of \$420,000 each for five (5) beds each, to provide services to a statewide total of twenty (20) individuals in the following four (4) regions: Region 1 (NRO) Sussex, Passaic, Bergen, Warren, Morris, Essex, Hudson; Region 2 (NRO) Hunterdon, Somerset, Union; Region 3 (CRO) (Mercer, Middlesex, Monmouth, Ocean); Region 4 (Burlington, Camden, Gloucester, Salem, Cumberland, Atlantic, Cape May).

Additionally, up to \$100,000 in one-time capital funding may be available for physical modifications to a site that is either purchased, owned, or in a long-term lease by the bidder.

Crisis Diversion Homes

This is an RFP for the development of four (4) Crisis Diversion Homes (CDH). Crisis Diversion Homes will serve individuals who have recently experienced a crisis and will prioritize referrals from Crisis Receiving Stabilization Centers (CRSC) and Mobile Crisis Outreach Response Teams (MCORT). The goal is to provide stabilization, to divert hospital admissions and reduce emergency department (ED) visits. Available Funding: Total average annualized DMHAS funding for each award through a cost-reimbursement contract is \$692,429. The total projected contract ceiling per home is not to exceed \$1,211,750 over the entire initiative, beginning February 15, 2004, through September 30, 2025. There will be four (4) awards. One in each of the following counties: 1. Morris 2. Mercer or Monmouth 3. Warren or Hunterdon 4. Gloucester

- The Board shared Mr. Tim Gallagher's announcement that he is resigning from the Board of Trustees. The Board thanked Mr. Gallagher for his service.

#### **COMMENTS FROM THE PUBLIC:**

- Mr. Frangipane, father of a patient recently transferred to Ann Klein, raised concerns about three issues:
  - Timely treatment: Father says son sustained a fractured wrist after assault by another patient; received immediate care for his injury but evaluation by orthopedic surgeon was delayed. Staff attributes that to transportation complications. Staff emphasized they could not discuss detailed information re. patient's condition/treatment, publicly, because of HIPPA rules.
  - 2. Contraband in the Raycroft Complex: The Raycroft complex now has metal Detectors and bag scanners in place. Staff who either don't comply with using the metal detectors and bag scanners or are found to be bringing in contraband, are subject to disciplinary action.
  - Air conditioning: Son complained about excessive heat in the unit. TPH
    has portable chillers outside the Raycroft Complex. Repairs are being
    made to the present air conditioning system.

Administration response to questions about adequacy of staff preparedness for assaults:

- Units are managed by Nursing Supervisors and Assistant Director of Nursing (ADON), Program Coordinators and Complex Administrators.
- Annual education is required for all staff Re: de-escalation and patient management and safety.
- The Violence Prevention Committee works diligently to assess assaults and to implement strategies to reduce their occurrence.
