Interested persons may also request in writing that the Department hold a non-adversarial public hearing on the amendment or extend the public comment period specified in this notice. Such requests should reference Program Interest No. 435437, Activity No. AMD180001 and must demonstrate sufficient public interest for the public hearing or extension of the comment period, as defined under N.J.A.C. 7:1D-5.2(d). The request must be submitted within 30 days of the date of this notice to the Department address cited above. Should the Department decide to hold a public hearing, additional notice will be published in a future issue of the New Jersey Register and the comment period will be extended to 15 days after the public hearing date. All comments submitted prior to the close of the comment period shall be considered by the Department before making a final decision on the proposed amendment.

Sewer service is not guaranteed by adoption of this amendment since it represents only one part of the permit process and other issues may need to be addressed. Inclusion in the sewer service area as a result of the approval of this amendment does not eliminate the need to obtain all necessary permits, approvals, or certifications required by any Federal, State, county, or municipal review agency with jurisdiction over this project/activity.

Take notice that on August 23, 2018, the Department of Health (Department) received a petition for rulemaking from the above petitioner requesting that the Department make certain amendments to the Manual of Standards for Licensing Ambulatory Care Facilities at N.J.A.C. 8:43A-30.7, Radiation oncology services quality improvement methods, and to the Hospital Licensing Standards at N.J.A.C. 8:43G-28.19, Radiation therapy continuous quality improvement methods.

A notice acknowledging receipt of the petition was published in the October 15, 2018, New Jersey Register at 50 N.J.R. 2177(a). In accordance with applicable law, the Department reviewed the petition and has determined that additional time is needed to deliberate about this petition. Time is needed to further evaluate the standards for certification of the American Society for Radiation Oncology and compare them with the standards of the American College of Radiology and the American College of Radiation Oncology. The Department has asked the American Society for Radiation Oncology for additional information and has sought input from stakeholders.

Accordingly, pursuant to N.J.A.C. 1:30-4.2(a)3, this matter will be referred for further deliberation for a period not to exceed 90 days. A copy of this public notice is being mailed to the petitioner.

NEW JERSEY STATE COUNCIL ON THE ARTS
Notice of Applications Available for General Operating Support, General Program Support, and Arts Project Grants for Fiscal Year 2020 (July 1, 2019 to June 30, 2020)

Take notice that the New Jersey State Council on the Arts, acting under the authority of P.L. 1966, c. 214, hereby announces the availability of the following grant program:

Name of program: Fiscal Year 2020 Organizational Grants Program, including grants in the following categories:

General Operating Support (multi-year support)

General Program Support (multi-year support)

Arts Project Support (one-year support)

Purpose: To stimulate and encourage the production and presentation of the arts in New Jersey and to foster public interest in and support of the arts in New Jersey through the award of matching grants to eligible organizations. Matching grants under this program are exclusively to support arts organizations, programs, and projects for fiscal year 2020 (July 1, 2019 to June 30, 2020).

Eligible applicants: Must be a New Jersey incorporated, nonprofit organization that is tax exempt under section 501(c)3 or 4 by determination of the Internal Revenue Service and registered with the Charities Registration Bureau or be a unit of local government in New Jersey; must have been in existence and active for at least two years prior to making application; must have a board of trustees empowered to formulate policies and be responsible for the administration of the organization, its programs, projects, and finances; must be able to demonstrate multi-county or Statewide impact; must have organizational goals related to the arts and a clear arts purpose to the proposed programs or project; and must comply with all pertinent State and Federal laws, rules, and regulations.

Ineligible applicants: Organizations that are unincorporated, incorporated in another state, or incorporated as profit-making entities; organizations, agencies, institutions, or projects that do not have organizational goals related to the arts or a specific arts project to propose; and organizations that are local in public impact.

Grant size: Grants will range in size, but will not exceed 25 percent of organizational budget for General Operating Support and General Program Support grants or 50 percent of project expenses for Arts Project grants.

Amount of available funding for the program: Will depend on the finalization of the Council's legislative appropriation for fiscal year 2020.

Match: All grants offered under this program require a cash match. The required match is 3:1 for General Operating Support and General Program Support grants, and 1:1 for Arts Project grants. In-kind contributions are not allowed as any part of the match. Indirect costs may not be included.

Deadline for submission: Complete applications for General Operating Support, General Program Support, and Arts Project grants must be e-filed no later than February 13, 2019.

Notice of Intent to Apply: Notice of Intent to Apply must be e-filed by December 4, 2018. The Notice of Intent to Apply briefly describes the prospective applicant organization and the purpose for which funds will be sought. A separate Notice of Intent to Apply must be submitted for each grant sought. Applications not preceded by a Notice of Intent to Apply (if required) will be disqualified.

Decisions: All complete applications from eligible applicants will be evaluated according to the published criteria for evaluation by independent peer panels of experts appropriate to the category or arts
