Notice of Certificate of Need Call for New Specialized Long-Term Care Beds for Pediatric Care

Take notice that, in compliance with N.J.S.A. 26:2H-1 et seq., Christopher R. Rinn, Acting Commissioner, New Jersey Department of Health (Department), is inviting certificate of need applications on an expedited review basis to establish new specialized long-term care beds for pediatric care in accordance with the provisions of N.J.A.C. 8:33H-1.5 and N.J.S.A. 26:2H-1 et seq. The Department is inviting applications on an expedited review basis because the award of 17 beds throughout the State will have a minimum impact on the health care system as a whole. The call for new specialized long-term care beds for pediatric care, originally scheduled for January 3, 2017, was postponed because the Department was in the process of gathering and evaluating data to determine whether there was a need for new specialized long-term care beds for pediatric care. The next scheduled call for new specialized long-term care beds for pediatric care is scheduled for January 2, 2018.

The Department collected data for calendar years 2014, 2015, and 2016 from general acute care hospitals and long-term acute care hospitals through a survey that requested data regarding any placement delays that resulted in extended stays after patients were clinically cleared, due to the unavailability of specialized long-term care beds for pediatric care. In addition, the Department surveyed providers of specialized long-term care beds for pediatric care asking for facility utilization and capacity data for

calendar years 2014, 2015, and 2016. Based on its analysis of the data it received, the Department has determined that there is a limited need for additional new specialized long-term care beds for pediatric care in the following regions:

Region	Identified Additional Beds Needed
<u>Region 1 - South Jersey</u> (Atlantic, Burlington, Cape May, Camden, Cumberland, Gloucester, Ocean, and Salem counties)	3 beds
<u>Region 2 - North Jersey</u> (Bergen, Essex, Hudson, Hunterdon, Mercer, Middlesex, Monmouth, Morris, Passaic, Somerset, Sussex, Union, and Warren counties)	14 beds

In accordance with N.J.A.C. 8:33-1.2(d), certificate of need applications shall be reviewed for conformity with the rules in effect on the date the certificate of need application is deemed complete for processing.

Geographic areas to be served: Atlantic, Bergen, Burlington, Camden, Cape May, Cumberland, Essex, Gloucester, Hudson, Hunterdon, Mercer, Middlesex, Monmouth, Morris, Ocean, Passaic, Salem, Somerset, Sussex, Warren, and Union counties.

Date applications are due: April 1, 2018.

Date completeness review decision is anticipated to be issued: July 1, 2018.
