

Dear Dr. Elnahal:

This office represents Appellant GGB New Jersey, LLC ("GGB") in the above styled matter, which is currently pending before the Appellate Division.

On February 4, 2019, counsel for Harvest of New Jersey ("Harvest") wrote to you, pursuant to Rule 2:9-7, requesting that the New Jersey Department of Health ("DOH") issue a stay of its December 17, 2018 Final Agency Decision ("Decision") awarding six licenses for the operation of medicinal marijuana alternative treatment centers pending the outcome of these appeals. GGB now joins in Harvest's stay request for the reasons set forth in Harvest's February 4 letter. In the event the DOH fails to respond by Thursday, February 7, 2019, GGB will construe the DOH's inaction as a *de facto* denial and reserves the right to move for an emergent stay from the Appellate Division.
