The Department of Health, Division of Medicinal Marijuana (DMM), acting under the authority of the Jake Honig Compassionate Use Medical Cannabis Act, N.J.S.A. 24:6I-1, et seq. (Act) and the DMM Rules, N.J.A.C. 8:64-1, et seq. (Rules), hereby issues Curaleaf NJ, Inc., 640 Creek Road, Bellmawr, NJ 08031, a Permit to Operate an Alternative Treatment Center (ATC) for the purpose of cultivating, processing and manufacturing medicinal marijuana at 111 Coolidge Avenue, Bellmawr, NJ 08031, in compliance with the Act, Rules and the conditions listed below.
