H. <u>Major Research and Public Service Activities</u>

In Fall, 2010, WCCC conducted the Noel Levitz student satisfaction survey of the student body to gauge opinions across a variety of topics related to the institution. The results will be compared to the previous results collected from the 2007 administration of the same survey.

I. Major Capital Projects Underway in FY 2010

During FY10, WCCC began working on acquiring a new facility in Phillipsburg, New Jersey. This 52,000 ft² building will house the College's continuing education, customized training and partnership programs when the College completes the acquisition in summer, 2011. In July 2010, the county issued Chapter 12 bonds to support the acquisition of this renovated facility.

During summer 2010, the College also completed a number of interior renovation projects, including phase I of the Library renovation project. Phase 2 of this project, which includes the addition of a second story mezzanine, will be completed in summer, 2011. Various exterior improvements also were completed in summer, 2010.
