Preface

Hudson County Community College

Hudson County Community College is a comprehensive, two-year college located in the Journal Square section of Jersey City, with a satellite location in the northern part of the county. HCCC serves one of the most urban and diverse counties in the nation.

The mission of the College is to provide high quality educational opportunities that promote student success and are accessible, comprehensive, and learning centered. All programs and services are designed to meet the educational needs of a linguistically and ethnically/racially diverse community, and to promote the economic, technological, cultural, social, and civic development of Hudson County and its service areas.

The College is committed to equal educational opportunities for traditional and non-traditional students who can benefit from its programs and services without regard to race, ethnic or national origin, religion, age, gender, disability, economic status, or educational background.

Hudson County Community College has expanded the scope of its offerings by adding to the curriculum practical and pragmatic courses of study that meet the educational needs of our county. Improved services have resulted in a steadily increasing retention rate, which has risen over the last 10 years from well below the sector average to match or surpass New Jersey colleges serving similar populations. The graduation rate has also improved considerably. New assessment systems have been developed to monitor students' academic progress and college-wide institutional performance.

A. Accreditation Status

Institutional Accreditation

Hudson County Community College is accredited by the Commission on Higher Education of the Middle States Association of Colleges and Schools, 3624 Market Street, Philadelphia, PA 19104, (215) 662-5606. The Commission on Higher Education is an institutional accrediting agency recognized by the U.S. Secretary of Education and the Commission on Recognition of Postsecondary Accreditation. The five-year Periodic Review Report was submitted by the College June 1, 2014. The monitoring report submitted in September 2009 was accepted and accreditation was last reaffirmed on November 19, 2009. The next monitoring report is due 2018-2019.

Professional Accreditation

The Occupational Therapy Assistant (OTA) Program is a collaborative program between Hudson County Community College and Rutgers, The State University of New Jersey, and is accredited by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA).

The Respiratory Care (RTP) program is offered in conjunction with the Rutgers School of Health Related Professions, is accredited by the Committee on Accreditation for Respiratory Care (CoARC).

The Culinary Arts Institute's Associate Degree program is accredited by The American Culinary Federation Educational Institute (ACFEI) Accrediting Commission.

The Cooperative Nursing (NSG) Program offered in conjunction CarePoint is accredited by the Accreditation Commission for Education in Nursing (ACEN). CarePoint is a National League of Nursing Center for Excellence.

The Paramedic Science (EMT) program is offered in conjunction with the Jersey City Medical Center and is accredited by the Commission of Accreditation of Allied Health Education Programs (CAAHEP).

The AS Radiography is a partnership program between CarePoint Health and HCCC. The CarePoint Health Radiography program is accredited by the Joint Review Committee on Education in Radiologic Technology (JRCERT) and approved by the New Jersey Radiologic Technology Board of Examiners.
