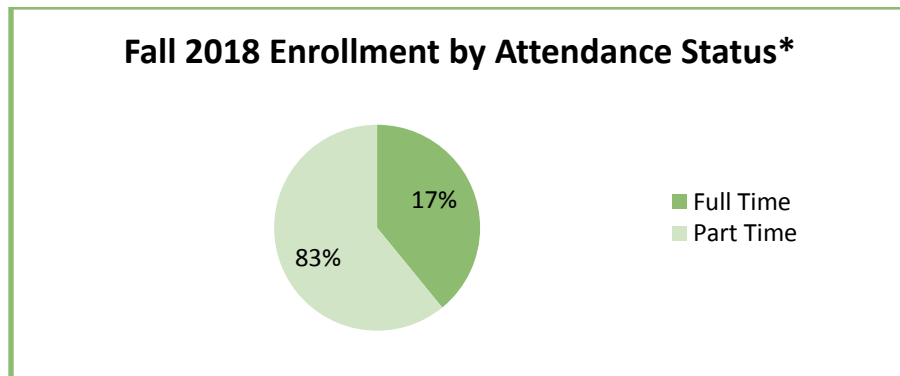

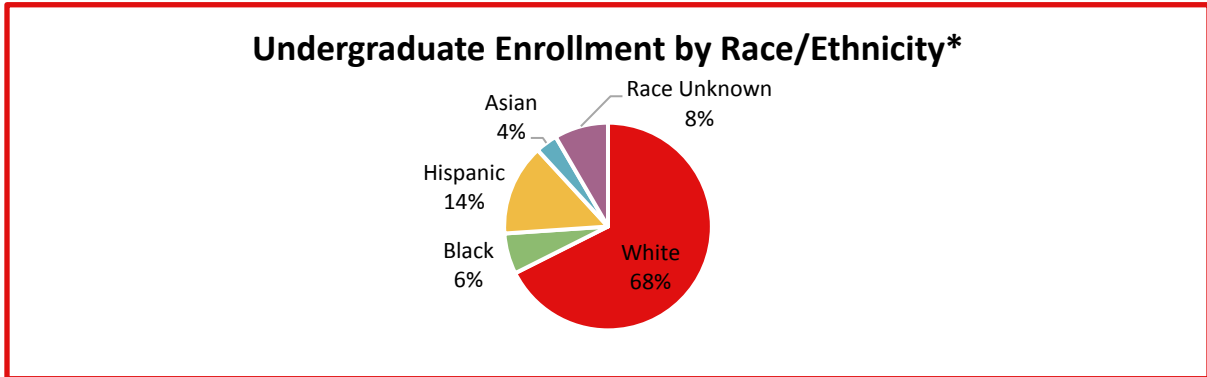

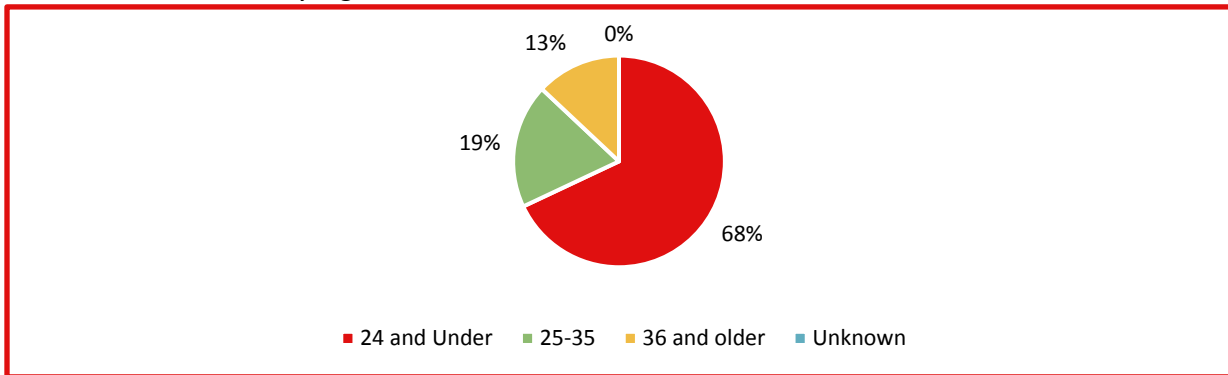

Enrollment by Race/Ethnicity:



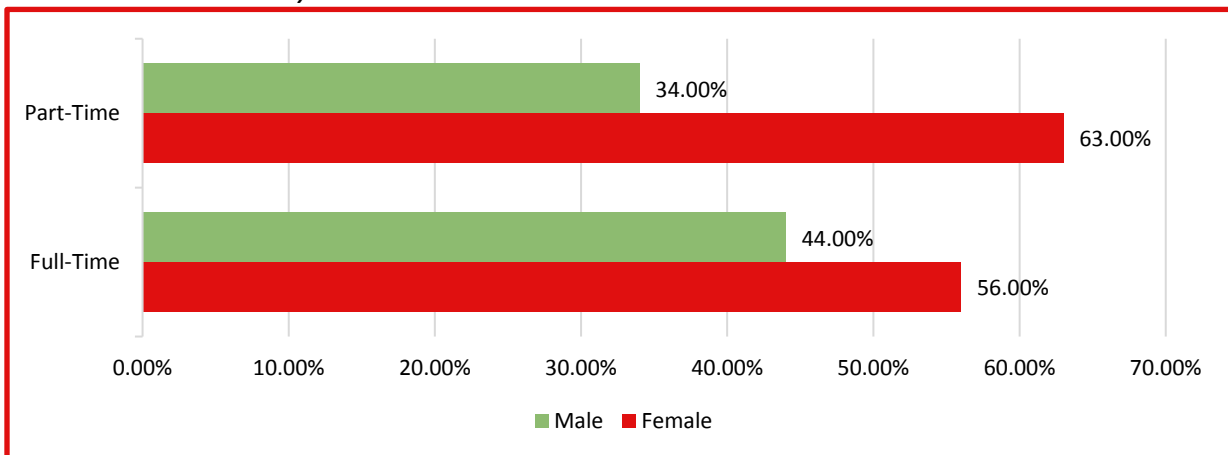

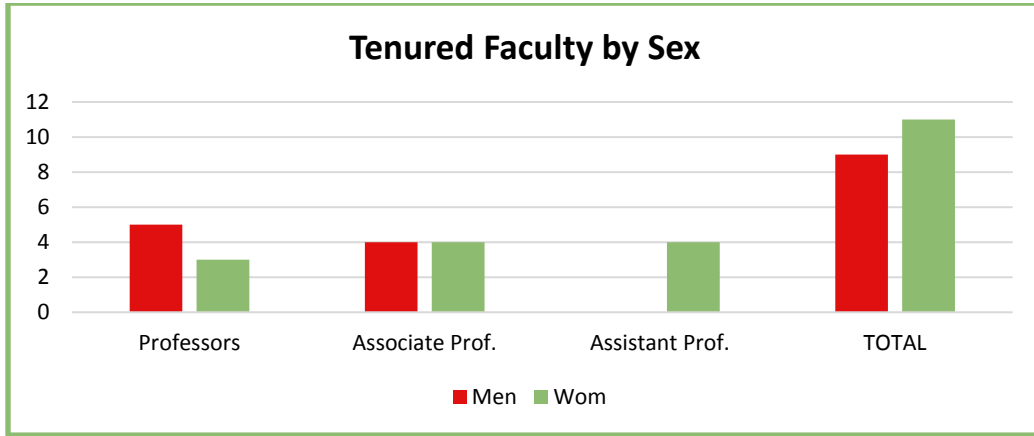

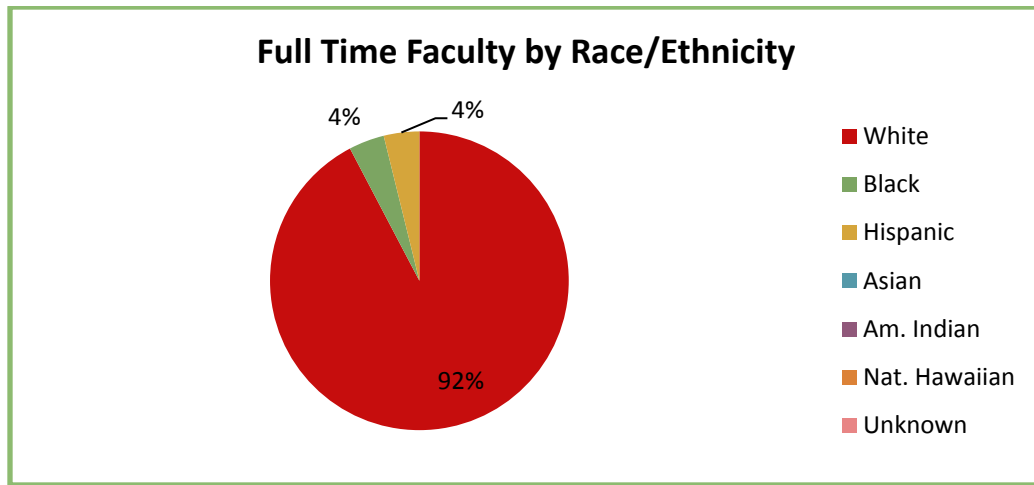

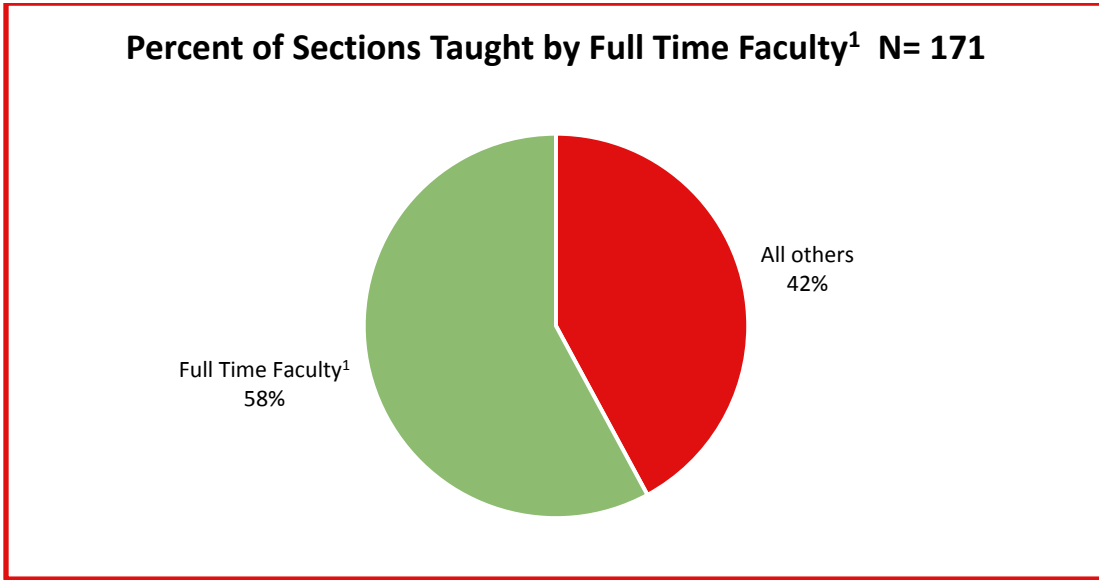

Other Information:

In Spring 2019, WCCC opened the Building Annex, which houses a lecture hall, a large computer learning lab, offices and an open lounge atrium area. The final phase of this project will be completed shortly with upgraded walkways and upgraded walkways to parking and the College’s drone port. The project expanded handicapped accessible restrooms on the campus, and included a special prep area for those needing a Hoyer lift and a separate room for breastfeeding mothers.

During 2018-19, WCCC became the first public college east of the Mississippi to convert all of its student learning materials to an on-line subscription through Cengage Unlimited. Students pay just \$135 to obtain a one-year digital subscription to all of their textbooks. This program became operational in Spring 2019 and thus far has saved full-time students approximately \$800-1,000 a semester. The College was able to pair this new initiative with the Governor’s CCOG pilot program and provide students with Cengage subscriptions, e-Readers and even meal vouchers and gift cards for food insecure students. WCCC had a strong success rate with the CCOG program as measured in student academic progress. CCOG even provided the financial assistance to help several students graduate last spring.

The UAS (Drone) program also had a drone port constructed for the Fall 2018 semester that provided an outside learning laboratory for this new program. Students from this program have already participated in real life experiences by providing technical mapping services for commercial and agricultural businesses in the county and participating in a county-wide active shooter drill at the largest regional high school.

H. Major Research and Public Service Activities

WCCC's mission does not include research activities, however, the College does engage in a number of public service initiatives. Its employees serve on a number of non-profit organizations and WCCC has strong partnerships with a number of regional non-profit agencies. For example, it offers free tenancy to the American Red Cross in its Small Business Incubator.

I. Major Capital Projects Underway in FY 2019

The GO Bond Project begun last year is finally in the closing stage, with new facilities available for students starting Summer 2019. The College's next phase of capital activities will focus on the renewal of infrastructure.

During 2018-19, the College undertook a major boiler project on the Phillipsburg site. During FY20, the College will undertake a roof replacement project for one wing of that facility.

With the initial campus complex in Washington nearing 20 years old, there is a need to focus on renewing the HVAC infrastructure and replacing the roof in the original segment of the main building. The HVAC replacement is scheduled to occur over spring, 2020. That summer, the College plans to upgrade its initial bathrooms in the central portion of the facility.
