

Enrollment By Attendance Status, Fall 2021



Non-Credit Clock Hours, FY 2021



Enrollment for academic year 2021 totaled 1,724 students and 24,225 credit hours for a full-time equivalency of 808 students.



In fall 2021, 6.4% of students enrolled in one or more remedial courses. Of the new first-time, full-time students, 15.5% enrolled in at least one remediation course in their first semester. 41% of the students in remedial courses were first-time, full-time students.

Undergraduate Enrollment by Race/Ethnicity by Attendance Status, Fall 2021



b. By gender

Five-eighths of the student body is female (62.3%). A higher proportion of male students (58.2% of total male student population) was enrolled full-time compared to female students (52.7% of total female student population).

Total Enrollment by Attendance Status and Gender, Fall 2021



c. By age

Over three-fifths (61.9%) of SCC's student body is traditional college age (under 25 years of age). The proportion of traditional age students is higher among full-time students (74.1%) versus part-time students (47.0%). The average age of the SCC student is 24. Female students are, on average, older than male students (25 versus 22 years of age); part-time students are, on average, older than full-time students (26 versus 23 years of age).

Enrollment by Age and Attendance Status, Fall 2021



3. Numbers of students receiving financial assistance

Financial aid awards totaled \$3.7 million in academic year 2020-21, consisting of 78.0% federal aid programs, 12.9% state aid programs, and 9.2% Foundation and institutional aid programs. Fifty-two percent of first-time, full-time students received federal, state, or institutional financial aid for an average aid award (not including loans) of \$5,358. Forty-seven percent of first-time, full-time students received federal, state, or institutional financial aid for an average award (not including loans) of \$6,175.



First-Time, Undergraduates By State Residence, Fall 2021



D. Student Outcomes

1. Graduation rates

Graduation rates of first-time, full-time degree seeking students reflect the percentage of students that graduate, by completing a degree or certificate, within a specified time frame of first enrolling at SCC. Of the 168 students in the fall 2018 cohort, 38.7% graduated in two years. An additional 10.1% graduated the third year, for a total three-year graduation rate of 48.8%.

Fall-to-Fall Retention Rates of First-Time Students by Attendance Status, 2016-2021



Degrees and Certificates Conferred by Race/Ethnicity, AY 2021



Completions by Award Type, AY 2021



Degrees and Certificates Conferred by Gender, AY 2021





Assistant Professor **Jenna Lucente in** conjunction with SCC Dean of Glass Kristin Deady, and glass artist Alexander Rosenberg, co-curated the Fall season at the Delaware Contemporary.

Furthermore, Lucente has another large public art commission underway with New Jersey Transit at the Elizabeth Station. The commission is for glass designs, which will encompass four different elevator towers at the station. Two of the towers were installed in 2022. The remaining two will be installed in 2023.

Professor Lucente also instructs monthly figure drawing sessions at the Delaware Contemporary in Wilmington, DE.

Jennifer Martin was recognized as the "Volunteer of the Year" for 2021-2022 at the Annual Tutor Appreciation Event.

Abigail Chomo was recognized as a Phi Theta Kappa All-State Academic Team Representative at the April 2022 Awards Ceremony.

4. Collaborations with area schools

Salem Community College received the Office of the Secretary of Higher Education NJ GEAR UP/College Bound grant, which enabled the college to collaborate with the Penns Grove-Carneys Point Regional School District. The grant enables the college to provide services for up to 175 students in grades 7-12. Student participants have access to a full tutoring program during the academic year, along with a Summer Enrichment Program for students; college tours; cultural events; instruction for study skills, reading, and math; mentoring; and parent workshops.

As a recipient of the College Readiness Now VII Grant (CRN VII), Salem Community College partnered with Penns Grove-Carneys Point Regional School District and Salem County Vocational Technical School District to provide Accelerated Learning Programs to local students. Students enrolled in ENG101, as well as a companion support course during the spring 2022 semester. Students who successfully completed the course were able to earn college level credits while still in high school.



Salem Community College is one of three recipients, and the only community college recipient, in the state of New Jersey for the Opportunity Meets Innovation Challenge (OMIC) grant. This opportunity provides fee-free college credits for up to 24 total credits to 40 high school students across the county who fall below a designated income threshold. The College's approach for OMIC is built around wrap-around services, including academic advising, academic support/tutoring and career counseling. This two-year grant is designed to serve as a pilot to provide evidence and support for extended funding to extend fee-free college credits to a larger population of high school students.

In April 2022, Salem Community College hosted the Salem County School Counselor's Association (SCSCA) for a breakfast meeting. 15-20 School Counselors from districts around the county were in attendance. During the event, SCC staff presented sessions on topics such as high school programs/dual enrollment, EOF and financial aid.

5. Public service activities

a. Community service and outreach events

SCC hosted the annual veterans medals ceremony in partnership with the County of Salem Office of Veterans Affairs, and a veterans recognition dinner with the SCC Foundation.

Due to the pandemic, Salem Community College's 20th International Flameworking Conference (IFC) was three years in the making. Not surprisingly then, a record number of SCC glass alumni attended. The conference (March 18-20) celebrated SCC's more than 60 years of Scientific Glass Technology and 20 years of Glass Art.

The on-campus Samuel and Jean Jones Glass Education Center, hosting its first IFC, received rave reviews from the more than 300 attendees from 29 states and Canada.

Assistant Dean of Glass Education and IFC Chair Kristin Deady scheduled an all-alumni cast of presenters: featured artist Sally Prasch, Kiva Ford, Doni Hatz, Dan Coyle, Paul Stankard, Patty Clune, Tracy Drier, Erich Moraine, Jeremy Grant-Levine, Bob Russell, Carl Natalino, Katie Severance and Rich Brainard.

The IFC was founded by SCC Distinguished Alumnus and internationally respected artist Paul Stankard of Mantua, N.J. Stankard is now IFC chair emeritus. The IFC is made possible through a grant from the Salem County Cultural and Heritage Commission and New Jersey State Council on the Arts, as well as the SCC Foundation and glass industry sponsors.

At Homecoming in September 2021, SCC and the SCC Foundation saluted two local frontline healthcare heroes who have helped save lives and made sacrifices for the community during the pandemic. When introduced to the crowd of 250 guests in the DuPont Field House on the SCC campus, registered nurses Suzy Strang from the Salem Medical Center (SMC) and Sheetal Stewart from Inspira Health received a standing ovation. An SCC graduate, Strang has worked at SMC for 20 years, the last five in the Intensive Care Unit. Stewart has worked for Inspira Health since September 2012.

SCC participated in the Wind Port Town Hall and the Salem County schools' unification feasibility study public hearings.

Additionally, SCC continues to contribute in the ongoing English as a Second Language class with Gateway Community Action.

The college also partnered with Salem County Vocational-Technical School District for GED class.

Salem Community College continues to take part in Salem County Economic Development Council's monthly meetings.

With federal, state and county COVID restrictions relaxed, SCC co-sponsored and hosted several events for K-12 populations:

The College continues to serve as the permanent home of the award-winning Team 316 (The LUNATECS) of South Jersey Robotics; affiliated with FIRST Robotics. The LUNATECS qualified for and competed in the FIRST international robotics championship in Houston in April 2022.



Dr. Mike Gorman serves on the Salem County Chamber's Government Relations Committee and the Chamber's Marketing Committee. Those are in addition to serving as Secretary on the Chamber Board of Directors and serving on the Business Education Committee.

President Dr. Michael R. Gorman is also a member of the Forman Acton Foundation, the Penns Grove/Carneys Point Regional School District Advisory Board, the Rotary of Penns Grove, the Salem Community College Foundation (ex-officio), the Salem County Chamber of Commerce (Chamber Board Secretary and member of Business Education Committee), the Salem County Vocational-Technical Educational Foundation, the Salem County Economic Development Council, the Salem Medical Center, and Stand Up for Salem.

Furthermore, Dr. Gorman served as the facilitator for the Salem County schools' unification feasibility study.

Bill Clark chaired the Salem County Chamber of Commerce's Business Education Committee and served as vice chair of Deepwater Industries Federal Credit Union Board of Directors.

Maria Fantini was a member of the Rotary of Penns Grove.

Ceil Smith facilitated the Salem Circle of Friends (with Salem Medical Center), was a member of both the Salem City Council and the Salem Yuletide Committee.

Moreover, Smith was a board member at the Salem Medical Center and was the commissioner at the Delaware River and Bay Authority.

Associate Professor **Karen Mattison** serves on the New Jersey Collegiate Business Administration Association (NJCBAA) leadership cabinet as Vice President. I. Major capital projects underway in fiscal year 2022

While recovering from the effects of the COVID-19 pandemic, there were minimal Capital Projects during FY 2022. In FY 2022, Salem Community College replaced the primary HVAC system in Davidow Hall, which houses the Sol & Jean Davidow Performing Arts Theatre and the DuPont Field House. Costing \$1.1 million, this project was funded via NJ Chapter 12 Bond Program. Anticipated projects in FY 2023 include campus bathroom modernization and replacing our athletic floor in the DuPont Field House. Bathroom renovations are estimated at \$50 thousand while field house flooring is approximately \$175 thousand. Other potential capital projects include updates to the theatre lighting and sound systems with estimated costs approximating \$75 thousand.



1. By fall credit hour totals





Fall Student Enrollment Status


