





Demographic Trends: Adults

Declines in Pennsylvanians aged 25-64




- Adult population projected to decline 5.3% from 2020-2040.
- BUT over 1 million Pennsylvanians have some college but no degree.



Attainment Varies by Region

Pennsylvania Associate's and Bachelors' degree attainment rate by county



Only 11 Pennsylvanian counties have a higher attainment rate than the national average of 46%

Four-Year Graduation Rate (all 4-year Sectors, 2013 cohort): 51.8%


Two-Year Graduation Rate, Community Colleges (2017 cohort): 11%

2023 Statewide Workforce Credential Gap



Statewide, Pennsylvania postsecondary institutions' annual credential supply fell short of employer's demands, resulting in a workforce credential gap of 61K in 2023

2023 Annual Postsecondary Credential Workforce Gap by Postsecondary Credential Type in Pennsylvania



Workforce Credential Gap

• Workforce Credential Gap represents the difference between demand for workers with postsecondary-level skills and the supply of credentials from PA postsecondary institutions adjusted for reenrollment and out-migration assumptions².

2032 Projected Skilled Worker Gap¹ #. 000s




Withing eight years, PA will experience a workforce credential gap of 218K if nothing is done.

Filling the projected worker gap requires increasing attainment by 4.4% over current attainment projections.







New Jersey's colleges face challenges in engaging adult learners








Challenges include increased competition from online and out-of-state programs

ReUp and OSHE's partnership has boosted re-enrollment, advanced degree attainment, and enhanced the state's economic vitality.



ReUp's first-ever state partnership, launched in 2023 and continues through August 2026



Established a statewide marketplace model of 22 institutions designed to increase degree attainment and advance statewide workforce goals



Created a national model for how states can re-enroll learners at scale



Performance metrics in New Jersey

Since all 22 institutions launched, ReUp has conducted outreach, engaged with learners on their pathways back to school, and drove meaningful re-enrollment outcomes.



288,000+ outreached



28,000+ engaged



13,500+ enrolled

Insights into SCND learners across New Jersey

ReUp analyzes engagement patterns, barriers to re-enrollment, and demographic trends of adult learners, uncovering pathways that bring adult learners back, advancing equity, and strengthening the state economy.

68% want to return within 1 year

Of learners who have engaged with ReUp, 45% want to return as soon as possible, and 23% want to return in 6 to 12 months.

64% are in good academic standing

64% of stopout learners left college with a GPA above 2.0.

When students graduate from high-demand pathways offered through New Jersey's SCND marketplace, the benefits extend well beyond individual achievement to strengthen the state's overall economy.




Re-engaging learners through Project Re-Enroll

Inspired by ReUp's work, Essex County College launched Project Re-Enroll, a pilot initiative designed to welcome back students who had previously been academically dismissed.

As a result of the personalized invitations sent over the summer (2025), 103 learners have already re-enrolled, demonstrating the impact of thoughtful, student-centered communication in reopening pathways to education and opportunity.

"Project Re-Enroll reflects what Essex County College stands for — access, opportunity, and second chances. Every student deserves the chance to finish what they started, and I'm proud that our team's efforts have helped so many learners return and thrive"





Ramapo College of New Jersey



Strengthening adult learner success through proactive retention initiatives

Ramapo College of New Jersey appointed an Advising Team Lead to direct the institution's first Persistence Initiative, a strategic effort designed to strengthen returning student retention and success.

As a direct outcome of these efforts, Ramapo College recorded a 60% percent increase in retaining returning learners from Summer 2025 to Fall 2025, underscoring the effectiveness of data-driven student success strategies and the institution's commitment to supporting diverse learner populations.

Barriers identified through data and stakeholder input

Prominent grant-funded strategies that addressed institutional and student barriers

Considerations for strengthening and scaling re-engagement efforts

Using the Report and Brief to Inform Future Work

- Use findings to assess and identify gaps in current practices
- Utilize data on holds and balances, and promising practices to build leadership support for adult learner re-engagement
- Modify promising policies and processes for administrative hold and balance resolution, and enrollment supports to fit institutional contexts


