

2024 Spring Insights

The New Jersey Office of the Secretary of Higher Education (OSHE), in collaboration with ReUp Education, continues their work to close the opportunity gap for the state's 790,000 students with some college credits, but no degree (SCND). Focused solely on stopped-out learners, ReUp seamlessly integrates with 22 NJ institutions of higher education, empowering learners to navigate their academic journey successfully and graduate with confidence. ReUp leverages both automated marketing and high-touch coaching interactions to dynamically support learners at scale in achieving their goals, ultimately increasing state-wide degree achievement and boosting local economies.

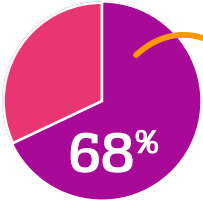

Black and Latino/a learners are **more likely to engage** in ReUp Success Coaching than students of other racial/ethnic groups.

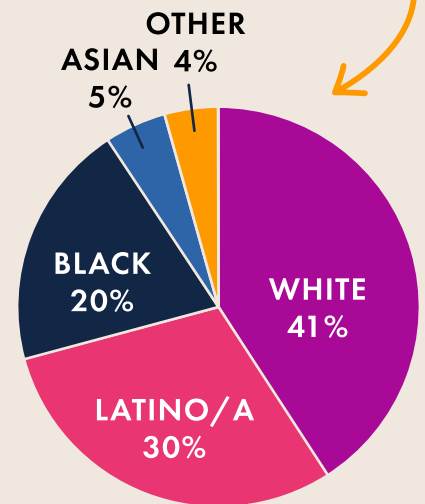


Across all racial and ethnic groups, Black and Latino/a learners have **higher re-enrollment rates than any other groups.**

Nationally, Black and Latino/a students stop out at nearly 1.5x the rate of white students.³

These insights indicate that underrepresented students benefit significantly from additional support as they return to school.
