Communication Access Real-Time Translation (CART) List**

Dear Consumer:

The New Jersey Division of the Deaf and Hard of Hearing (DDHH) is the principal state agency established by New Jersey Law (PL 1977, C. 166) on behalf of people of all ages who are deaf, hard of hearing, and deaf blind. The division provides education, advocacy, and direct services to eliminate barriers and promote increased accessibility to programs, services, and information routinely available to the state's general population.

As part of the Division's mandate to promote increased accessibility, DDHH manages a CART captioning referral list. CART stands for "Communication Access Realtime Translation", a word-for-word speech-to-text service that displays complete translation of all spoken words and environmental sounds. CART is a reasonable accommodation under the Americans with Disabilities Act (ADA) for persons with hearing loss.

Attached is the DDHH referral list containing contact information for CART captioners in New Jersey. DDHH disseminates this list as a service to the community and resource for entities to locate and hire CART captioners.

DDHH is unable to make any claim as to the skills of any CART captioner. Each CART captioner functions as an independent business entity, it is strongly encouraged to become familiar with the CART captioner's business policies (i.e. fees, payment, cancellation of services, etc.).
