The New Jersey Division of the Deaf and Hard of Hearing (DDHH) is the principal state agency established by New Jersey Law (PL 1977, C. 166) on behalf of people of all ages who are deaf, hard of hearing, and deafblind. The division provides education, advocacy, and direct services to eliminate barriers and promote increased accessibility to programs, services, and information routinely available to the state's general population.

As part of the division's mandate to promote increased accessibility, DDHH currently maintains statewide directories of certified interpreters in specialties including but not limited to healthcare and legal. DDHH is now expanding these resources to include a comprehensive list of K-12 educational interpreters who hold the NJ Standard Certification.

DDHH manages and updates the attached sign language interpreter referral list containing contact information for K-12 educational interpreters. Sign language interpreting is a reasonable accommodation under the Americans with Disabilities Act for persons who are deaf, hard of hearing, or deaf-blind. DDHH disseminates this list as a service to state programs, providers, and the community to locate and hire sign language interpreters.
