DDHH and these agencies have a long history of working together to improve the quality of life of people with hearing loss. DDHH looks forward to continuing this positive collaboration.

DDHH Staff Member Catie Purrazzella Given Special Recognition

At the NJAD/NJRID joint conference, staff member Catie Purrazella was given an award by NJAD in special recognition for her involvement with the Deaf Advocacy Project. The Project is cosponsored by the DDHH and provides treatment and support to victims of domestic violence who are deaf and hard of hearing. The certificate was inscribed with the following:

"With NJAD collaboration on the Deaf Advocacy Project regarding Domestic Violence and Sexual Assault, Catherine went above and beyond to ensure access for Deaf victims and survivors. Deaf Consumer is Awarded \$35,000

DDHH staff often advocate for people who are deaf and hard of hearing to receive access to goods and services as stated in several laws that protect consumers from discrimination. After attempts were made by DDHH staff Catie Purrazzella to convince a health facility to provide an interpreter, it was referred to the NJ Division on Civil Rights who successfully followed through and secured a settlement which hopefully will prevent a recurrence. NJ DDHH and NJ Division on Civil Rights to Host Community Forums in 2016 by Jason Weiland, DDHH Field Representative

Since 2003, the NJ Division of the Deaf and Hard of Hearing and NJ Division on Civil Rights (DCR) have collaborated over the years to address issues related to the needs of the deaf and hard of hearing community. As a result of this partnership, the agencies were able to settle with five major movie theatre companies in NJ to boost the number of screens with captioning from three to sixty. With a former Attorney General's support, the partners worked with the New Jersey Hospital Association and more than 90 hospitals to develop the Communication Access Guide for Working with the Deaf and Hard of Hearing. This has greatly impacted the way access to hospital services and doctor's offices have been provided in the state.

During November, DDHH met with NJ DCR Assistant Director Philip Freeman and Legal Specialist Edward Haas to revisit the needs of the deaf and hard of hearing community. Video Remote Interpreting, Motor Vehicle Commission, and access to other service providers were just a few of the items discussed that day. We decided to host community forums in New Jersey similar to those in the past. Currently, DDHH is looking into possible dates and locations. Interviews Conducted for Vacancy

DDHH staff conducted interviews for the "Deaf and Hard of Hearing Specialist" civil service positions that are currently vacant. Candidates are being considered for final approval.

Advisory Council Meeting Held

The Right to Special Education in New Jersey by Catie Purrazzella, Service Coordinator

Many parents reach out to the Division of the Deaf and Hard of Hearing and request advocacy resources regarding access to an appropriate education for their deaf and hard of hearing children including Individual Education Programs (IEPs). Sometimes parents believe that school districts are not providing appropriate access to their education. They want to know how to advocate on behalf of their children.
