FINAL DECISION

Petitioner appealed from the Respondent Agency's denial of Work First New Jersey/General Assistance ("WFNJ/GA") and Emergency Assistance ("EA") benefits. Because Petitioner appealed, the matter was transmitted to the Office of Administrative Law for a hearing. A plenary hearing was scheduled for April 3, 2019, before the Honorable Andrew M. Baron, Administrative Law Judge ("ALJ"). On September 27, 2019, the ALJ issued an Initial Decision dismissing Petitioner's appeal.

No Exceptions to the Initial Decision were received.

As the Director of the Division of Family Development, Department of Human Services, I have reviewed the ALJ's Initial Decision and the record, and I hereby ADOPT the ALJ's Initial Decision and AFFIRM the Agency's determination.

The record in this matter reflects that, on April 3, 2019, Petitioner and the Agency's representative appeared for the scheduled hearing, but before the case was heard, Petitioner walked out of the waiting area and did not return. See Initial Decision at 2. As a result, the ALJ found that Petitioner had abandoned the hearing, and dismissed her case. Ibid.

Based on the foregoing, I find that Petitioner abandoned her fair hearing in this matter and, therefore, the Agency's denial of WFNJ/GA and EA benefits to Petitioner stands, and is thereby affirmed. Moreover, I take official notice of the fact that Petitioner was denied WFNJ/GA and EA benefits by notice dated March 19, 2019, and as such, Petitioner is now out of time to request another fair hearing on these issues. Therefore, Petitioner's fair hearing is hereby dismissed with prejudice, and Petitioner is advised that she is foreclosed from requesting another fair hearing on this specific denial. See N.J.A.C. 10:90-9.10(b).

Accordingly, the Initial Decision is hereby ADOPTED and the Agency's action is hereby AFFIRMED.
