DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS JUNE 2024

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of June, the TANF caseload had increased by 583 cases, from 11,102 in June 2023 to 11,685 in June 2024; an increase of 5.3%.
- The counties with caseloads that increased the most since June 2023 were Union (21.9%), Morris (16%), and Cumberland (15.3%).
- The counties with caseloads that decreased the most since June 2023 were Warren (-24.4%), Bergen (-17.3%), and Sussex (-13.3%).
- Of the WFNJ/TANF cases, 2,444 or 20.9% were child-only in June 2024.
- The counties with the most child-only cases were Camden (408), Hudson (356), and Essex (252).
- Hudson (5,297), Essex (4,698), and Camden (4,156) counties had the greatest number of persons receiving TANF in June 2024.

NJ SNAP (Formerly FOOD STAMPS)

- In June 2024, there were 447,612 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 36,753 or 8.9%, since June 2023.
- There were 844,611 persons receiving NJ SNAP benefits as of June 2024; an increase of 52,523 or 6.6% since June 2023.
- The counties having the highest SNAP caseload increase since June 2023 were Union (26.9%), Morris (11.8%), and Somerset (11.1%).
- The counties having the highest SNAP caseload decrease since June 2023 was Atlantic (-1.1%).

EMERGENCY ASSISTANCE

- There were 1,636 TANF families receiving Emergency Assistance (EA) in June 2024; an increase of 161 or 10.9% since June 2023.
- In June 2024, EA payments were made for 605 SSI recipients.

DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS JUNE 2024

- There were 2,197 GA cases with Emergency Assistance payments in June 2024; an increase of 409 or 22.9% since June 2023.
- The counties that showed the highest percent increase in Emergency Assistance payments were Passaic (300%), Sussex (150%), and Burlington (135.2%).
- The counties that showed the highest percent decrease in Emergency Assistance payments were Gloucester (-73.3%), Union (-36.4%), and Salem (-33.3%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has increased from 10,411 to 15,461 since June 2023; an increase of 48.5%.
- There were 11,360 Employable GA and 4,101 Unemployable GA cases in June 2024.
- The counties that showed a percent increase for GA cases were Passaic (132.1%), Hudson (99.1%), and Salem (99.1%) since June 2023.
- The counties that showed the highest percent decrease for GA cases since June 2023 was Hunterdon (-7.8%).
- In June 2024, GA cases showed a 0.83% increase since May 2024.

CHILD SUPPORT SERVICES (QUARTERLY REPORT)

- The total collection for the Child Support Services Program was about \$276 million from April 2024 to June 2024; an increase of 1.35% over the same period from FFY 2023.
- Total distributions increased 0.2% from June 2023.

WORK FIRST NEW JERSEY (WFNJ)

- During the report month of June 2024, there were 575 families in which at least one member was employed and an additional 189 families whose WFNJ assistance cases were closed due to employment related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (142), Hudson (106), and Camden (43).
- There were 267 former TANF cases receiving post-TANF support in the form of child care assistance.






Work Participation Rates Achieved Over 12 Month Period Ending with JUNE 2024



Number WFNJ Families Receiving EA by County JUNE 2024





ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as NJ SNAP (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
