Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of January, the TANF caseload had decreased by 973 cases, from 11,662 in January 2019 to 10,689 in January 2020, a decrease of 8.3%.
- •The counties with caseloads that increased the most since January 2019 were Burlington (4.1%), Cape May (5.9%) and Hunterdon (20.0%).
- •The counties with caseloads that decreased the most since January 2019 were Warren (-13.0%), Hudson (-13.1%) and Passaic (-14.3%).
- Of the WFNJ/TANF cases, 3,646 or 34.1% were child-only in January 2020.
- The counties with the most child-only cases were Camden (605), Essex (417) and Passaic (371).
- Essex (4,544), Camden (3,621), Hudson (3,201), Passaic (2,914) and Atlantic (1,845) counties had the greatest number of persons receiving TANF in January 2020.

NJ SNAP (formerly FOOD STAMPS)

- In January 2020, there were 336,067 households receiving NJ SNAP benefits. The number of NJ SNAP households decreased by 22,505 or 6.3%, since January 2019.
- There were 659,929 persons receiving NJ SNAP benefits as of January 2020, a decrease of 52,549 or 7.4% since January 2019.
- The counties having the highest caseload decrease since January 2019 are Somerset (-8.3%), Atlantic (-8.6%) and Burlington (-8.8%).

EMERGENCY ASSISTANCE

- There were 1,767 TANF families receiving Emergency Assistance (EA) in January 2020, an increase of 240 or 15.7% since January 2019.
- In January 2020, EA payments were made for 605 SSI recipients.

- There were 2,126 GA cases with Emergency Assistance payments in January 2020, an increase of 222 or 11.7% since January 2019.
 - The counties that showed the highest percent increase in Emergency Assistance payments were Essex (106.9%), Cumberland (180.0%) and Monmouth (191.7%).
 - The counties that showed the highest percent decrease in Emergency Assistance payments were Bergen (-16.4%), Atlantic (-16.9%) and Morris (-17.4%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has decreased from 10,669 to 10,028 since January 2019, a decrease of 6.0%.
- There were 4,109 Employable GA and 5,919 Unemployable GA cases in January 2020.
- The counties that showed a percent increase for GA cases were Somerset (19.2%), Sussex (31.3%) and Hunterdon (35.8%) since January 2019.
- The counties that showed the highest percent decrease for GA cases since January 2019 were Hudson (-14.9%), Morris (-16.6%) and Bergen (-22.5%).
- In January 2020, GA cases showed a 1.0% increase since December 2019.

CHILD SUPPORT SERVICES (Quarterly Report)

- The total collection for the Child Support Services Program was about \$304 million from October 2019 to December 2019, a decrease of 1.2 percent over the same period for FFY 2019.
- Total distributions decreased 1.6% from December 2018.

WORK FIRST NEW JERSEY (WFNJ)


- During the report month of January 2020, there were 1,071 families in which at least one member was employed and an additional 148 families whose WFNJ assistance cases were closed due to employment related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (239), Camden (154) and Hudson (126).
- There were 924 former TANF cases receiving post-TANF support in the form of child care assistance.








Work Participation Rates Achieved Over 12 Month Period Ending with JANUARY 2020





Number WFNJ Families Receiving EA by County JANUARY 2020




ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.

EXPLANATORY NOTES

The Department of Human Services Division of Family Development provides basic income and an opportunity to achieve self-sufficiency for individuals and families served by the Division's programs. The Division provides leadership, direction and supervision to those public agencies responsible for administering those programs and plans for and develops policies to promote self-sufficiency.
