## AGENCY DKT. NO. C066778003 (BURLINGTON COUNTY BD. OF SOC. SVCS)

Petitioner Agency charges Respondent with committing an intentional program violation ("IPV") of the Supplemental Nutrition Assistance Program ("SNAP"). The Agency asserts that Respondent intentionally failed to report receipt of household earned and unearned income, while she received SNAP benefits, thus causing Respondent to receive an overissuance of benefits to which she was not entitled. Respondent was properly noticed of the Administrative Disgualification Hearing, the charges against her, and the proposed disqualification penalty, via certified mail, return receipt requested, on September 29, 2022. See Exhibits P-16, P-17. Because Respondent failed to execute and return the waiver of her right to a hearing, the matter was transmitted to the Office of Administrative Law ("OAL") for a hearing as a contested case. See Exhibit P-15. On November 30, 2022, the Honorable Susan L. Olgiati, Administrative Law Judge ("ALJ"), held a telephonic plenary hearing, took testimony, and admitted documents. Respondent did not appear for the hearing, and the matter proceeded ex parte, which is permissible pursuant to our regulatory scheme. See N.J.A.C. 1:10-14.1(d). On December 1, 2022, Respondent left a voicemail message with OAL, advising that she had attempted to call into the hearing but was cut off. As a result, the matter was rescheduled for hearing on December 12, 2022. Respondent confirmed her availability for the rescheduled hearing, but again failed to appear. Respondent was given ten days to present good cause for her failure to appear at the December 12, 2022, hearing. Respondent did not respond, and the record then closed on December 22, 2022.

On December 30, 2022, the ALJ issued an Initial Decision, which found that the Agency had met its burden in establishing, by clear and convincing evidence, that Respondent had deliberately and intentionally withheld information from the Agency, which resulted in Respondent receiving an overissuance of SNAP benefits, to which she was not entitled. See Initial Decision at 5. Specifically, the ALJ found that Respondent intentionally did not report the receipt of earned income, and unearned income in the form of partial Unemployment Insurance Benefits ("UIB"), which resulted in an overissuance of SNAP benefits to Respondent in the total amount of \$2,134.29, for the period of March, 2016, through October, 2016. Id. at 2, 3, 5; see also Exhibits P-1, P-2, P-3, P-4, P-5. P-9, P-10, P-11, P-20, and N.J.A.C. 10:87-5.4(a)(1), (2), -5.5, -9.5.



As this was the first IPV committed by Respondent, the ALJ ordered the mandatory regulatory penalty of a 12-month disqualification from receipt of SNAP benefits, pursuant to N.J.A.C. 10:87-11.2(a)(1). See Initial Decision at 5.

No Exceptions to the Initial Decision were filed.

As Assistant Commissioner, Division of Family Development, Department of Human Services, I have considered the Initial Decision in this matter, and following an independent evaluation of the record, I concur with the ALJ's decision, and hereby adopt the Findings of Fact and Conclusion of Law in this matter.

I direct that the Agency proceed to recoup the overissuance.

Accordingly, based upon the foregoing, I hereby ADOPT the Initial Decision in this matter, and ORDER that Respondent is disqualified from receipt of SNAP benefits for a period of 12 months. I further ORDER that the Agency is to recoup the overissuance.
