FINAL DECISION

OAL DKT. NO. HPW 03465-23 L.S.

AGENCY DKT. NO. C132096015 (OCEAN COUNTY BOARD OF SOC. SVCS.)

Petitioner Agency charges Respondents, B.S. and L.S., separately, with committing an intentional program violation ("IPV") of the Supplemental Nutrition Assistance Program ("SNAP"). The Agency asserts that Respondents intentionally failed to accurately report household earned income, while they received SNAP benefits, thus causing Respondents to receive an overissuance of benefits to which they were not entitled. Respondents were properly noticed of the Administrative Disgualification Hearing, the charges against them, and the proposed disqualification penalties, via certified mail, return receipt requested, on March 22, 2023. See Exhibit P-1. Because Respondents failed to execute and return the waiver of their right to a hearing, their separate matters were transmitted to the Office of Administrative Law ("OAL") for a hearing as contested cases. On May 12, 2023, at the commencement of the hearing, the Honorable Dean J. Buono, Administrative Law Judge ("ALJ"), consolidated Respondents' separate matters, docketed under OAL Docket Nos. HPW 03464-23 (B.S.) and HPW 03465-23 (L.S.). On the date of the hearing, a settlement agreement was negotiated between B.S. and the Agency. The hearing was then conducted, and the ALJ held took testimony, and admitted documents. Respondent L.S. did not appear for the hearing, while B.S. did. Respondent L.S. was given ten days following the hearing, to present good cause for her failure to appear. Respondent L.S. did not respond. At the conclusion of the hearing, the record remained open for receipt of an executed repayment agreement. On June 1, 2023, the Agency submitted a copy of the settlement, requested a decision to enforce the penalty period, and the record then closed.

On June 22, 2023, the ALJ issued an Initial Decision, which found that the Agency had met its burden in establishing, by clear and convincing evidence, that Respondents, B.S. and L.S., had deliberately and intentionally withheld information from the Agency, which resulted in Respondents receiving an overissuance of SNAP benefits, to which they were not entitled. See Initial Decision at 5. Specifically, the ALJ found that Respondents intentionally did not report B.S.'s earned income, which resulted in an overissuance of SNAP benefits to Respondents in the amount of \$4,125, for the period of February, 2019, through August, 2020. Id. at 3, 4, 6; see also Exhibits P-2, P-3, P-4, P-5, and N.J.A.C. 10:87-5.4(a) (1), (2), -9.5.



As this was the first IPV committed by Respondents, the ALJ ordered the mandatory regulatory penalty of a 12-month disqualification from receipt of SNAP benefits, pursuant to N.J.A.C. 10:87-11.2(a)(1). See Initial Decision at 6.

No Exceptions to the Initial Decision were filed.

As Assistant Commissioner, Division of Family Development, Department of Human Services, I have considered the Initial Decision in this matter, and following an independent evaluation of the record, I concur with the ALJ's decision, and hereby adopt the Findings of Fact and Conclusion of Law in this matter.

I direct that the Agency proceed to recoup the overissuance.

Accordingly, based upon the foregoing, I hereby ADOPT the Initial Decision in this matter, and ORDER that Respondents, B.S. and L.S., are disqualified from receipt of SNAP benefits for a period of 12 months. I further ORDER that the Agency is to recoup the overissuance in accordance with the executed repayment agreement.
