**FINAL DECISION** 

OAL DKT. NO. HPW 19069-15 I.F.

AGENCY DKT. NO. C148728 (MONMOUTH COUNTY DIV. OF SOC. SVCS)

Petitioner challenges the correctness of Respondent Agency's calculation of her Supplemental Nutrition Assistance Program ("SNAP"), f/k/a the Food Stamp Program, benefits on recertification. Because Petitioner appealed, the matter was transmitted to the Office of Administrative Law for a hearing. On January 4, 2016, the Honorable Joseph A. Ascione, Administrative Law Judge ("ALJ"), held a plenary hearing, took testimony and admitted documents into evidence.

On January 15, 2016, the ALJ issued his Initial Decision which affirmed the Agency's calculation of Petitioner's benefits. The issue in this case involves the date of submission of Petitioner's Interim Reporting Form ("IRF"). The Agency states that Petitioner's IRF was received by the Agency on October 6, 2015, and therefore, Petitioner's SNAP benefits were prorated at \$161.00 instead of \$194.00 to reflect the exclusion of benefits from October 1 through October 5. See Initial Decision at 2; see also N.J.A.C. 10:87-6.3(b). Petitioner argues she previously submitted the IRF on two prior occasions; however, there is no written documentation of the mailing or receipt of the documents from the Agency. See Initial Decision at 2. The ALJ found that Petitioner failed to provide evidence she submitted her IRF prior to October 6, 2015, and concluded the Agency appropriately prorated Petitioner's benefits. See Initial Decision at 4. I agree.

No Exceptions to the Initial Decision were filed.
