FINAL DECISION

Petitioner appeals from Respondent Agency's termination of her Emergency Assistance ("EA") in the form of Temporary Rental Assistance ("TRA") because Petitioner has exhausted her lifetime limit of EA, plus all available extensions. Because Petitioner appealed, the matter was transmitted to the Office of Administrative Law for a hearing. On November 10, 2015, the Honorable Mumtaz Bari-Brown, Administrative Law Judge ("ALJ"), held a plenary hearing, took testimony, and admitted documents. On December 21, 2015, the ALJ issued an Initial Decision affirming the Agency determination.

In the Initial Decision, the ALJ found that Petitioner is a Work First New Jersey/Temporary Assistance for Needy Families ("WFNJ/TANF") recipient who has received 27 months of EA to date. See Initial Decision at 2; see also Agency's Check History Printout dated November 10, 2015. The Agency terminated Petitioner's EA/TRA in November 2015, and denied her request for a three-month extreme hardship extension of EA, because Petitioner has exhausted her lifetime limit of EA, plus all available extensions. See Initial Decision at 2. The ALJ concluded that the Agency's termination of Petitioner's EA/TRA, as well as its denial of her request for an extreme hardship extension, were proper and should be affirmed. See Initial Decision at 4.

No Exceptions to the Initial Decision were filed.
