## AGENCY DKT. NO. C127289003 (BURLINGTON COUNTY BD. OF SOC. SVCS)

Petitioner Agency charges Respondents, A.F. and S.G., with committing an intentional program violation ("IPV") of the Supplemental Nutrition Assistance Program ("SNAP"). The Agency asserts that S.G. intentionally failed to report receipt of household earned income, while she and Respondent A.F., her adult child living in the same household, received SNAP benefits, causing them to receive an overissuance of benefits to which they were not entitled. Respondents were noticed of the Administrative Disgualification Hearing ("ADH") scheduled for October 3, 2022, the charges against them, and the proposed disgualification penalties, via certified mail, return receipt requested, on August 3, 2022. See Exhibit P-14. Because Respondents failed to execute and return the waiver of their right to a hearing, the matters were transmitted to the Office of Administrative Law ("OAL") for a hearing. See Exhibit P-13. Both matters, docketed under OAL Docket Nos. HPW 07682-22 (A.F.) and HPW 07683-22 (S.G.), respectively, were consolidated for purposes of hearing. See Initial Decision at 2; see also N.J.A.C. 1:1-17.3. Respondents did not appear on October 3, 2022. Thereafter, S.G. contacted the OAL to advise that she had relocated to South Carolina, and that she was unable to telephonically appear on October 3, 2022, due to hurricanes and storms occurring there at that time. Accordingly, the matters were rescheduled, and the parties telephonically appeared on October 24, 2022. On that date, the Honorable Susan L. Olgiati, Administrative Law Judge ("ALJ"), held a telephonic plenary hearing, took testimony, admitted documents, and the record then closed.

On November 14, 2022, the ALJ issued an Initial Decision, which found that the Agency had met its burden in establishing, by clear and convincing evidence, that S.G. had deliberately and intentionally withheld information from the Agency, which resulted in Respondents receiving an overissuance of SNAP benefits, to which they were not entitled. See Initial Decision at 7. Specifically, the ALJ found that S.G., while receiving SNAP benefits, intentionally did not report the receipt of household earned income, which resulted in an overissuance of SNAP benefits to Respondents in the amount of \$2,667.85, for the period beginning December, 2020, through April, 2021. Id. at 2, 3, 4; see also Exhibits P-1, P-4, P-5, P-6, P-7, P-8, and N.J.A.C. 10:87-5.4(a)(1), (2), -9.5.



The ALJ also found that A.F., as an adult member living in the household at the time when the overpayment of SNAP benefits occurred, is also responsible for repayment of the SNAP benefits overpayment totaling \$2,667.85. See Initial Decision at 6, 7; see also Exhibit P-14 at 65-66, and N.J.A.C. 10:87-11.2(k), -11.20(d)(1).

As this was the first IPV committed by S.G., the ALJ ordered the mandatory regulatory penalty of a 12-month disqualification from receipt of SNAP benefits, pursuant to N.J.A.C. 10:87-11.2(a)(1). See Initial Decision at 7.

No Exceptions to the Initial Decision were filed.

As Assistant Commissioner, Division of Family Development, Department of Human Services, I have considered the Initial Decision in this matter, and following an independent evaluation of the record, I concur with the ALJ's decision, and hereby adopt the Findings of Fact and Conclusion of Law in this matter.

I direct that the Agency proceed to recoup the overissuance.

Accordingly, based upon the foregoing, I hereby ADOPT the Initial Decision in this matter, and ORDER that Respondent S.G. is disqualified from receipt of SNAP benefits for a period of 12 months. I further ORDER that the Agency is to recoup the overissuance.
