**DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS
NOVEMBER 2017**

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of November, the TANF caseload had decreased by 3,938 cases, from 19,622 in November 2016 to 15,684 in November 2017, a decrease of 20.1%.
- The counties with caseloads that decreased the most since November 2016 were Union (-32.3%), Bergen (-36.8%) and Cape May (-37.7%) .
- Of the WFNJ/TANF cases, 4,885 or 31.1% were child-only in November 2017.
- The counties with the most child-only cases were Essex (747), Camden (740) and Hudson (503).
- Essex (7,185), Camden (5,355), Passaic (5,013), Hudson (4,555) and Atlantic (2,851) counties had the greatest number of persons receiving TANF in November 2017.

NJ SNAP (formerly FOOD STAMPS)

- In November 2017, there were 385,219 households receiving NJ SNAP benefits. The number of NJ SNAP households decreased by 35,511 or 8.0%, since November 2016.
- There were 767,864 persons receiving NJ SNAP benefits as of November 2017, a decrease of 67,373 or 8.1% since November 2016.
- The county that showed a percent increase for NJ SNAP benefits as of November 2017, was Warren (0.8%).
- The counties having the highest caseload decrease since November 2016 are Essex (-10.1%), Union (-11.5%) and Ocean (-11.8%).

EMERGENCY ASSISTANCE

- There were 1,790 families receiving Emergency Assistance (EA) in November 2017, a decrease of 779 or 30.3% since November 2016.
- In November 2017, EA payments were made for 429 SSI recipients.

GENERAL ASSISTANCE

GA Emergency Assistance

- There were 1,991 Emergency Assistance payments made to GA cases in November 2017, a decrease of 706 or 26.2% since November 2016.
- The counties that showed the highest percent increase in emergency assistance payments were Warren (10.3%), Hudson (13.1%) and Sussex (20.0%).
- The counties that showed the highest percent decrease in emergency assistance payments were Monmouth (-39.1%), Ocean (-57.7%) and Cumberland (-92.3%).

GA Program

- The total numbers of cases receiving GA has decreased from 16,177 to 13,028 since November 2016, a decrease of 19.5%.
- There were 5,382 Employable GA and 7,646 Unemployable GA cases in November 2017.
- The counties that showed the highest percent decrease for GA cases since November 2016 were Union (-30.5%), Ocean (-32.8%) and Salem (-33.7%).
- In November 2017, GA cases showed a 2.3 percent decrease since October 2017.

CHILD SUPPORT SERVICES (Quarterly Report)


- The total collection for the Child Support Services Program was about \$303 million from July 2017 to September 2017, a decrease of 5.3 percent over the same period for FFY 2017.
- Total distributions decreased 8.2% from September 2016.

WORK FIRST NEW JERSEY (WFNJ)

- During the report month of November 2017, there were 1,635 families in which at least one member was employed and an additional 308 families whose WFNJ assistance cases were closed due to employment - related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (364), Camden (255) and Hudson (170).
- There were 2,093 former TANF cases receiving post-TANF support in the form of child care assistance.





Ending With NOVEMBER 2017




NOVEMBER 2015 THROUGH NOVEMBER 2017 (STATEWIDE)**







ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is in an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKIDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
