

DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS DECEMBER 2022

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of December, the TANF caseload had increased by 1490 cases, from 9,655 in December 2021 to 11,145 in December 2022; an increase of 15.4%.
- The counties with caseloads that increased the most since December 2021 were Sussex (61.1%), Bergen (59.6%), and Union (34.7%).
- The counties with caseloads that decreased the most since December 2021 were Cape May (-5%) and Warren (-3.8%).
- Of the WFNJ/TANF cases, 2,578 or 23.1% were child-only in December 2022.
- The counties with the most child-only cases were Camden (457), Hudson (296), and Passaic (263).
- Hudson (4,516), Camden (4,108), and Essex (3,904) counties had the greatest number of persons receiving TANF in December 2022.

NJ SNAP (Formerly FOOD STAMPS)

- In December 2022, there were 404,136 households receiving NJ SNAP benefits. The number of NJ SNAP households decreased by 64,241 or -13.7%, since December 2021.
- There were 784,830 persons receiving NJ SNAP benefits as of December 2022; a decrease of 118,043 or -13.1% since December 2021.
- The counties having the highest SNAP caseload increase since December 2021 was Hunterdon (4.5%).
- The counties having the highest SNAP caseload decrease since December 2021 were Hudson (-24.4%), Union (-24.1%), and Passaic (-23.7%).

EMERGENCY ASSISTANCE

- There were 1,197 TANF families receiving Emergency Assistance (EA) in December 2022; a decrease of 81 or -6.3% since December 2021.
- In December 2022, EA payments were made for 568 SSI recipients.

DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS DECEMBER 2022

- There were 1,756 GA cases with Emergency Assistance payments in December 2022; a decrease of 57 or -3.1% since December 2021.
- The counties that showed the highest percent increase in Emergency Assistance payments were Cumberland (100%), Gloucester (100%), and Cape May (66.7%).
- The counties that showed the highest percent decrease in Emergency Assistance payments were Sussex (-84.6%), Salem (-60%), and Ocean (-42.9%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has decreased from 13,895 to 10,363 since December 2021; a decrease of -25.4%.
- There were 6,950 Employable GA and 3,413 Unemployable GA cases in December 2022.
- The counties that showed a percent increase for GA cases were Cape May (24.6%), Gloucester (13.8%), and Somerset (13.3%) since December 2021.
- The counties that showed the highest percent decrease for GA cases since December 2021 were Hudson (-54%), Passaic (-46%), and Burlington (-38.8%).
- In December 2022, GA cases showed a -2.59% decrease since November 2022.

CHILD SUPPORT SERVICES (QUARTERLY REPORT)

- The total collection for the Child Support Services Program was about \$257 million from October 2022 to December 2022; a decrease of -4.95% over the same period from FFY 2022.
- Total distributions decreased -5.4% from December 2021.


WORK FIRST NEW JERSEY (WFNJ)

- During the report month of December 2022, there were 532 families in which at least one member was employed and an additional 155 families whose WFNJ assistance cases were closed due to employment - related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Hudson (116), Essex (74), and Camden (60).
- There were 200 former TANF cases receiving post-TANF support in the form of child care assistance.








Work Participation Rates Achieved Over 12 Month Period







DECEMBER 2022









ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is in an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as NJ SNAP (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
