IMPORTANT NOTICE: ACTION NEEDED

Dear NJ FamilyCare member,

This is another notice that your NJ FamilyCare/Medicaid benefits will be terminated effective September 30, 2026, due to new federal requirements. The reason for the termination is the information you submitted could not be read or was not enough to prove that you have a qualifying immigration status to receive NJ FamilyCare/Medicaid benefits beginning October 1, 2026. The federal non-citizen eligibility rules can be found at 42 CFR 435.406 and Section 71109 of the One Big Beautiful Bill Act.

You may still submit the needed proof.

An Immigration Status Reporting Form is included with this letter. On the back of that form, there is a list of immigration statuses that can qualify for NJ FamilyCare beginning October 1, 2026. Read the list carefully.

If you think you have a qualifying immigration status, complete the Immigration Status Reporting Form and return it with copies of your documents as soon as possible. If you do, we can see if you still qualify for NJ FamilyCare.

Immigration statuses that can qualify for NJ FamilyCare/Medicaid on October 1, 2026:

1. **U.S. citizen** (regular, naturalized, or derived) or **U.S. national** with a U.S. Passport, naturalization certificate, etc.
2. **Pregnant and lawfully present in the U.S.** with a Permanent Resident card, visa, Employment Authorization Document (work permit), I-94 Arrival/Departure Record, etc.
3. **Under age 21 and lawfully present in the U.S.** with a Permanent Resident card, visa, Employment Authorization Document (work permit), I-94 Arrival/Departure Record, etc.
4. **Lawful Permanent Resident** or any other qualifying status of at least 5 years.
5. **Adjusted to Lawful Permanent Resident** from one of the following groups:
 - a. Refugees
 - b. Asylees
 - c. Certified victims of trafficking and their spouse, child, sibling, or parents
 - d. Veterans or active-duty military and spouses or unmarried dependents who also have qualified non-citizen status
 - e. Amerasian immigrants
 - f. Iraqi and Afghani special immigrants and parolees
 - g. Individuals who were paroled into the U.S. between February 24, 2022, and September 30, 2024, under the Ukrainian Humanitarian Parole (UHP) program
 - h. People whose deportation is being withheld
6. **Cuban/Haitian Entrant** with Employment Authorization Document (work permit), I-94 Arrival/Departure Record, foreign passport, I-862, etc.
7. **Compact of Free Association (COFA) migrant** – including individuals from Micronesia, Marshall Islands, and Palau – with Employment Authorization Document (work permit), I-94 Arrival/Departure Record, foreign passport, etc.

Other important information

You may be eligible for alternate insurance for the remainder of 2026. Starting October 1, 2026, you may qualify for health coverage through Get Covered New Jersey, the State's Official Health Insurance Marketplace. Complete your enrollment at Get Covered New Jersey as soon as possible to avoid a gap in coverage. Enroll by September 30, 2026, for coverage beginning October 1, 2026. You may be eligible for financial help to lower the cost of your monthly premium and out-of-pocket costs until the end of 2026. However, due to new federal rules, beginning January 1, 2027, you must have a qualifying immigration status to receive financial help. If you do not have a qualifying immigration status, you may pay full price for coverage in 2027. You can learn more about your coverage options and free local assistance at GetCovered.NJ.gov.

In addition, the Medical Emergency Payment Program covers emergency services, including labor and delivery, for New Jersey residents age 19 and older who do not qualify for NJ FamilyCare because they do not meet the U.S. citizenship or immigration requirement.
